ISSUE

To inform the Community Safety Committee of the Manly Place Plan Project and the Night Time Economy Project.

BACKGROUND

Place Planning

Northern Beaches Council is working to create great places that are vibrant, safe, inclusive and sustainable right across the Northern Beaches. We actively undertake place-based planning approaches throughout the Northern Beaches to support the planning, design and management of local town centres.

Place planning is a strategic approach to planning, designing, and managing the physical infrastructure and services around us. A Place Plan establishes a vision for the area and helps allow our places to grow incrementally over time, in line with the needs of our community.

Council's place planning framework focuses on working with the community to develop plans for our places grounded in our residents' connection to local villages and neighbourhoods.

Manly Place Plan Project

The Manly Place Plan project formally commenced on 1 July 2021. The objective of this Plan is to deliver a place-based, tactical oriented strategy to address the current and future needs of the Manly Strategic Centre.

The study area for the Manly Place Plan is shown at Attachment 1.

Place planning will involve:

- extensive community engagement activities to canvas the current values and concerns of the community and identify what that they believe Manly should be like in the future, from social, natural, environment, economic and cultural perspectives
- developing an evidence based framework to enhance the physical and social aspects this 'place'
- incorporating all the feedback obtained for other projects, for example the recently exhibited Plan of Management and Masterplan for Ivanhoe Park

- incorporating Council's strategic documents such as the Move Strategy and Action Plans, the LSPS and associated technical studies
- seeking further community opinion on practical ways for the Place Plan to be implemented
- working with the community to address the current and future needs of the Manly strategic centre.

Place Plans sit within a broader strategic planning framework that includes the Greater Sydney Region Plan, North District Plan, Council's Local Strategic Planning Statement Towards 2040 and other local policies such as local environmental plans and development control plans.

The Place Plan centres on public domain improvements and programs that aim to support and build capacity within the local community.

Priority 26 of Council's <u>Local Strategic Planning Statement</u>, <u>Towards 2040</u> (Attachment 2), Action 26.3 states the intention to:

Prepare a place plan for Manly and develop LEP and DCP controls to respond to LEP studies, thematic history study, West Esplanade heritage activation plan, destination management plan and night-time economy to balance competing plans.

Places for People is also a key Community Outcome of Council's Community Strategic Plan, Shape 2028.

Manly Night Time Economy Project

The Manly Night Time Economy (NTE) project will provide important input to the Manly Place Plan project.

Priority 30 of the <u>Local Strategic Planning Statement</u> (Attachment 3), Action 30.3 identifies the need to diversify the Night Time Economy:

Prepare place plans, precinct plans and activation plans that support social practical and functional activities in the evening and night-time, including:

• Manly place plan to respond to alcohol-related violence, anti-social behaviour and tension between competing land uses.

Local government can influence the Night Time Economy though:

- · Planning controls
- Regulation and compliance
- · Funding or delivering events
- · Availability and quality of public space
- Providing cultural and recreational venues community centres, libraries, pools, art galleries, theatres
- · Marketing and promotion
- Advocating, collaborating and partnerships.

Crime and antisocial behaviour impact negatively on the experience of participants in the Night Time Economy. A safe night time environment attracts a greater diversity of participants and supports an enjoyable experience.

The Night Time Economy project will canvass a range of issues which relate to community safety including:

- · Night time trading
- Licensed premises
- Outdoor alcohol restrictions (i.e. Alcohol Free Zones and Alcohol Prohibited Areas)
- Transport and access
- Crime mapping
- Events

Consultants

A consultant Masterplanner, Ethos Urban, has been engaged to prepare the Manly Place Plan. HillPDA Consulting has been engaged to undertake a Night-Time Economy Study of the Manly Strategic Centre. Targeted stakeholder engagements are a key element for both consultants.

The scope of works for the Masterplanner and Night-Time Economy Study are summarised in Attachment 4. This includes consideration of:

- Alcohol-related crime and anti-social behaviour issues occurring in the Manly Strategic Centre
- · Night-time economy activities
- Community safety and crime prevention through the future design of spaces in the Manly Strategic Centre.

Priority 26

Manly as Sydney's premier seaside destination

Manly is characterised by its frontages to the harbour and beach, iconic Norfolk Island pines and older historic buildings and generally low-scale development. The world-famous ocean beach is linked to Manly Cove and East and West Esplanades streets. Some of these projects are complete by The Corso flanked by quaint laneways and heritage buildings. The town centre is bordered by popular foreshore areas that connect to Sydney Harbour National Park at North Head and Cabbage Tree Bay Aquatic Reserve. These elements are evidence of Manly's history and social significance.

The town centre offers cultural, tourist, retail and entertainment uses. It is also a residential and economic centre, supporting the highest population density and the highest proportion of health and education and knowledgeintensive jobs of all of the LGA's centres. Manly has the youngest demographic and is the most culturally diverse of the LGA's centres, supporting mostly professionals and managers.

Manly is an important tourist destination and the LGA's only designated late-night precinct. These uses must be balanced with the needs of Manly's residents and other specialised uses which include the International College of Management Sydney, Manly Art Gallery and Museum (one of 40 regional and public galleries in NSW), Australia's first hospice for young adults, Soldier On (a veterans' rehab centre at North Head) and Royal Far West (a provider of health and education services for country children and their families).

Manly 2015 Master Plan supports a mix of cultural, tourist, retail and entertainment through urban design upgrades to streets, lanes and plazas, including pedestrianising and some are identified as future projects in the Northern Beaches Delivery Program.

People in Manly are the highest users of active and public transport compared to other centres. It offers 20-minute ferry commutes to Sydney CBD, but connections to lower Northern Beaches suburbs are poor. Addressing this will improve access to the rest of the LGA including Warringah Mall, the B-Line, Manly Andrew 'Boy' Charlton Aquatic Centre and sportsgrounds at North Manly, making it easier for people to travel to Manly without a car and reducing demand for parking in the centre. This will be supported by a regional cycling route to Dee Why and improved end-of-trip facilities, such as bike storage.



Priority 30

A diverse night-time economy

We define the night-time economy as economic activity between 5pm and 4am. It includes bars, clubs, events and restaurants, as well as services such as transport, supermarkets, childcare, gyms, training and education facilities.

In NSW, the night-time economy had a sales turnover of \$38 billion in 2016-17 based on figures from food, drinks and entertainment business, and employment. It represents 8.5% of the economy in NSW and 26% of employment in Australia overall⁴¹. time offerings in places that will grow and change – like Dee Why, Brookvale or Frenchs Forest – is fundamental, especially to support shift workers at Northern Beaches Hospital.

The types of night-time activities are changing – from fast-casual dining, eat streets and popup food trucks to events, festivals and late-night shopping, or late-night gyms. Diversified night-time activities also avoid reliance on alcohol-focused businesses and can help to address anti-social behaviour in Manly, Mona Vale and Newport.


We will prepare a night-time economy strategy to manage the economy's sustainable growth while minimising potential land use conflict. This will create flexibility to maximise employment, turnover and tourism benefits while also delivering active and vibrant strategic and local centres. It will identify solutions to facilitate live entertainment, arts, creative and cultural opportunities in appropriate locations.

The strategy will address safety, late-night transport, noise and light pollution and consider established precincts like Manly, seasonal precincts in the northern end of the peninsula, emerging precincts in areas of transformation such as Dee Why and specialised precincts such as the microbrewery cluster at Brookvale. It will include location-specific solutions that cater for all age groups.

Manly is the only designated late-night entertainment precinct in the LGA.

Suburbs such as Forestville, Belrose, Narrabeen, Newport, Killarney Heights, Elanora Heights, Freshwater and Fairlight could be investigated for evening activities, while more diverse night-

- Northern Beaches LGA (2016-17)⁴¹





ISSUE

As the current Council Term concludes in December, with the Local Government Elections on 4 December 2021. A summary of matters receiving attention from the Committee throughout the Council Term is provided for the information of the Committee.

BACKGROUND

Matters receiving ongoing attention from the Committee throughout the Term

The Committee has received briefings and monitored the status of the following matters throughout the course of the Term. The Committee has discussed these matters and advised the development of strategies by Council, local service providers and other stakeholders:

Policing issues

Northern Beaches Police Area Command have provided ongoing advice to the Committee on reported crime across the Northern Beaches, including crime trends, advice on emerging issues and recommendations for community safety messaging.

Environmental Compliance

Environmental Compliance has provided ongoing advice to the Committee on compliance issues including the management of companion animals, dog attacks and ranger activity in the management of the alcohol restrictions at East Esplanade Reserve.

Community Safety Plan

Council has engaged with the Committee in the consultation and development of the Community Safety Plan.

• Alcohol Restricted Areas

The management of alcohol restricted areas across the LGA.

Suicide Prevention

The Suicide Prevention Working Group was established in 2018 in response to a Coronial Inquest into suicides at North Head and an increasing concern in the community regarding suicide in all demographics, particularly young people.

COVID-19

During 2020 and 2021, the Committee considered and addressed a number of challenging community safety issues impacting the Northern Beaches community as the result of the COVID-19 pandemic.



ITEM NO. 6.4 - 18 NOVEMBER 2021

Committee Highlights by Year

The Committee has considered a diverse range of community safety issues across the Northern Beaches throughout the Term.

In 2018 the Committee:

- Received advice from service providers on the issues facing youth on the Northern Beaches and advised strategies for the management of underage drinking and broader mental health related matters.
- Improved the management of alcohol consumption in public spaces by recommending a consistent method of establishing Alcohol Prohibited Areas.
- Monitored the management of community safety at East Esplanade Reserve Manly at the request of Council, including the development and progression of the East Esplanade Community Safety Management Plan. Strategies were also discussed and implemented in order to address alcohol related antisocial behaviour reported at that location.
- Initiated the Suicide Prevention Working Group sub-committee in response to a Coronial Inquest into suicides at North Head and an increasing concern in the community regarding suicide in all demographics, particularly young people. The Committee monitored the activities of the Working Group and received advice on actions taken to identify gaps in prevention, intervention and postvention support, the conduct of de-escalation strategies training to frontline workers, the development of cliff top prevention strategies and advocacy for the installation of a telecommunications tower at North Head.
- Advised on an application for a grant under the Federal Government Safer Communities Fund for the installation of Vehicle Mitigation strategies in Manly to improve community security
- Monitored the development of the 'More to Manly' Safer Laneways Project funded by the Federal Government Safer Communities Fund which saw increased lighting, public art and CCTV installed around Manly Town Centre to increase community safety and public amenity.
- Assisted the initial development of the Community Safety Plan, advising its scope and framing.

In 2019 the Committee:

- Noted the results of the Community Safety Survey and continued to monitor and advise the development of the Community Safety Plan.
- Raised concerns about passenger safety and the impact of changes to public buses with Sydney Buses, Transport for NSW and received a report on Schools Road Safety Audits.
- Received updates from a range of service providers regarding a range of community safety
 related issues including a presentation by Manly Warringah Women's Resource Centre on
 services available to the community and information on current activity and challenges relating
 to rough sleeping in public spaces.
- Noted a discussion paper for the Special Commission Inquiry into the drug "Ice", established a
 working group to consider its recommendations and made a submission to the Special
 Commission.
- Made representations to State Government, local MPs and the Attorney General regarding the need for strengthened legislation and stricter controls over access to Nitrous Oxide. The Attorney General shared the Committee's concern and referred the matter for further examination.

- Received research and a report from Northern Sydney Local Health District regarding the Online Supply of Alcohol. The Committee forwarding correspondence to local State MPs in support of the report recommendations.
- Monitored the progress of the Suicide Prevention Working Group and noted a briefing regarding action being taken by the Local Drug Action Team to address local drug and alcohol related suicides.
- Received a report from Northern Beaches Liquor Accord outlining a range of initiatives being implemented to reduce underage drinking, fake IDs, and alcohol related problems in and around licensed premises.
- Initiated a Housing and Homelessness Forum to identify gaps, discuss housing needs and
 envision future best practice for housing options. The resulting discussion paper was received
 and its recommendations considered, resulting in the establishment of the Northern Beaches
 Housing and Homelessness Interagency and accompanying Case Coordination Group.
- Received the outcomes of the Mental Health Summit.
- Secured \$800,000 Federal and Council funding for installation of bollards around Manly Wharf and the entrance to the Corso, Manly.
- Supported the installation of lighting as part of the Lagoon Park Landscape Plan.
- Completed the More to Manly Safer Laneways Project.
- Considered the safe use of the Newport 'Portside' Space.

In 2020 the Committee:

- Endorsed a submission to the NSW Parliament Legislative Assembly Inquiry into the Protocol for Homeless People in Public Places and received a report on the Northern Beaches Homeless Street Count.
- Received updates on the Northern Beaches Suicide Response.
- Advised Council of the impact of COVID-19 on the Northern Beaches community and service providers and identified emerging issues of concern needing action/support.
- Received a presentation outlining an increase in reported illicit drug use during COVID-19, including among youth.
- Received a presentation from Northern Sydney Local Health District on the Women and Alcohol Project, a Northern Beaches Study.
- Advised on Council's Jump Rock Safety Review.
- Noted Council's draft Public Space Vision and Design Guidelines, particularly as they relate to Crime Prevention through Environmental Design principles.
- Supported a Community Medical Waste Collection Program Trial.
- Provided input on safety considerations for the Urban Night Sky Place Proposal for Palm Beach.
- Continued to monitor and advise the development of the Community Safety Plan.
- Received a briefing on the Better Together Social Sustainability Strategy and provided feedback on the issues raised.

In 2021, the Committee:

- Continued to keep informed about the impact of COVID-19 on the Northern Beaches community, and to provide advice to Council on emerging issues.
- Received advice on issues impacting youth across the Northern Beaches and the impact of Public Health Order restrictions, closure of schools and recreation facilities on mental health.
 The Committee considered the availability of services and programs in support of young people and their safety.
- Considered the significant impact of restrictions of business operations and employees, the supports and policy and process amendments being implemented to assist businesses to operate, and opportunities for change over the long term.
- Received advice from local service providers on an unreported increase in domestic violence during lockdowns and the impact of COVID-19 on the availability of services and housing for victims of domestic violence. The Committee received presentations regarding programs for offenders and victims of family and domestic violence and discussed the need to consider expansion of available housing options.
- Received a presentation on safety issues impacting seniors across the Northern Beaches, including the impact of COVID-19 on health, safety and wellbeing of seniors and services available for support.
- Received briefings on the impact of COVID-19 on the health of Northern Beaches residents
 including the progress of the COVID-19 vaccine rollout across the LGA. Considered emerging
 issues, heightened by community stress during the pandemic, including emerging issues and
 locations of crime and alcohol related antisocial behaviour.
- Received advice on the Homeless Street Count 2021 and considered the impact of COVID-19 on people experiencing homelessness.
- Continued to receive briefings and advise Council's development of strategic and operational planning related to community safety including the Better Together Social Sustainability Strategy and the Community Safety Plan 2021-2026 adopted by Council on 28 September 2021.
- Received updates and provided advice to Council on proposals to re-establish 14 Alcohol Free Zones throughout the Northern Beaches and received a briefing on the management of Alcohol Prohibited Areas.
- Received a presentation on the Manly Place Plan project and Night Time Economy project.

DISCUSSION

Council would like to thank Community Safety Committee members for their contribution to the safety of those who live, work and visit the Northern Beaches. The Committee has made a significant contribution to understanding, influencing, communicating and impacting a wide range of community safety issues. The Committee has continued to meet during the COVID-19 pandemic and has ensured that ongoing and emerging community safety issues have continued to receive professional and timely attention during difficult times.
