2.0 DECLARATION OF PECUNIARY AND CONFLICTS OF INTEREST

Members are advised of the following definitions of a "pecuniary" or "conflict" of interest for their assistance:

Section 442 of the Local Government Act, 1993 states that a "pecuniary" interest is as follows:

- "(1) [Pecuniary interest] A Pecuniary interest is an interest that a person has in a matter because of a reasonable likelihood or expectation of appreciable financial gain or loss to the person or another person with whom the person is associated.
- (2) [Remoteness] A person does not have a pecuniary interest in a matter if the interest is so remote or insignificant that it could not reasonably be regarded as likely to influence any decision the person might make in relation to the matter."

Members should reference the Local Government Act, 1993 for detailed provisions relating to pecuniary interests.

Council's Code of Conduct states that a "conflict of interest" exists when you could be influenced, or a reasonable person would perceive that you could be influenced by a personal interest when carrying out your public duty.



PURPOSE

To brief the Community Safety Committee on the East Esplanade Reserve Community Safety Management Plan.

REPORT

Summary of activities:

- The updated actions within the Management Plan will be presented at the meeting.
- There has been a request from Council's Parks and Recreation business unit for the Community Safety Committee to consider a 'ban on glass' on East Esplanade following correspondence from an East Esplanade resident and referred to Council by Councillor Stuart Sprott.

Environmental Compliance advise that under the Local Government Act there are several offences where a penalty notice can be issued relating to glass bottle/receptacles:

Break bottle receptacle in public place Leave in public place bottle/glass receptacle Fail to comply with terms of notice.

Each of these penalties are issued to a person which means the officer would have to get confirmation of name and address of each offender.

Given it is anticipated that alcohol would be involved, there would be a high level of risk to Council officers as they are seen as being an easy target to some elements of society.

Any enforcement would require a joint operation with NSW Police.

 Council representations have been made to the Director of Compliance Operations, Liquor and Gaming in regard to the impact of takeaway alcohol on the amenity of the area in which the liquor is purchased. The representations included requesting advice about any responsibility nearby alcohol retailers may have on the "disturbance to the quiet and good order of the neighbourhood". A response is yet to be received.

PURPOSE

To brief the Community Safety Committee on a Federal Government Safer Communities Fund – Round 2 grant application.

REPORT

Council was unsuccessful in its grant application for Manly town centre vehicle mitigation installations within the Federal Government Safer Communities Fund Round 1. An application has now been submitted for Round 2 grants.

The intent of the grant is to strengthen vulnerable locations against intentional (terrorist related) vehicle intrusions as well as protection against other types of vehicle accidents into these spaces. This is termed vehicle mitigation. The application has been developed with the support and assistance of Northern Beaches Police Area Command. Police have assisted in identifying appropriate locations around the Manly CBD including Manly Wharf, entrance areas to The Corso and beachfront, and the types of barriers required.

For Council to meet the grant deadline of 26 September, and in order to strengthen the grant, the following supporting paragraph was included in the submission:

Northern Beaches Council's Community Safety Committee is chaired by the Mayor, five Councillors and representation by Police Commander, NSW Health, Chamber of Commerce, State MPs, Liquor Accord, Transport NSW, Family and Community Services, a range of local service agencies and community representatives. The committee acknowledges Manly as the locality that is most vulnerable to crime and are strongly supportive of any initiatives that support the improvement and strengthening of safety and security in Manly.

Due to the earlier deadline, Council could not explicitly state that the Committee endorsed the application. Nevertheless, it would be valuable if the Committee could now consider endorsing the application.

RECOMMENDATION OF COORDINATOR, COMMUNITY SAFETY

That the Committee endorse Council's application to the Safer Communities Fund for vehicle mitigation installations in Manly.

ITEM 4.6 NORTH HEAD TELECOMMUNICATIONS REPRESENTATIONS

UPDATE

REPORT

PURPOSE

To update the Community Safety Committee on the North Head Telecommunications representations.

REPORT

At the Community Safety Committee meeting on 7 June 2018, the Committee recommended that Council advocate on behalf of the Committee for installation of a Telstra tower on North Head.

Below is a summary of communication that has since followed:

- 2 August: Letters from Mayor on behalf of the Community Safety Committee were sent to six telecommunications stakeholders including representatives of Telstra, Optus, Vodafone and the body the two industry bodies that they collaborate together on issues of mutual interest – Australia Mobile Telecommunications Association Ltd. (AMTA) and Communications Alliance Ltd.
- 2 August: Representations made directly to the Federal Member for Warringah, The Hon Tony Abbott MP via meeting with Superintendent Darcy.
- 9 August: Reply received from Vodafone
- 13 August: Reply received from AMTA and anticipating further advice
- 19 September: Telephone conversation with Michael Ryan, Telstra.

Mr Ryan advises that work in this area is progressing. It is a collaborative approach undertaken by the telecommunications stakeholders through AMTA. AMTA are awaiting advances in technology in order to be able to access individual's handheld devices when there is a life threatening situation. This work is also being needed for the Blue Mountains area.

It is understood that the capability to locate a person's device by emergency services already exists, particularly in android phones. Apple is still harder to access. If someone calls 000 there is already technology that can GPS locate the caller. The more challenging aspect is to locate someone's device, who doesn't necessarily want to be located. Whilst this is legislated in cases of National Security, the legislation does not cover life threatening incidents including suicide. Privacy issues are a major impediment and advocacy for legislative change is required.

The call to install base stations on North Head is less likely to succeed as there is no commercial need therefore the carriers won't do it willingly. It also appears that the above mentioned technologies will be more effective and will overtake the need for this site specific request.

Mr Ryan further advised that we consider advocating directly to the Minister for Communications, continue lobbying through Federal Member for Warringah, The Hon Tony Abbott MP and consider submissions to the Black Spot funding program.

There is also a bi-annual National Emergency Call Forum coordinated by NSW Police Communications Commander which includes all the telecommunications stakeholders. The Committee could request that this issue be included as a future agenda item at the Forum.
