- Forward to the Department of Planning & Infrastructure the tabled submission that highlights the total lack of strategic merit of the Planning Proposal and its gross inconsistency with the Warriewood Valley Strategic Review adopted by Director-General of the Department of Planning & Infrastructure and Council.
