Question 1: Mr R Smith

To the Mayor: Re the quote attributed to you in Pittwater Life July 2013 "Mayor Townsend said the Council had legal advice that the objectors' argument that the park ... was on Crown land and therefore could not be used for parking by shoppers was not correct". As the General Manager has now confirmed that Council never did receive any legal advice regarding this matter do you admit your statement was not correct?

Answer:

The Mayor responded that this question has been dealt with previously and the response is on page 102 of tonight's Agenda, being that the advice to the Mayor was provided by the General Manager, that advice being that the construction of the carpark in accordance with the Plan of Management on Beeby Reserve is legal.

Question 2: Mr R Smith

To Cr White: Appendix 50 of Save Beeby Park Committee Submission to Crown Lands Minister Andrew Stoner 26 July 2013 of which all Councillors do have a copy as it is on the computer disc delivered to you recently shows a form email Councillor White circulated via emails to objectors on and around 22 June 2013 where you state:-

"Beeby Park is currently being used informally as a parking lot. The Council will formalize this and will properly drain and landscape the reserve. When this is complete there will be more than twice as many trees as there are now."

Base level maths on this therefore means even if only 55 trees were to currently exist on the site and all were removed then a minimum of 110 trees would need to be planted to result in twice the current amount. However only 70 will be planted so the maths don't add up even for this scenario. But your statement is that there will be twice as many trees as there are now.

Map 01 Existing Vegetation which is contained in the Review of Environmental Factors for the Part 5 assessment shows 161 trees are currently in Beeby Park. 55 trees to be removed leaves 106 trees remaining. Then add the 70 trees to be planted results in 176 trees at completion.

Again the maths don't add up in that twice the number of trees at completion as there are now is 2 times 161 would mean 322 trees but there will be only 176. This equates to 9% more trees at completion not 100%.

Do you admit your statement in the form email you sent out therefore was not correct?

Notes:

- 1. Cr Grace raised a point of order regarding the complexity of the question being put to Cr White, in that it was difficult to answer a question in this forum based on complex calculations and conclusions which may or may not be accurate.
- 2. The Mayor requested that Mr Smith rephrase his question in more simplified terms.

How many trees will be on site on completion of works at Beeby Park?

Question 3: Mr P Walker

To the General Manager: Could you please confirm the Freedom of Information response that Council received a letter from Crown Lands dated 24 May 2013 regarding Beeby Park, stating that as the Minister has not adopted the Kitchener Park Plan of Management 2009, it is "understood to have no statutory effect on the subject Crown Land."
