

Ideas for MWWMSP Advisory Committee Meeting – 12/12/2018:

1. Understand the Impacts to the POM of the new Crown Lands Management Act 2016 which commenced operation on the 1st July 2018. (What happens and what plan does this come under, and zoning, and timeframes?)
2. Discuss the boundaries of the Park & identify the status of all land on the boundaries: Crown Land parcels with leases; Zoning; level of protection. (e.g. Water Board land, Aquatic Reserve, MVPS APZ, etc.) (Zoning ideally E2 rather than RE1 for increased protection).
3. Identify (in order to manage) the impact of any upcoming developments bordering on the Park. (maybe categorise for level of impact) – e.g. NB Tunnel, FF High School, 181 Allambie Road, etc.
4. Educational - signage, events, (environmental, War memorial, etc.), brochures for all ages, Field of Mars type educational resources or programs?
5. Program of bush regeneration - especially on edges and lease edges;
6. Community involvement in clean-ups and bush regeneration, etc.
7. Water quality – possible presence of the chemical that causes motor neurone disease being found in the water of Manly Dam. Education on what is happening – testing and findings?
8. National Heritage register - only War Memorial Park of its kind. (Currently only the Dam wall). The register was replaced by a National Heritage List and MWWMP was never transferred onto it. Can this omission be addressed?
9. Review Recreational uses & management: including waterskiing; mountain bikers (removal of self-made additional tracks); Night time bike riding; golf course,
10. The creation of definitive fauna and flora lists...and potential action recovery plans for “at risk” species (eg Climbing Galaxias, Pygmy Possums etc).
11. Mike Baird promised that:- “once the MVPS works have been completed, areas of the Asset Protection Zone no longer needed or critical to the school will also be transferred back to the park”.
12. Hazard Reduction Burns - In the past there has been talk of mosaic style control burns that would be less destructive to the park’s environs and wildlife. Maybe something that should be put on the “to do” list? Council is currently inviting submissions for Fire Prone Land mapping <https://yoursay.northernbeaches.nsw.gov.au/bush-fire-prone-land-map2018>
13. Review POM actions and progress.
14. Notification / Communication improvement:
 - a) regarding developments surrounding the Park – eg recent Golf Course subdivision
 - b) 181 Allambie Road
 - c) inclusion of community groups with vested interest?
15. Identify all stakeholders / community groups that are involved with the Park?

Eg. The Trust; Save Manly Dam CC, RSL; Merchant Navy; Water skiers; Mountain Bikers; Bush walkers; Scouts; D of E groups; Surf Life Saving training; Schools;
16. Compliance – MVPS, Bike Tracks, dogs , etc.
17. Council’s 100,000 tree policy –Using NBC 100,000 trees policy – can we gradually/strategically replace any non-native locals with native locals?

18. Please advise if there are any Aboriginal Land Claims on any of the parcels of land that make up the War Memorial Park?
