Section 4 of the Model Code of Conduct for Local Councils in NSW 2018 states that a pecuniary interest is as follows:

"A pecuniary interest is an interest that you have in a matter because of a reasonable likelihood or expectation of appreciable financial gain or loss to you or a person referred to in clause 4.3.

You will not have a pecuniary interest in a matter if the interest is so remote or insignificant that it could not reasonably be regarded as likely to influence any decision you might make in relation to the matter, or if the interest is of a kind specified in clause 4.6.

For the purposes of this Part, you will have a pecuniary interest in a matter if the pecuniary interest is: a) your interest, or b) the interest of your spouse or de facto partner, your relative, or your partner or employer, or c) a company or other body of which you, or your nominee, partner or employer, is a shareholder or member."

Council's Code of Conduct states that a "conflict of interest" exists when you could be influenced, or a reasonable person would perceive that you could be influenced by a personal interest when carrying out your public duty.



Draft Water Management for Development Policy Review

### **EXECUTIVE SUMMARY**

### **PURPOSE**

To provide the Environment Strategic Reference (SRG) with an update on the draft Northern Beaches Water Management for Development Policy.

### **REPORT**

As discussed at the previous Environment SRG meeting on 30 May 2019 staff are currently reviewing and consolidating former Council policies to develop a draft Northern Beaches Water Management for Development Policy (Policy). The purpose of the Policy is to provide the guidelines for effective management of stormwater, rainwater, groundwater and wastewater within the Northern Beaches Local Government Area (LGA) and to protect and enhance the natural environment while ensuring protection of public and private property.

In the development of this draft Policy, Council has considered the existing policies from the former Councils, policies and procedures from other Councils, as well as feedback from internal stakeholders and feedback provided by the Environment SRG at their last meeting.

Overall the policy position is in line with the former policies. The Environment SRG will be briefed on the most significant changes for their feedback at their meeting.


Once adopted the draft policy would replace the relevant existing policies of the three former Councils thus supporting a single approach to water management for development on the Northern Beaches.

It is proposed to place the draft Policy on public exhibition with the associated changes required for the Pittwater, Manly and Warringah (2011) Development Control Plans, after which submissions will be considered and the final policy will be reported to Council seeking adoption.

### **EXECUTIVE SUMMARY**

### **PURPOSE**

To discuss the draft Climate Change Action Plan with the Environment Strategic Reference Group (SRG) and provide an opportunity to give feedback.

### **REPORT**

The draft Climate Change Action Plan (the Plan) is the first of a suite of action plans that will be developed to provide Council with a clear path forward to deliver the goals and commitments in the Protect. Create. Live. Northern Beaches Environment and Climate Change Strategy 2040 (the Strategy). The plans will detail actions to be undertaken over a four year timeframe and will align with Council's Delivery Program. The actions will be translated into the Council's annual operational plan.

At the Environment SRG meeting of 30 May 2019 a workshop was held with members to identify actions that should be included in the Plan. A draft Plan has been prepared that has taken into consideration the actions identified in this workshop and the commitments in the draft Strategy.

### RECOMMENDATION OF SENIOR SUSTAINABILITY OFFICER

That the Environment Strategic Reference Group participate in the discussion and provide feedback on the draft Climate Change Action Plan.
