PURPOSE

This report will provide an update to the Transport and Travel Strategic Reference Group (SRG) on the development of options to run a trial of smart parking systems, mainly parking sensors, at five (5) locations across the Northern Beaches, including one (1) in the Manly area.

SUMMARY

As detailed in '*Move – Northern Beaches Transport Strategy*' Council's Smart Parking Management objective is to manage car parking in a way that is equitable and supports the economic viability of centers and boosts sustainable public transport and active travel use.

Smart Parking focuses on the use of technology to provide a number of improvements to the customer parking experience. It also captures data which Council can utilise to manage parking through accurate and real time information relating to parking demand, turnover, length of stay and availability.

By implementing a Smart Parking Sensor approach across the Northern Beaches Local Government Area (LGA), Council will have the opportunity to test a range of market leading technology from a variety of suppliers to determine the best outcome for Council and the community.

ISSUE

Traditionally, the method used by Council to gather information about off-street parking availability and turnover is through the engagement of a traffic and parking consultant to undertake a study 12 hours per day over a seven (7) day period.

This results in a large on-going financial commitment for Council and restricts the ability to gather large amounts of parking data to inform decisions and to report back to the community.

BACKGROUND

Following endorsement at the Council Meeting to be held on 22 October 2019, Transport Network and Parking Operations will commence an EOI process to seek interested Smart Parking technology providers to participate in a 12-month trial. The EOI process will include consideration of:

- 1. Best use of technology and hardware for each specific location.
- 2. Consideration of weather conditions and environmental impacts on hardware in coastal locations.
- 3. Dashboard viewing and reporting tools.
- 4. Operator service levels.

The five (5) proposed locations selected for inclusion in the trial include:

- 1. Pittwater Park carpark (south), Palm Beach
- 2. Park Street, Mona Vale
- 3. Manly Beach, South Steyne
- 4. Forestville commercial area
- 5. Narrabeen commercial area.

PURPOSE

This report will provide an update to the Transport and Travel Strategic Reference Group (SRG) on the development of an Electric Vehicle (EV) charging infrastructure Expression of Interest (EOI). The purpose of the EOI is to seek partnerships with EV charging provider/s to delivery public charging infrastructure across the Local Government Area (LGA) for a trial period of up to two (2) years.

SUMMARY

The Transport Network and Environment, Parking Operations and Resilience & Climate Change Teams are working together to deliver EV project and to also develop the Northern Beaches Electric Vehicle Plan.

Council has already begun the journey to transition its own fleet to electric vehicles and has installed charging infrastructure at its depots and carparks in Warriewood, Cromer and Manly. Council also provides EV charging points in the PCYC carpark in Dee Why at no cost to the public.

ISSUE

Council currently has no on-street or off-street public EV charging infrastructure across the Local Government Area (LGA). Funding to support the delivery of EV charging has not been identified in the 2019/20 Delivery Program and Budget therefore Council is seeking partnership opportunities with providers to supply EV infrastructure at no cost to Council in exchange for the use of on-street and off-street car parking spaces at no charge during the trial period.

To further enhance the EV charging network, an EOI is currently open seeking interest from EV charging providers to trial technology and hardware in the following proposed locations for:

- Manly Town centre
- Mona Vale, Park Street carpark adjacent to the library
- Woolworths carpark, Old Barrenjoey Road, Avalon
- Glen Street Library carpark, Belrose
- Dee Why library carpark, Pittwater Road, Dee Why
- Dee Why beach.

BACKGROUND

Transport is undergoing a shift and the transition to electric vehicles in the passenger vehicle sector is at the forefront. Governments around the world are also taking action to prepare for and accelerate the adoption of Electric Vehicle (EV) technologies, in recognition of the economic, social and environmental benefits (NSW Government, NSW Electric and Hybrid Vehicle Plan, 2019).

A range of studies have shown that range anxiety or perceived lack of charging infrastructure is a significant barrier to the uptake of electric vehicles.

EXECUTIVE SUMMARY

PURPOSE

To provide an overview of the draft Northern Beaches Local Strategic Planning Statement – *Towards 2040.*

REPORT

The draft Northern Beaches Local Strategic Planning Statement - *Towards 2040* is now on public exhibition until **10 November 2019**.

Towards 2040 is the Northern Beaches Council's first Local Strategic Planning Statement (LSPS) and has been prepared in accordance with the requirements of Section 3.9 of the *Environmental Planning and Assessment Act 1979* (EP&A Act).

Towards 2040 outlines the Northern Beaches' direction for housing, employment, transport, recreation, environment and infrastructure over the next 20 years. It will help guide future land use decisions through planning priorities, principles and actions that build on the strengths and opportunities for the Northern Beaches as well as addressing key issues and challenges. It will inform Council's new Local Environmental Plan (LEP) and Development Control Plan (DCP) and broader framework of Council policies and strategies.

Towards 2040 reflects local values and aspirations, building on the 10-year vision set out in the Community Strategic Plan, *Shape 2028*. It applies to the whole Northern Beaches Local Government Area (LGA).

To support the preparation of *Towards 2040* and subsequent LEP and DCP, a number of technical studies are being prepared. The preliminary findings from these studies provide a detailed evidence base and form part of the exhibition package:

- Demographic Analysis.
- Housing Issues and Opportunities Paper.
- Employment Study Background Paper.
- Social Infrastructure Issues and Opportunities Paper.
- Environment Background Report.

Towards 2040 aligns with the higher level plans including the Greater Sydney Commission's (GSC) Greater Sydney Region Plan – *A Metropolis of Three Cities* (Region Plan) and the North District Plan (District Plan). It has been arranged and presented under the same themes and directions contained in the Region Plan and District Plan. *Towards 2040* comprises thirty planning priorities which fall under these themes and directions. This presents a clear line-of-sight and connection between the metropolitan and district plan, and what this means at the local level.



ITEM NO. 6.3 - 17 OCTOBER 2019

Towards 2040 includes a 20-year vision for a sustainable, liveable, connected and productive Northern Beaches. The *Towards 2040* vision will be achieved by:


- Working with NSW Government, other councils, the community and other stakeholders.
- Protecting and enhancing the health of the LGA's waterways, coast, bushland and biodiversity, and increasing the urban tree canopy.
- Maintaining the coastal and bushland character, scenic and cultural landscapes and the Metropolitan Rural Area.
- Designing the built environment to be more efficient with less impacts on the natural environment
- Building resilience to urban and natural hazards and impacts from climate change.
- Providing educational, recreational, arts and creative opportunities.
- Enhancing centres and neighbourhoods as vibrant and inclusive places for social interaction
- Providing well-designed, diverse and affordable housing in the right locations.
- Protecting and celebrating heritage and each area's unique character.
- Improving public transport within the Northern Beaches and to Greater Sydney.
- Improving walking and safe cycling and embracing emerging transport technology.
- Strengthening strategic centres and providing more jobs closer to home.
- Safeguarding employment lands and supporting sustainable tourism and night time economy.
