5.1 SMART PARKING

M Carter provided the group with an update on this item.

There are a number of Smart Parking providers currently offering a range of products and services to Local Government. To determine the best suite of technology for Council to use across a number of location and asset types, it is proposed that a trial is undertaken to test a range of Smart Parking technologies from suitable providers. This will provide Council with the opportunity to:

- Seek an improved parking experience to all of our customers.
- Explore options and innovation to ensure integration with our Pay and Display equipment messaging signage, and future enforcement technology.
- Review the software reporting tools to support the delivery of parking outcomes.

The following five locations are proposed for the Smart Parking trials:

	Location	Background		
1.	Pittwater Park carpark (south), Palm Beach 73 spaces and two (2) accessibility and two (2) P5 spaces	 Parking is managed through the Palm Beach Parking Demand Management Strategy adopted by Council in November 2016. Peak parking demand is experienced over December/January, school holidays and most weekends. Smart parking data will be used to monitor parking turnover and availability for reporting purposes. Information captured may also inform changes to parking conditions to provide improved parking outcomes for offshore residents. 		
2.	Park Street, Mona Vale 41 spaces and four (4) accessibility spaces between Pittwater Road and Barrenjoey Road	 Mona Vale is one of the identified Strategic Centres in the LGA and experiences peak parking demand due to a range of business, recreational and social parking demands. Smart parking data will be used consider changes to parking conditions to support local business. This may include expansion of time restrictions by time and day of week and changes to length of stay.

3.	Manly Beach, South Steyne 27 spaces and one (1) accessibility space between Raglan Street and Denison Street	Manly Beachfront is a destination that attracts both locals and visitors and experiences high parking demand due to a range of recreational, business, tourism and social parking demands. Smart parking data will be used to better understand parking occupancy and provide real-time availability to visitors/residents
4.	Forestville commercial area, Council carpark in Darley Street 50 car parking spaces and four (4) accessibility spaces	 Parking conditions are managed through 3P Monday to Friday and 2P/3P Saturday. No restrictions on Sunday. The Forestville commercial area provides local shopping for the community as well as a library, community centre, church and primary school. Smart parking data will be used to better understand parking occupancy and turnover in this location to inform future decisions to parking conditions. Opportunities to investigate variable time of day parking arrangements to support night time business.
5.	Narrabeen commercial area, Council carpark in Wellington Street and Lagoon Street Wellington Street 46 spaces and one (1) accessibility space Lagoon Street carpark 69 spaces and two (2) accessibility spaces	 Parking conditions are managed through 3P Monday to Friday and 2P Saturday. No restrictions on Sunday. The Narrabeen commercial area provides parking to support local business. Smart parking data will be used to provide real-time information to visitors/residents.

The report is being put to Council at its meeting on 22 October 2019. If the report is endorsement by Council, the Transport Network and Parking Operations will commence an EOI process to seek up to five interested Smart Parking technology providers to participate in a 12 month trial commencing possibly in November 2019. The EOI process will include consideration of:

- 1. Best use of technology and hardware for each specific location.
- 2. Consideration of weather conditions and environmental impacts on hardware in coastal locations.
- 3. Dashboard viewing and reporting tools.
- 4. Operator service levels.

At the conclusion of the trial period, a report will be prepared for a future Council Meeting to inform of the outcomes and to seek endorsement to proceed to commence a Tender process to appoint a provider (or providers) to collaborate with Council to deliver Smart Parking across the LGA.

Question: Is it proposed that this information will be sent to our Rangers for monitoring / fining motorists whose vehicles parking time allowance has been exceeded?

Answer:

It is proposed that the new system will contain sensors that will send information to the central monitoring point. It will also be connected to an application which will provide motorists the opportunity to pay to extend their parking time to the full limit however will not allow them to recharge past a certain limit. For those who exceed their time, a message will be sent to the Rangers for further action.

3.1 MINUTES OF TRANSPORT AND TRAVEL STRATEGIC REFERENCE GROUP MEETING HELD 22 AUGUST 2019

5.2 ELECTRIC VEHICLES ISSUES

M Carter provided the group with an update on this item.

The group discussed:

- The types of Electronic Vehicles (EV) available on the market.
- Church Point being a possible option within the Northern Beaches LGA for residents with EV vehicles and are overnight commuters.
- Both bus and rail services are researching and going out to tender for installing EV spaces within their transport carparks.
- Council is working with Taxi NSW in the roll out of an e-vehicle fleet and it is possible that
 Manly may be the first location to trial electric taxis. It is proposed that Manly, Dee Why and
 Mona Vale will contain these EV taxi services which may be implemented as early as
 December 2019.

Question: What type of Chargers are available:

Answer: There are three main types of EV charging – **rapid**, **fast**, and **slow**. These represent the power outputs, and therefore charging speeds, available to charge an EV. Note that power is measured in kilowatts (kW):

- 1. Rapid chargers are one of two types AC or DC [Alternating or Direct Current]. Current Rapid AC chargers are rated at 43 kW, while most Rapid DC units are at least 50 kW. Both will charge the majority of EVs to 80% in around 30-60 minutes (depending a battery capacity). Tesla Superchargers are also Rapid DC and charge at around 120 kW. Rapid AC devices use a tethered Type 2 connector, and Rapid DC chargers are fitted with a CCS, CHAdeMO or Tesla Type 2. This style of charger can cost up to 2.5 million dollars
- 2. **Fast chargers** include those which provide power from 7 kW to 22 kW, which typically fully charge an EV in 3-4 hours. Common fast connectors are a tethered Type 1 or a Type 2 socket (via a connector cable supplied with the vehicle).
- 3. **Slow units** (up to 3 kW) are best used for overnight charging and usually take between 6 and 12 hours for a pure-EV, or 2-4 hours for a PHEV. EVs charge on slow devices using a cable which connects the vehicle to a 3-pin or Type 2 socket.

Question: Do electric vehicles have universal chargers?

Answer: Yes, all EV's come with a standard charging cable that can plug into a common 120-volt household electrical outlet

Question: In the future, is it likely that all commercial facilities i.e commercial facilities, business hubs and shopping centres will install these style facilities as an incentive for people to park and charge their vehicles as they are expected to stay for at least two to three plus hours?

Answer: Yes. Currently commercial centres like Westfield Brookvale, Stocklands, Dee Why Grand, The Hills and Harbord Diggers all have EV spaces/chargers. Companies can benefit from the Government in the form of grants to install EV spaces / charging units.

Company owners can decide whether to provide free charging or a top charge fee to use the facilities, many opting for zero or low cost to incentive EV usage. It is also proposed that in the future the charging points can be linked to Pay and Display machines.

ACTION

That the Transport and Travel Strategic Reference Group receive a further update on Electric Vehicle Infrastructure in early 2020.



5.3 DRAFT LOCAL STRATEGIC PLANNING STATEMENT - TOWARDS 2040

NOTE: Michelle Carter and J Frangoples left the meeting at 7:00pm.

N Cocks provided an update to the group on this item.

Towards 2040 is the Northern Beaches Council's first Local Strategic Planning Statement (LSPS) and outlines the Northern Beaches' direction for housing, employment, transport, recreation, environment and infrastructure over the next 20 years. It reflects local values and aspirations, building on the 10-year vision set out in the Community Strategic Plan, Shape 2028. The document will guide future land use decisions for the Northern Beaches Local Government Area through planning priorities, principles and actions that build on the strengths and opportunities as well as addressing key issues and challenges. It will inform Council's new Local Environmental Plan (LEP) and Development Control Plan (DCP) and broader framework of Council policies and strategies.

To support the preparation of Towards 2040 and subsequent LEP and DCP, a number of technical studies are being prepared. The preliminary findings from these studies provide a detailed evidence base and form part of the exhibition package:

- Demographic Analysis.
- Housing Issues and Opportunities Paper.
- Employment Study Background Paper.
- Social Infrastructure Issues and Opportunities Paper.
- Environment Background Report.

Towards 2040 aligns with the higher level plans including the Greater Sydney Commission's (GSC) Greater Sydney Region Plan – A Metropolis of Three Cities (Region Plan) and the North District Plan (District Plan). Towards 2040 comprises thirty planning priorities which fall under these themes and directions. This presents a clear line-of-sight and connection between the metropolitan and district plan, and what this means at the local level.

The draft Northern Beaches Local Strategic Planning Statement - Towards 2040 is now on public exhibition until 10 November 2019.

Following the presentation, the group discussed:

- Meeting housing targets now that Ingleside Planning Precinct is no longer going ahead.
- Meeting current housing targets with a reviewed mix of smaller, affordable and senior housing.
- Connecting housing with transport and parks.
- How strategic centres, infrastructure, services and facilities match growth in the area

Question: Would it ever be possible to have a train station built on the beaches which could incorporated or be surrounded by a cluster of developments to service the line?

Answer: In order for a train line to be built and be viable for operation, it would require up to between 40,000 and 70,000 commuters per day which is double the population of the Northern Beaches Local Government Area.

The draft Bike Plan will be presented at the November ordinary Council meeting for approval to be placed on public exhibition. Council is working with Roads and Maritime Services (RMS) to implement this plan and to date, Council has received \$750K in funding.

Question: How many shared paths do we have for bikes and pedestrians.

Answer: Mapping is on line as part of this project which shows the existing network. This

document will fill in the gaps and assist with functionality. You can currently ride from Dee Why to Mona Vale with some sections being shared with the road. In the future,

roads will turn into a shared environment.
