### **ITEMS DISCUSSED**

K Menzies informed the group of SRG stakeholder engagements and public exhibitions conducted on 'The Road Safety Plan' and noted that most comments and feedback received were regarding a need for a better infrastructure. A workshop was also conducted with a youth advisory group. While different aspects of road safety were discussed, the prevalent view out of the workshop was the need and the importance of education around road safety for all, adults and youth.

Question: Is there information available identifying key behaviours that need to be changed?

**Answer:** Key behaviours are not named but issues such as actions of motorist towards cyclists could be used as an example. Other main causes identified are speed and fatigue.

It was suggested that it might be beneficial to identify and name those key behaviours prior to educating the community.



Questions were raised about road sharing and the ongoing perception that roads are for cars and that bicycles are just a nuisance. The Chair also noted that at the Community and Belonging SRG, aggressive behaviour on the road was identified as one of the key issues from a community's perspective.

# 6.2 UPDATE ON NORTHERN BEACHES HOSPITAL ROAD CONNECTIVITY AND NETWORK ENHANCEMENT PROJECT

### **OVERVIEW OF UPDATE**

### **ITEMS DISCUSSED**

Following the presentation, the group agreed that clearer images of both bike and car friendly options would be more encouraging and would provide additional options to locals. It was agreed that to change the mindset of 'that roads are for cars and bicycles are just a nuisance'; to encourage everyone to think more widely on what roads could be, the messaging needs to be reconsidered and to be more inclusive.

It was also suggested that more community engagement be conducted and the a community be provided with a more visual idea on the progress.



### 6.3 UPDATE ON THE MONA VALE ROAD EAST PROJECT

### OVERVIEW OF UPDATE

A Khan and Ma Yan, provided an update on the project. A copy of the presentation provided to the group is at Attachment 2.

The group was informed of the progress and the challenges encountered during the project, particularly the removal of asbestos contaminated soils; a time consuming and quite expensive process.

The group was also advised that:

- there will be no removal and/or destruction of any material as they are just shifting and reusing materials
- there will be not privacy screens for Ingleside residents
- the road will be clearway.

A Khan advised that due to the complexity of the project numerous resources have been put in place to provide information and answer questions from for the community, including a website and two 1800 numbers. It was also noted that the engagement through regular drop in session and the communication with the residents has been active and residents questions and concerns have been answered.

### 7.0 GENERAL BUSINESS

#### Item 7.1 – Transport for New South Wales (TfNSW) Restructure


T Knox Grant provide an update on the TfNSW structural changes. Changes were a result of and in response to a number of gaps identified in the previous TfNSW structure on roles, responsibilities and on who to contact

T Knox Grant also advised of newly established community and place division:

- for a better connection between people and the organisation
- to ensure better and clearer division and responsibilities
- to improve a connection between what is taken on board and delivered.







#### Item 2 – Parking Scheme

The Chair sought feedback on Council's Parking Scheme, which allows the residents of Manly street parking extensions in addition to the existing parking permits. The Chair noted that since the scheme was created it had created a continuing debate on the prices. The Chair advised on the principle of pricing and that previously, first ticket was free and the second \$47 (compliance from the Roads and Maritime Services). Current pricing is now \$47 for the first and \$121 for the second. The question was asked "if we had a particular scheme, should this be something that is free to residents and subsidised by the rest of the Northern Beaches community or user pay principle"?

The majority of the group felt that the user pays principle should apply with one member dissenting. That member felt that paying for parking outside your home was not fair, nor having rates increase to subsidies the scheme.

## **Project Objectives**

- Allow for long term network performance with Warringah Road and Wakehurst Parkway as key arterial connections between Sydney's north and Chatswood and Sydney's CBD
- Maintain or improve road safety in accordance with current standards
- Provide for improved heavy vehicle access on the network surrounding the hospital
- Increase the levels of active transport

## Key challenges

- Delivery timeframe for Stage 1 due to hospital opening
- Property acquisition and associated timeframes
- High impact work in highly urbanised environment
- Significant disruption to residents, local community and commuters
- Community support and resident fatigue with ongoing night work and high noise activities
- Delivering the upgrade under live, dynamic conditions with 100,000 vehicles moving through the project site daily

- Utilities and services relocation (+ 150 cutovers for service relocations) & unknown unidentified services


















## Site Locality






## Scope of Works – Main alignment





## Scope of Works – Typical x-sections








## Scope of Works – Western Early Works

## Current status of project

- · Clearing and grubbing of vegetation
- · Removal of asbestos contaminated soils
- · Commencement of major earthworks including stabilisation of subgrade
- · Relocation of high voltage overhead power lines
- · Relocation of sewer and Optus IOF
- · Commencement of stormwater including construction of open drains
- · Completion of retaining wall 2 and wall 6
- · Lateral shift of the road alignment
- · Extension of the right turn bay into Tumburra Street (20 metres)
- · Property adjustment works

## Upcoming works – next 6 months

- Continuing major earthworks
- · Ongoing identification and removal of asbestos contaminated soils
- Continuing drainage
- Continuing erection of fauna fencing
- · Continuing property adjustment works
- Relocation of underground and above ground utilities
- · Commencement of fauna bridge abutment
- · Major lateral shift to allow for continuation of structures
