# 6.0 AGENDA ITEMS

## 6.1 CHILDREN'S SERVICES STRATEGY

### **DISCUSSION**

M Messina, Acting Director of Community and Belonging and Rosemary Nettleship, Manager Family Day Care provided a presentation in relation to this item. The following points were highlighted:

- Quality affordable childcare services that support families and children is a priority for Northern Beaches Council.
- Local Government plays a key role in supporting low income, disadvantage or vulnerable families in the community. It also plays a key role in meeting the needs of children with additional needs.
- A Children's Services Strategy has been developed in order to plan for the future needs of children and guide the delivery of education and care services for children and families in the community.
- In order to design the Children's Services Strategy, consultation was undertaken by Urbis. A

range of different stakeholders provided feedback.

- Engagement activities included Councillor and management team workshops, focus groups, surveys to children's services customers, phone surveys and research regarding children's services offered by other Councils.
- Feedback included the need for more vacation care and long day care, more services in the north of the Northern Beaches, flexible delivery and innovative programming.
- The 4-year Strategy includes focus areas, each with specific actions that will be achieved over this period.

# **Next Steps**

 Review the 32 submissions received, update the strategy and present the updated strategy to Council for adoption.

The number of vacancies and hours of operation at the centres and vacation care were discussed. The rationale for Council's role in the provision of children's services was also discussed, focusing on the role of Council supporting the more vulnerable and disadvantaged people in the community and providing choice. Comments made also noted that the Strategy focuses on Council provided children's services and discussion on how Council could work with non-Council service providers. Council welcomes the possibility to work with the private sector in order to share knowledge.

#### 6.2 OPEN SPACE AND RECREATION STRATEGY - OVERVIEW

# **DISCUSSION**

Damian Ham, Manager Open Space and Recreation Planning provided a presentation on this item. The following points were discussed:

- The Open Space and Recreation Strategy (the Strategy) is a 15-year strategy.
- The Strategy will guide the development and management of Northern Beaches open spaces and outdoor recreation facilities.
- Action Plans that highlight specific commitments will be developed and reviewed every 5 years.
- Key themes of the Strategy are parks, playgrounds, beaches, tracks and trails and recreational use of bushland areas.
- The Strategy will integrate with Council's strategies and plans, including the Community Strategic Plan, Arts and Creativity Strategy, Destination Management Plan and Environment and Climate Change Strategy.

Discussion arose and members discussed ideas to improve access to recreational spaces. A question regarding community consultation and the use of the "Have Your Say" page was raised.

In response, it was stated that Council takes into consideration all feedback received by community members when undertaking projects. SRG members also highlighted that alternative mechanisms should be used to engage people with disability.

Some suggestions for improvements to open spaces were dancing lessons, chess and backgammon tables in the parks for seniors.

## 6.3 VOLUNTEER POLICY

### DISCUSSION

N Watson, Volunteer Coordinator provided a presentation in relation to this topic. The following points were highlighted:

- The Volunteer Policy outlines Council's philosophy, roles and responsibilities regarding volunteer involvement.
- Council has over 900 volunteers working in 12 Council services across the Northern Beaches.
- An Integrated Volunteer Management Framework is being developed to ensure that Council volunteers are managed effectively and consistently across Council.
- The framework aligns with best practice standards as outlined by Volunteering Australia in the National Standards for Volunteer Involvement.
- The Integrated Volunteer Management Framework consists of 3 key components:



- Volunteer Policy
- Procedures for Recruiting, Inducting, Managing and Exiting Volunteers
- Volunteer Database Software System
- Roles and Responsibilities of Volunteering
- Principles embodied in the management of volunteers

## Next Steps

- Consultation with SRG members and supervisors of volunteers within Council
- Volunteer Policy is drafted March 2020

SRG members participated in a workshop about the philosophy on volunteering. The following question was raised for discussion: What are the benefits of volunteering for the individual, Council and Northern Beaches community?

The SRG discussed the idea of a central volunteer hub and volunteering information on Council's website - <a href="https://www.northernbeaches.nsw.gov.au/things-to-do/volunteering">https://www.northernbeaches.nsw.gov.au/things-to-do/volunteering</a>.

The process of volunteer applications was discussed, including the telephone interview where candidates are asked about their interests. Skills and previous experience are taken into consideration when offering roles to volunteers.

It was highlighted that Council should run workshops for organisations that provide volunteer services in order to share expertise and the volunteering programs on offer by Council.

SRG members believe that volunteers should be acknowledged.

#### 6.4 BIG IDEAS FORUM

#### DISCUSSION

W Wrathall, Team Leader Community Development and J Smith, Community Development Officer, provided a presentation on this topic.

The following points were discussed:

- Big Ideas Forum (the forum) is a quarterly forum ran by the Community Development Team.
- The forum was established in March 2019 and since then different forums have been held. Topics included "Why Neighbourhoods Matter", "Mental Health", "The Ageing Revolution"
- This forum provides opportunity to local groups and services to promote themselves and provide information on what they do. Council partners with local services and artists to present at the event.
- Community members are encouraged to provide suggestions for future topics via Council's website and in person via the event feedback

- The topics for Big Ideas Forums are determined through the identification of social issues and available speakers and working with groups and services.

Suggestions by SRG members included scheduling the events on nights other than Wednesdays and in different venues across the Northern Beaches. It was highlighted that this was a great program, one of the best things Council has organised for the community

The group participated in workshop regarding topics for consideration for the next 2020/21 Forums. Options considered were: technology (intergenerational debate), environment and sustainability, free speech and democracy, religion and ethics and housing and homelessness.

A pamphlet for the next Big Ideas Forum to be held on 4 March was circulated to the group.
