ISSUE

The purpose of this workshop is to identify current challenges and aspirations to shape the Northern Beaches Economic Development Plan.

BACKGROUND

Council's Delivery Program states that an Economic Development Plan (EDP) be prepared for the Northern Beaches. Previous EDPs have been prepared for the former Pittwater and Warringah Councils, but this will be the first Northern Beaches wide EDP.

Work on the EDP commenced in 2019 with the completion of the draft Northern Beaches Employment Study, which identified emerging industry trends and recommendations for key employment centres to support job growth over the next 20 years. This was presented to the Economic & Smart Communities SRG in February 2020. Following this technical study, Council is now developing an EDP which will have actions to work with the business community to support job growth and business activity across the Northern Beaches, over the next five years.

With the onset of the economic crisis due to the global COVID-19 pandemic, the EDP has heightened importance, and needs to recognise and respond to volatile business conditions. It is proposed that the EDP includes both a short-term recovery phase (two years) and a longer-term economic growth phase (two to five+ years).

DISCUSSION

To kick-start the preparation of the EDP, we are holding an "out of session" workshop with members of the Economic & Smart Communities SRG. This will set the strategic directions for the EDP by establishing an agreed framework for the Plan's development, including challenges, aspirations and ideas.

To make the most of this opportunity we have engaged the services of an Economic Development expert to facilitate this workshop. Nathan Pratt, from NDP, has a wealth of experience in writing local government EDPs and has led the creation of economic development strategies at Strathfield, City of Ryde, City of Parramatta and City of Sydney Councils. He is also President of the NSW Economic Development Partnership, a network of ED officers from across NSW.

This interactive workshop will be run virtually and will encourage breakout group discussions and idea sharing through a range of techniques.

In preparation, below is a series of questions which will be workshopped. Economic & Smart Community SRG members are encouraged to provide initial responses to each of these items in advance of the workshop to inform discussion.

- 1. What can be done to support business recovery from COVID-19 in the short-term?
- 2. What do you see as key barriers to business growth on the Northern Beaches?

- 3. What are the longer-term aspirations for the Northern Beaches as a place to do business?
- 4. What are your ideas on how these aspirations will be realised?

The latest available data, including economic outlook (jobs and GRP) to December 2021, from .ID The Population Expert and local spend data from Geografia, will also be shared to inform discussion on current economic conditions and recovery.

Through discussing the above questions, we will identify the directions/themes and potential actions, to shape the Northern Beaches EDP.

The output from the workshop will inform a draft outline of the EDP which will be presented at the next Economic & Smart Communities SRG on 18 November 2020.
