2. Nov 2020: Present draft Plan to the Community Safety Committee for endorsement


3. Feb 2021: Submit draft Plan to Council to approve for public exhibition

#### **ISSUE**

To brief the Committee on actions implemented by the Northern Beaches Suicide Response Steering Group and other suicide prevention and response initiatives.

#### **DISCUSSION**

#### Northern Beaches Suicide Response Steering Group

In June 2018, Council's Community Safety Committee resolved to form a Working Group to address growing concerns in the community about deaths by suicide on the Northern Beaches. In April 2019 this group was succeeded by the Northern Beaches Suicide Response Steering Group. The Steering Group plays a leadership role in the suicide prevention space, with a focus on coordination, communication, advocacy, intervention and postvention. The Steering Group continues to meet quarterly to oversee the coordination of strategies within a local Action Plan.

Members of the Steering Group include:

- Community Care Northern Beaches (CCNB)
- Lifeline Northern Beaches
- Northern Beaches Hospital
- Northern Beaches Lived Experience Group
- Northern Beaches Police Area Command
- Northern Sydney Local Health District (NSLHD)
- Sydney North Health Network (SNHN)
- Ambulance NSW.

#### **Suicide Postvention Pilot Protocol**

One of the most pressing issues identified by the Northern Beaches Suicide Response Steering Group was the need for a coordinated response following a death by suicide. Police, Lifeline Northern Beaches, Council and Community Care Northern Beaches (CCNB) worked closely to investigate other models which could be adapted for a local response to support both families and the broader community. Funded by CCNB, a critical incident response protocol has been trialled since July 2019 to allow for better coordination of key agencies and services following a death by suicide or a suicide attempt. Ensuring long term sustainability for the Postvention Protocol is a key priority for the Steering Group.

CCNB are continuing to fund and resource the Northern Beaches Suicide Postvention Pilot Protocol with a second evaluation being conducted by Dr Grenville Rose. CCNB have had a substantial increase in notifications in recent months, with middle aged men being the highest statistic.

#### **Suicide Prevention Community Gatekeeper Training**

Council was successful in securing grant funding of \$340,000 from NSW Ministry of Health to roll out suicide prevention community gatekeeper training on the Northern Beaches. The funding is for a period of three years to deliver suicide intervention skills training and suicide awareness activities to over one thousand 'Community Gatekeepers', targeting middle aged men, young people, seniors and emergency services. A project officer has been employed to coordinate the delivery of training and a range of suicide awareness activities. Council continues to receive a steady number of community members signing up for training. All training has transitioned online in response to COVID-19, with participants completing LivingWorks Start and a debrief session with a LivingWorks trainer.

To date 293 people have completed the Gatekeeper Training. Community members are encouraged to sign up for training, and this registration can be done online here.

Council and service partners ran a free 'Safe and Sound' wellbeing webinar series in May and June 2020. The six webinars are aimed at supporting young people, youth supports, men, women, seniors and LGBTIQA+ communities to reinforce referral pathways to local services and community groups that focus on some key issues the community may be experiencing. 208 people watched the Safe and Sound webinar series live, with a further 420 people viewing the webinars on Council's website: <a href="https://www.northernbeaches.nsw.gov.au/community/safety-and-wellbeing/suicide-prevention/safe-and-sound-webinar-series">https://www.northernbeaches.nsw.gov.au/community/safety-and-wellbeing/suicide-prevention/safe-and-sound-webinar-series</a>

Future projects under the Gatekeeper Training project include:

- Development of a podcast for emergency services bringing to light the referral and internal pathways when dealing with an event
- Accidental Counsellor Plus training for emergency services, in partnership with Lifeline Northern Beaches. The first session will involve the Rural Fire Service, with more training for other emergency services scheduled for early to mid-2021.
- Life Transitions webinar series for late 2021.

#### **Mindframe Plus Training**

Mindframe is a national program supporting safe media reporting, portrayal and communication about suicide, mental ill-health and alcohol and other drugs. Mindframe is managed by Everymind and is funded by the Australian Government's Department of Health under the National Suicide Prevention Leadership and Support Program. The Steering Group noted that following recent deaths by suicide, there was much discussion online about suicide, some messaging was not always helpful, and in some cases may have been harmful to those who were vulnerable. Council partnered with Everymind to provide Mindframe Plus online training, giving participants the confidence to use appropriate language online when creating a post, sharing someone else's post,

or responding to someone who might be experiencing suicidal thoughts. Sessions were held on 3 September for the service sector and 21 September for community members. Everymind assisted with designing proactive positive messaging and mental health literacy for stakeholder use and social media safe messaging. 25-30 people attended each online session.

#### **Local Suicide Prevention Network**

In addition to coordination with local services, the Steering Group is partnering with Wesley LifeForce to establish a community led network to complement the service system and encourage the inclusion of those affected by suicide. Wesley LifeForce received federal funding to establish Networks across the country and have now held three community meetings online, with over 48 people attending the first two meetings. This is a very high number of participants compared to other regions.

Meetings to date have workshopped identifying skills within the community and key areas of interest which the Network wish to focus on. The next online meeting is scheduled for Tuesday 6 October. #### **Hotspot Management and Means Restriction**

Council continues to actively monitor high risk headland locations, and undertake safety audits with Police when required, as well as installing permanent or temporary fencing and natural barriers where appropriate.

Council is also represented on the National Suicide Hotspot Advisory Group which provides advice, guidance and support for locations which have been deemed at high risk for death by suicide. Northern Beaches Council is the only local government representative on the Group. The Advisory Group met for the first time in February 2020. The Group meets quarterly and is convened by Lifeline Australia. The Group will examine key locations nationally to provide appropriate solutions and guidance.

Lifeline Australia are supporting the Northern Beaches Suicide Response Steering Group in considering innovative ways of managing headlands across the Northern Beaches. Council is a representative on the Advisory Group's working group focused on 'Community Engagement and Increasing Likelihood of Third-Party Intervention' and is assisting with the development of a toolkit which will guide Councils across Australia on all aspects of hotspot management.

#### Avalon Community Meeting on Suicide Prevention - 27 September 2020

Council facilitated members of the Northern Beaches Suicide Response Steering Group to hold a community meeting in response to a recent suicide which had caused considerable community anxiety and grief. The meeting was held at Avalon Recreation Centre on Sunday 27 September, with 37 people attending to talk with local community organisations; Community Care Northern Beaches, Lifeline Northern Beaches, Council, OneEighty and Avalon Youth Hub. Residents had the opportunity to hear about what was happening in the region around suicide prevention initiatives, and to voice their concerns around suicide prevention and community safety. Invitations were letterbox dropped to residents around the Bangally headland area, and invitation extended to people who had been in contact with local organisations voicing their concern.

Participants were informed of ways they can be involved in suicide prevention, from training opportunities, to joining the newly formed Northern Beaches Local Suicide Prevention Network, as part of a whole of community response.



#### **State and Regional Initiatives**

## A. Northern Sydney Joint Regional Mental Health, Suicide Prevention and Drug & Alcohol Plan (Joint Regional Plan)

The Joint Regional Plan is a platform for enhancing collaboration and coordination between Northern Sydney Local Health District (NSLHD), Sydney North Health Network (SNHN) and community partners around a number of agreed local needs and priorities.

In response to COVID-19, the delivery date for the Joint Regional Plan has been extended to 31 December 2020. SNHN will be consulting with the Northern Beaches Suicide Response Steering Group in October 2020. Outcomes from recent sector and community consultation have resulted in six priority areas in the Joint Regional Plan:

- 1. Supporting mental health service coordination and collaboration through regional planning, co-design and partnership
- 2. Building community resilience and capacity to respond to suicide attempts and deaths
- 3. Improving the physical health and nutrition of people living with mental illness and alcohol and other drug issues
- 4. Improving mental health literacy by increasing community awareness of available services and enhancing access
- 5. Improving the mental health of priority population groups including CALD groups, Aboriginal and Torres Strait Islander community and LGBTI community members
- 6. Enhancing coordination and of service access for people using alcohol and other drugs.

#### **B. NSW Towards Zero Suicide Initiative**

NSLHD have appointed a Clinical Change Manager tasked with the primary goal to reduce suicide rates with three focus areas:

- 1. Towards Zero Suicide In Care a large part of the role, addressing inpatient and community settings and developing safety planning and developing clinician capacity
- 2. Outreach in community teams
- 3. Alternatives to Emergency Department during crisis.

Current key focus is a district wide rapid response to youth suicide to reduce wait times during crisis which will include consultation with the community and the Steering Group.

#### **COUNCIL SUPPORT**

Council continues to coordinate the Suicide Response Steering Group and is committed to providing leadership in suicide prevention and response, as detailed in the following resolution of Council on 29 September 2020:

- 1. That this Council:
  - a. Extends its sympathy to local families who have lost loved ones through suicide and acknowledges concern in the community about the continued tragic attempted suicides and loss of life.

- b. Reaffirms its commitment to be a leader in suicide prevention and that Council will continue to work with the community to prevent suicides, noting that Council was awarded \$340,000 to train 'community gate keepers', has assessed all high risk areas on the Northern Beaches and placed LifeLine details at key sites, strategically placed specially designed barriers at a high-risk location and undertaken prevention work in schools.
- 2. Requests the CEO to furnish a short report to the next meeting of Council:
  - a. The status and outcomes of Resolution 24/2019 "United Action to Stop Suicides" submitted by Councillors De Luca and Sprott and subsequent Resolution;
  - b. An update on all of Council's current initiatives in relation to suicide prevention and outline of any actions and required resources to effect further initiatives regarding suicide prevention on the Northern Beaches, particularly in relation to any outstanding infrastructure required at high risk locations and resources to conduct education and awareness programmes.
  - c. Include efforts to work with other relevant agencies to improve the quality of suicide data and reporting.

As such, a report will be presented to the Council meeting on 27 October 2020. Any potential actions that are identified will be the subject of consultation with members of the Suicide Response Steering Group and relevant agencies.

- A. That the information be received and noted.
- B. That the Committee provide comments on potential actions for discussion with the Suicide Response Steering Group and consideration by Council regarding suicide prevention.

#### **ISSUE**

Safer by Design – Crime Prevention Through Environmental Design (CPTED)

#### **BACKGROUND**

The Northern Beaches Draft Public Space Vision and Urban Design Guidelines (PSV&DG) sets out to unify and consolidate public domain guidelines policy and materials palettes of the former three councils. The guidelines are used to evaluate, plan and design streets and open public spaces. Council at its meeting of 29 September 2020 endorsed the document for public exhibition <a href="https://yoursay.northernbeaches.nsw.gov.au/northern-beaches-public-space-vision-and-design-guidelines">https://yoursay.northernbeaches.nsw.gov.au/northern-beaches-public-space-vision-and-design-guidelines</a>.

#### DISCUSSION

Critical to the successful implementation of public space design is crime prevention through environmental design. The principles of CPTED, as defined in A5.5 Safer by Design (p.xxii) of the PSV&DG, set out to promote and support positive and desirable use of open space with CPTED principles applied holistically throughout the Northern Beaches.

Risks to community can be reduced through considered and sensible design solutions, lighting, anti-graffiti mechanisms and finishes in material selections, appropriate lighting that addresses public space safety and pedestrian movements and landscaping, including increased tree canopy coverage to mitigate the effects of UV radiation. Active planning that incorporates safety can lead to reducing opportunities for criminal behavior and improving perceptions of safety in the community.

The document sets out street design objectives with key principles of safer design addressed through a considered and consolidated approach to street design, materials palettes and furniture selections that provide a baseline of best practice principles, with recommendations addressing character, buildability, sustainability, safety, durability, economy and quality, and new and upgraded infrastructure embedding smart technology, adopting interoperability protocols and cybersecurity standards.

#### **RECOMMENDATION**

That the Community Safety Committee:

- A. Note the key principles of Crime Prevention Through Environmental Design outlined in the draft Public Space Vision & Design Guideline document.
- B. Provide comments or suggestions for inclusion prior to the final report being presented to Council for endorsement, following public exhibition.
