- Final designs are not yet available



Action: Investigate indigenous representation on the committee & provide an update at the February 2019 meeting.

- State no mandatory requirement, though it would be appropriate to include a representative of local indigenous people in the committee
- Council no objection to amending the Committee's Terms of Reference



Action: Provide committee with the State government contacts for land claims & information about any current land claims related to the State Park at the February 2019 meeting.

• The State manages any land claims and will discuss during the meeting.



Action: Provide update on Manly Dam Playplace project.

At December 2018 Council meeting it was resolved to:

- Upgrade Manly Dam playground & allocate \$300,000 of the Connecting All Through Play - Inclusive Play program for that purpose.
- Consult with all stakeholders involved in the project to date on the draft design before implementation.
- Allocate \$1.2m to develop an inclusive playground, upgraded public toilets & other facilities at Clontarf Beach per the masterplan currently being developed.



Action: Provide the committee with information about grants available for State Park projects as grant opportunities arise.

Crown Reserves Improvement Fund

- Opens 11/2/19, closes 22/3/19
- Provides financial support for the development, maintenance & protection of Crown reserves
- General projects, State Parks are eligible
- Ideas for funding? Discuss.

6.1 Capital Projects Update

- Playground in Picnic Area 1
- Toilets in Picnic Area 1 planned completion March/April 2019 (before ANZAC Day)
- Proposed upgrade to walkways including signage 2019/20



6.2 Operational Program Update including Bush Regeneration

Bush Regeneration Program

- Annual program funded by Council
- \$163,397 for 2018/19
- Northern Park area incorporates works on the Allambie side
- Southern Park area incorporates works on the Balgowlah/Seaforth side



6.2 Operational Program Update including Bush Regeneration

Bush Regeneration Program

- Annual Maintenance
- 107 hectares of active bushland
- 32.8km tracks/trails
- 15.5km foreshore & creek/drainage lines
- 8 hectares of Asset Protection Zone



6.2 Operational Program Update including Bush Regeneration

Key Issues include

- Encroachment by adjoining development & associated runoff incidents
- A faltering Sydney Water sewer system running through the Allambie side of the Park
- Creation (& constant re-opening after closure) of illegal bike tracks in numerous locations



6.3 Plans of Management

- With introduction of the Crown Land Management Act 2016, Council will become Crown Land Manager of 168 reserves previously managed under Reserve Trusts including Manly Dam
- State has provided Council with \$99,784 to assist with development of compliant PoMs by 31 June 2021. More resources are needed to meet this timeline.
- A prioritisation process for developing new or updated PoMs is underway - Manly Dam PoM will be a priority (timing for updated PoM to be known in May 2019)
