# **Environment and Climate Change Strategy (draft)**

- Recommends baseline studies, audits, full documentation of natural systems to inform
  - strategic planning , DA assessments
  - development controls, compliance
- Relevance to Manly Dam and operations
  - Bushfire planning and responses to other natural environment events refine planning
  - Formalise Park boundaries and land reservation status where anomalies currently remain and good conservation practice dictates.
  - Community awareness and education partnerships to be fostered with community, business, academia



# **Bushland and Biodiversity Policy (draft)**

- Recommends baseline studies, audits, full documentation of natural systems to underpin identified environmental values and ID core habitats, wildlife corridors and threatened communities.
- Relevance to Manly Dam and operations
  - Maintain, restore and enhance key areas identified above.
  - Improved compliance process.
  - Manly Dam close to major proposed developments hence relevance of above.
  - Collaboration with volunteers, adjacent landowners, business, government, academia and foster partnerships.
- Idea Manly Dam (as a freshwater system at the top of a catchment) to complement the CEC (saltwater and coastal/estuarine system) as a centre for environmental education and research etc



# **Keeping of Animals Policy (draft)**

- Promotes awareness and responsibility via working with and communicating with the community.
- Relevance to Manly Dam is:
  - ➤ Potentially less domestic pet issues within the Park and surrounding area with greater emphasis on compliance.



# Water Management for Development Policy (draft)

- Focus on quality of water discharged into natural systems. Quality criteria include biological, temperature, sediment load, salinity, profile of discharged waters.
- Water quality to be at a level to protect coastal ecosystems, maintain recreational opportunities and meet public health requirements.
- Goal to preserve, restore, remediate, maintain natural watercourses and corridors.
- Greater attention to these factors in planning, DA assessment, construction and ongoing management of areas and structures.
- Relevance to Manly Dam
  - > Very relevant due to scale of surrounding existing and proposed developments.
  - Impacts the quality of water coming into the Park and thence into the lake.
  - Techniques (hard or soft engineering) to intercept major road spills on Wakehurst Parkway and Warringah Rd to be canvassed.



# **Planning Proposal (Mermaid Pool)**

- Manly Creek formally identified as a significant wildlife corridor linking Manly Dam and the coastal system of Manly Lagoon and the beach. Includes the estuary and the adjacent flood plain.
- Rezoning of identified land parcels supports and reinforces the integrity of this system.
- System incorporates corridor, cultural heritage (pre and post European),
   landscape, biodiversity/remnant bushland, public access and recreational open space components.
- Draft identifies factors that complement the current Manly Dam Plan of Management which directs to protect and enhance this link.
