- Ann Sharp outlined her views, and the views of the Save the Manly Dam Catchment Committee, regarding land categorisation for the State Park. Ann stressed that it is essential that the State Park, particularly the bushland and vegetation is given the utmost protection and conservation for now and into the future and the land categorisation should reflect this. Ann made specific mention about the bushland and vegetation at the Wakehurst Golf Course and at the Aquatic Reserve part of the State Park.
- Jessica commented that it was generally not recommended to have small or isolated areas of trees or bushland categorised as natural area. That trees and bushland in any location are still covered by standard protections and legislation as appropriate, regardless of the land category.
- The Advisory Committee requested that the Area of Cultural Significance Category be overlayed across the entire State Park. Agreed.

#### **ACTION**

That Council consider the views of the Advisory Committee regarding the proposed land categorisation for the State Park and the request that the Area of Cultural Significance Category be overlayed across the entire State Park.

## 4.0 GENERAL BUSINESS

- Geraldine mentioned there was vandalism of the toilet block in section 1 on the weekend and broken bottles and rubbish everywhere. The water ski club tried to assist in the clean-up. Some people left the park due to the limited access to the toilets caused by the damage. Chris said that police were called and additional security has been arranged. Also that this vandalism occurs in waves. Steve said that he would have a conversation with the police about vandalism at the State Park.
- David asked about the Environmental controls in place for the operations of the Wakehurst Golf Course.
- Geraldine asked if 'don't feed the ducks' signs like the ones around Narrabeen Lagoon could be arranged for the State Park. Chris said that there are already sandwich boards with this message on them that are placed around the edge of the lake.

#### **ACTION**

 That the Advisory Committee are provided with a copy of the Environmental controls for Wakehurst Golf Course.
