1 Welcome and Introductions

The Administrator, Dick Persson welcomed the Local Representation Committees (LRC).

The following points were discussed and updates were provided:

Recent Storm Events

- Feedback was received regarding Council staff and volunteers that attended the affected sites and provided aid.
- All affected residents have been contacted by the Administrator and help has been provided.
 Engineers have been appointed to provide their expertise and assistance to affected residents.
- Construction of sea walls

NORTHERN BEACHES

- Council facilities (meeting rooms) have been allocated for residents to meet and discuss their current situation with the Administrator and General Manager of Northern Beaches Council.
- Emergency Planning for Storms and Floods

The following questions were raised by the members of the committee:

- Q: What measures Northern Beaches Council is undertaking for the next big storm that has been predicted to hit Sydney?
 - A: Interim protective measures are currently being developed. Sand bags will be placed in front of the affected properties
- Q: What will be Council's contribution to affected residents?
 - A: A specific amount was not provided as yet however we are working on a combined contribution from all levels of Government along with the affected property owners
- Q: Which other sites were damaged?
 - Area South of Palm Beach
 - Shelly Beach walkway will need to be assessed by Sydney Water for repairs before walkway can be reconstructed.

Entry signs to Northern Beaches Suburbs

- Q: What has been done with the entry signs to the previous council areas? Where are the signs currently being stored?
 - A: The signs are currently being stored by council and will be kept for historical purposes.

Members raised the point that the signs could be displayed at Kimbriki in order for community members to visit the site and view the signs

Financial Summary

- Operational Draft Plan 2016/17 Northern Beaches Council (draft operational plans of each of the former councils Manly, Warringah and Pittwater have been used as the basis to develop the current draft plan)
- Major Capital Works:
 - PCYC Dee Why
 - Church Point Improvements
 - Macpherson Street Bridge, road and footpath
- The budget 2016/17 projects total expenditure of \$484.5 million, including a capital works program of \$129.3 million.
- Merger Costs and Fund Funding from the NSW Government is available to Northern Beaches Council, \$10 million towards the merger costs of the new organisation and a further \$15 million through The Stronger Communities Fund for projects for each new council to spend on priority community initiatives.
- Community drop-in information sessions will be held to discuss the draft Operational Plan on the following dates
 - Manly Library Monday 20 June 5:30-7:30pm
 - Mona Vale Library Tuesday 21 June 5:30-7:30pm
 - Dee Why Library –Thursday 23 June 5:30-7:30pm
- Draft Operational Plan Timeline
 - Exhibition Opens 3 June
 - Exhibition Closes (end of submissions) 1 July
 - Council Meeting to adopt Operational Plan 7 July
 - Operational Plan commences 1 August
- A number of submissions were received on the previous exhibitions of the individual council
 plans. These submissions will be collated along with submissions on the combined
 Operational Plan. In total there are approximately 40 submissions.
- Q. What is planned for the different Fees and Charges across the Northern Beaches ie. Pittwater has an helicopter landing fee and Warringah does not?

A: The fees and charges currently on exhibition reflect the draft fees that were exhibited prior to the merger. Council will look to harmonise the fees and charges across the area as part of the 2017-18 Operational Plan.

Kimbriki Access Road

- Q: What will happen to Mosman Council's contribution towards Kimbriki tip?
 - Mosman Council will continue to be a shareholder of Kimbriki Environmental Enterprises which operates Kimbriki tip.

Other Questions:

- Q What savings have been achieved?
 - A: Savings will be achieved from reduction in senior staff and extension of self-insurance policy for workers compensation
- Q. What is the Notice of Rescission Motion no 1/2016 RFT 2015/105 Warringah Aquatic Centre Adjoining Land Tender (MC/16/70732) on the next Council agenda?
 - A: This rescission motion will allow the Administrator to reconsider the previous tenders and progress negotiations if required

Role of the LRC

- The LRC is a forum where members have the opportunity to continue dialogue with Council
 and it provides a connection opportunity
- · Aim of the committee is strategic rather than operational
- · Promote innovation and opportunities for service improvement
- Q: How are the ex-councillors monitoring their old email addresses? What is happening to emails sent by community members to the ex-Councillors? Are appropriate Council staff monitoring their emails?
 - A: Former Manly Council staff (governance business unit) are currently monitoring the ex-Councillors old emails and addressing the community members concerns. Automated messages are in place to ensure community members know where to address their customer requests.

Quick Wins - Learn from works well now and roll out across area ie in Manly:

- No alcohol advertising on Council managed Bus shelters
- Have more public fountains / water bubblers across the northern beaches (bubblers Drinking fountains) = reduction of bottles in waste = savings in collections
- Council leased premises terms and conditions to restrict use of disposable items
- Council events to include restrictions on stall holders using disposable items
- Provide fee :no junk mail stickers' for residents

LOCAL REPRESENTATION COMMITTEE - ECONOMIC

There were 6 themes raised at the initial meeting which the group wanted to concentrate on:

- Make Council financially sustainable and transparent
- Deliver Plan to the Community (test & measure)
- Ongoing cost efficiencies, innovations and resourcefulness
- Contribution to 20/07/16 CSP
- Community's diverse interests
- · Distribution of Services to the Northern Beaches

It was decided that the best way forward was to merge the Economic themes from the 3 former Council CSP's of the previous Councils into one document for them to review.

There was also a request for the current Fees and Charges on exhibition of the previous year, the Executive Officer reiterated that this request would need to be provided to the General Manager for consideration.

The group requested that the Asset Register of the 3 previous Councils also be combined into one document to include both natural and built assets for the Economic Local Representative Committee to consider.

One member requested that documents be distributed a week prior to the meeting to allow time to review if possible.
