Mayoral Minute No 19/2010 Surf Life Saving Sydney Northern Beaches – Support for Bid to Host Championships for 2013 and 2014

Surf Life Saving Northern Beaches is preparing a formal bid to host the 2013 and 2014 Surf Life Saving Australian Championships on beaches throughout the Manly, Warringah and Pittwater Council areas and are seeking 'in-principle' support for the bid from the three councils.

The Gold Coast (Kurrawa) has become the semi-permanent base for the championships and have an agreement to host most of the championships until 2020 except for 2013 and 2014. Surf Life Saving Australia has sought tenders from 'interested parties' for the 2013 and 2014 championships and have stated they would be keen to hold the event in New South Wales given the last time they were held in NSW was in 1990-1991.

In order to host the event, Surf Life Saving Northern Beaches requires support from the relevant Councils and Life Saving Clubs and has commenced discussions with the relevant State Government agencies to secure funding for the event.

A national event such as this would require considerable planning and Surf Life Saving Northern Beaches is keen to work with all the relevant parties to streamline the technical aspects of hosting such an event. An event like this would certainly increase tourism and business for the area and would give our local competitors an opportunity to compete in front of a home crowd.

At this stage, Surf Life Saving Northern Beaches is seeking in-principle support from each of the three councils on the northern beaches to assist with their bid to host the event. It is understood Pittwater Council and Manly Council will also consider this request at their next meetings.

As this event would not be held until 2013 – 2014 Council would have sufficient time to consider the allocation of funding required and assign funds outside of general operations funding.

RECOMMENDATION

- A. Warringah Council provide 'in-principle' support to Surf Life Saving Northern Beaches for their bid to host the 2013 and 2014 Surf Life Saving Australian Championships.

REPORT

Background

Council, in endorsing the Strategic Community Engagement Framework in May 2009, provided clear direction that a future committee framework was to comprise 3-4 high-level Strategic Reference Groups and a series of grass-roots Community Committees, each with advisory responsibilities.

Further to this, at its Ordinary Meeting on 23 March 2010, Council adopted the recommendations of the Community Engagement Working Party which included
