REPORT

BACKGROUND

Development Approval has been granted through the Land and Environment Court for a Seniors Housing Development at No.21-23 Mona Street, Mona Vale. One of the Conditions of Consent requires the developer to submit plans for a pedestrian refuge on Bassett Street near Mona Street, for approval by the Local Traffic Committee prior to release of a Construction Certificate. The Plans have now been received.

LOCATION

Bassett Street is a local road carrying moderate volumes of traffic. It performs a collector road function linking Pittwater Road to Mona Street. Pittwater High School is located on the north side of Mona Street opposite Bassett Street and the Winnererremy Bay Park and bike track are located to the east of the high school. The above facilities generate pedestrian activity across Bassett Street and the Seniors Housing Development will increase pedestrian movements across Bassett Street.

ISSUES

- Seniors Housing Developments are required to have safe and convenient pedestrian access to bus stops within 400m of the development. The pedestrian refuge and associated footpath adjustments will facilitate this.
- The footpath on Bassett Street is used by pedestrians as well as school aged cyclists and as such, the pedestrian refuge has been designed to facilitate storage of a bicycle within the traffic islands
- Buses turn into and out of Bassett Street at Mona Street and the refuge has been designed to allow for this to occur.
- Parking will be minimised by the use of kerb blisters on either side of Bassett Street, which reduce the extent of No Stopping required.

PROPOSAL

Council has undertaken a review of the location and issues and supports the introduction of a pedestrian refuge at the subject location, to assist residents of the Seniors Living Development to access public transport and to improve general pedestrian safety and amenity in the location

REPORT

BACKGROUND

Council has received concerns from local residents regarding difficulties safely accessing driveways and travelling along Beatrice Street, Clontarf. Parked cars on both sides of the street reduce the road width and increase the risk of collision when accessing driveways or proceeding along narrow sections of the road.

LOCATION

- Beatrice Street through Clontarf and Balgowlah Heights is a collector road that caters for two-way traffic connecting Cutler Road/Amiens Road and New Street W, with a 50km/h speed limit.
- The subject section of Beatrice Street has a gentle slope which provides ease for southbound traffic to gain speed.
- This street has an available road width of approximately 6.7m, and road centrelines are not installed at this location.
- On-street parking is generally unrestricted on both sides of this road.
- Adjacent land use consists of low-density housing.
- Bus routes 162, and 171x and multiple school services pass through this section of the street.
- A section of the footpath with limited width exists south of the driveway of No.28 in this location.

ISSUES

- Parallel parking is unrestricted on both sides of the street.
- Parked cars on both sides of the street reduce the road width and increase the risk of collision when accessing driveways or proceeding along narrow sections of the road.

PROPOSAL

Council has undertaken a review of the location and issues and proposes to install 2 lengths of No Parking restriction on the <u>east side</u> of the street:

- 1. Starting 6m north from the driveway of No.36 Beatrice Street, ending 6m south from the driveway of No.34 / No.32.
- 2. Starting 2m north from the driveway of No.30, ending 2m south from the driveway of No.24

PEDESTRIAN AND CYCLING IMPACT STATEMENT

This proposal will have the following impact(s) on pedestrians and people cycling:

- The proposal will have no impact on people cycling and does not affect any future planned facilities.
- The proposal does not affect the pedestrian facilities or impact on walking paths.

CONSULTATION

Consultation letters have been distributed to 36 properties within the immediate vicinity of the location providing notification of the proposed changes. The responses are noted in Attachment 2 – Table of Consultation.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the:

- A. Installation of two (2) sections of No Parking restrictions on the east side of the street:
- Starting 6 metres north from the driveway of No.36 Beatrice Street to 4 metres south from the driveway of No.34 / No.32 Beatrice Street, Clontarf.
- Starting 4 metres north from the driveway of No.30 to 2 metres south from the driveway of No.24 Beatrice Street, Clontarf.





REPORT

BACKGROUND

Council has received concerns from residents regarding vehicles parking close to the intersection of Hilma Street and Plateau Road, Collaroy Plateau. Concerns have also been raised regarding vehicles cutting corners and creating hazardous situations for other road users. The narrowness of Hilma Street contributes to the level of risk.

LOCATION

- Hilma Street and Plateau Road are local roads with a speed limit of 50km/h.
- The average width of Hilma Street is 7m and Plateau Road is 10m.
- The intersection between Hilma Street and Plateau Road is regulated by 'T' intersection Rules.
- Unlimited parking facilities are available on both sides of the roads.
- Plateau Road is a Bus route.

ISSUES

- Road users often park close to the intersection and visibility is compromised.
- Vehicles cutting corners and creating hazardous situations for other motorists.
- The intersection has no traffic control measures other than the standard 'T' intersection rules.
- The narrowness of Hilma Street increases the level of risk.
- Accident records reveal no accidents have occurred in the last five (5) years.

PROPOSAL

Council has investigated the issue and proposes to introduce a 20m length of 'Dividing Barrier Lines (BB)' on Hilma Street and a 30m length of 'Dividing Separation Line (S1)' on Plateau Road, north of Hilma Street. These changes will assist in keeping traffic on the correct side of the road on the approach to the intersection and will also mean that cars cannot park on either side of Hilma Street for a distance of 20m east of Plateau Road.

The Proposal is shown in Attachment:1 and includes the following:

- Installing 20m 'Dividing Barrier Lines (BB)' on Hilma Street at the intersection of Hilma Street and Plateau Road.
- Installing 30m 'Dividing Separation Lines (S1)' on Plateau Road north of Hilma Street.

PEDESTRIAN AND CYCLING IMPACT STATEMENT

This proposal will have the following impact(s) on pedestrians and people cycling:

- The proposal will have no impact on people cycling and does not affect any future planned facilities.
- The proposal does not affect the pedestrian facilities or impacts on walking paths.

Consultation letters have been distributed to 33 properties within the immediate vicinity of the location providing notification of the proposed changes.

- B. Installation of 30m 'Dividing Separation Lines (S1)' on Plateau Road north of Hilma Street.





Issue	Resident Comment	Council Response		
Parking Loss	Parking is in high demand and the removal of parking facilities is not acceptable.	'Dividing Separation line (S1)' does not impact parking facilities. A statutory 'No Stopping' distance of 10m is applicable at intersections. Therefore, out of the 20m double barrier line effectively 10m BB line only additionally restrict parking which can be compromised compared to the safety improvement. Further, Residents or Businesses do not rely on on-street parking.		
Boat and Trailer Parking	Occupy valuable parking spaces and create risks on narrow streets.	As everyone has equal rights on a public road, any registered vehicle can be used in the on-street parking facilities. Council has great difficulty in removing these vehicles under existing legislation. Legislative changes are required at the State level to effectively manage the issue.		
Speeding	Speeding is an issue and traffic calming measures are required.	Council's latest counts show that 85% of vehicles travel within the speed limit. Therefore, speeding is not an issue. Also, Accident Records reveal that no accidents have occurred in the last five (5) years at this intersection. Further, traffic- calming devices are not favoured on Bus Routes. So traffic calming devices are not required at this stage.		
Delineation	Does not improve safety or speeding issues.	Delineation will assist in keeping traffic on the correct side of the road on the approach to the intersection and will also restrict the travel lane width, hence traffic will be regulated and speed will be reduced. Dividing barrier lines on narrow street restrict parking and visibility will be improved. Therefore, safety will be enhanced, noting that Council continuously monitors and takes necessary action.

REPORT

BACKGROUND

Council has been asked by the NSW Police to implement road closures in Manly and Dee Why on New Year's Eve, to assist with crowd control and ensure the safety of spectators coming to watch the annual fireworks displays at 9pm at Manly and Dee Why. The road closures will be in similar locations to those introduced last year, with Special Event Clearways also established to assist with security and to disperse the crowds.

ISSUES

Road closures in Manly will be implemented between the hours of 5:00pm and 10:30pm on Sunday 31 December 2022. Road closures will be in place at the following locations:

- East/West Esplanade between Commonwealth Parade and Ashburner Street.
- Belgrave Street between Sydney Road & Gilbert Street (closed to all traffic other than Taxis who will be permitted to enter from Sydney Road).
- West Promenade.
- Wentworth Street between Darley Road and East Esplanade (closed to all traffic except drivers living in the closed section of Wentworth Street).
- Victoria Parade between Darley Road and East Esplanade (closed to all traffic except drivers living in the closed section of Wentworth Street).
- All side streets accessing the closed sections of East & West Esplanade will also be blocked. Traffic Controllers and/or Police will be manning each road closure site.

In Dee Why, The Strand will be closed between Dee Why Parade and Oaks Avenue. Howard Avenue between Clyde Road and The Strand will also be closed to all except residents living in that section of Howard Avenue. A One-Way traffic flow system will also be in place along Dee Why Beach headland between Oaks Avenue and Pacific Parade (between 6:30pm and 8:50pm). Road closures in Dee Why will be in place between 4:00pm and 10:00pm on Sunday 31st December 2022.

The Police have requested Council's assistance in implementing the road closures and obtaining approval of a TMP regarding the closures. There will also be amendments to bus stops to facilitate transport to the events.

To assist in this respect and for security reasons, Special Event Clearways will be established on:

- Belgrave Street, Manly, east side between Raglan Street & Sydney Road.

- Belgrave Street, Manly, west side between Sydney Road and Gilbert Street.
- West Promenade, Manly both sides.
- East and West Esplanade, Manly both sides.
- The Strand, Dee Why, both sides.

Further information relating to the Special Event Clearways and road closures are detailed in the attached TMP.

Police, Council and officers from the Transport Management Centre (TMC) have been liaising regarding the arrangements for the event. Implementation of the Special Event Clearways and vehicle towing in regard to the clearway restrictions, will be managed by TMC.

Council's Events Team will be installing notices to alert motorists of the proposed closures in the week leading up to New Year's Eve, as well as notifying emergency services and other authorities, as well as arranging for notification of residents and businesses in both Dee Why and Manly.

Further details on the event are included in the attached TMP. Also attached are the traffic control plans that affect the road closures of East/West Esplanade, Belgrave Street and The Strand for these events. The Traffic Management Plan as well as the Traffic Control Plans are similar to last year's event, which was conducted successfully.

PEDESTRIAN AND CYCLING IMPACT STATEMENT

This proposal will have the following impact(s) on pedestrians and people cycling:

- The proposal will have no impact on people cycling and does not affect any future planned facilities
- The proposal will facilitate safety for the large crowds of pedestrians expected to visit Manly and Dee Why for the fireworks

CONSULTATION

Notification letters have been distributed to properties within the immediate vicinity of the area impacted by the road closures. The events and associated traffic controls will be publicised in local media, on Council's website and social media platforms.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Local Traffic Committee recommends the closure of roads in Manly & Dee Why as detailed in the submitted Traffic Control Plans and Traffic Management Plan (TMP) for New Year's Eve celebrations in 2022 noting that:

- A. Council's Events Team will forward the TMP to the Transport Management Centre of TfNSW for approval.
- B. the Local Traffic Committee supports the road closures related to the event for the next five (5) years and that the item is not to be re-submitted to the Local Traffic Committee during this period unless there are significant changes to the traffic management arrangements for the event.

TRAFFIC MANAGEMENT PLAN

This document provides a Traffic Management Plan (TMP) for the proposal to temporarily close roads within Manly CBD for New Year's Eve (NYE) celebrations.

In the hours prior to the 9pm fireworks display, significant crowds gather along Manly Cove foreshore to secure a vantage point. Following the fireworks display in Manly at 9pm, a large exodus of people leave the area.

East and West Esplanade are therefore closed to traffic and parking between Ashburner Street and Commonwealth Parade to allow the safe assembly of crowds in the narrow harbour side reserves; the safe movement of emergency and event-related vehicles along the roadway during the event and the safe and efficient departure of people from the foreshore area.

Some roads leading to and around East and West Esplanade are also closed and/or have diversions/restrictions in place to facilitate the road closures as well as assist with the storage and movement of buses to disperse the crowds after the event.

A. DESCRIPTION OF PLAN

The Manly New Year's Eve fireworks are an annual event and will be held on Saturday 31 December 2022. The fireworks display occurs at 9pm from a barge in Manly Cove and is approximately 10 to 12 minutes in duration. Approximately 10,000 - 15,000 people are expected to attend the event.

As a result of large groups of people attending the event, temporary road closures will be put in place in Manly CBD.

While there is currently no intelligence indicating a direct threat, recent national and international incidents of vehicle-borne attacks targeting innocent people in mass gatherings have placed the NSW Police Force on 'high alert' for similar activities at major public events. In order to minimise this threat, Police have directed that road blocks be in place if vehicles attempt to drive into crowds of people enjoying the fireworks display. These road blocks (buses) will be placed across selected intersections to block any vehicular traffic from 5.00pm - 10.30pm on Saturday 31 December 2022.

NOTE: THERE WILL BE NO RESIDENT, BUSINESS OR TAXI VEHICLE MOVEMENTS PERMITTED ALONG THE CLOSED SECTIONS OF WEST PROMENADE, BELGRAVE STREET, EAST AND WEST ESPLANADE DURING THE ROAD CLOSURE PERIODS. ONLY EMERGENCY AND EVENT-RELATED VEHICLES WILL BE PERMITTED AT THESE TIMES.

The following traffic points are listed below to indicate the road closure and/or road block:

• Manly – Traffic Points

Ashburner Street and East Esplanade

Two standard buses and barricades to be positioned across East Esplanade at Ashburner Street. Positioned so as to stop any north-bound traffic travelling along East Esplanade past Ashburner Street and stop any traffic travelling west along Ashburner Street turning north into East Esplanade. C. MEASURES TO AMELIORATE THE IMPACT OF RE- ASSIGNED TRAFFIC

Council will be promoting the event through local media, on its website and social media. A letterbox drop to residents and businesses in the area of the road closures has been conducted. Promotional materials will be encouraging visitors to use public transport, carpool or walk/cycle to the event. In addition, Keolis Downer will be providing extra bus services between Dee Why and Manly and between Neutral Bay and Manly to cater for anticipated increased passenger numbers.

VMS boards will be used to inform motorists beforehand and during the closures. One VMS board will be placed on Sydney Road (north side) approximately 30m west of Belgrave Street for east bound road users. 



TRAFFIC MANAGEMENT PLAN

This document provides a Traffic Management Plan (TMP) for the proposal to temporarily close The Strand at Dee Why for New Year's Eve (NYE) celebrations.

In the hours prior to the 9pm fireworks display, significant crowds gather across Dee Why Beach to secure a vantage point. Following the fireworks display at Dee Why Beach at 9pm, a large exodus of people leave the area.

The Strand is therefore closed for parking and traffic between Dee Why Parade and Oaks Avenue to allow the safe assembly of crowds in the beachside reserves; the safe movement of emergency and event-related vehicles along the roadway during the event and the safe and efficient departure of people from the beachside area.

Some roads leading to and around The Strand have diversions/restrictions in place to facilitate the road closure.

In addition to the road closure, a one-way traffic system will be put in place along Dee Why Beach Headland between Oaks Avenue and Pacific Parade to manage traffic flow in this popular fireworks viewing location from 6.30pm – 8.50pm. This area will be managed by Traffic Controllers and no vehicles are allowed to enter between 8.50pm until 9.30pm (or once the fireworks display has concluded).

The TMP has been prepared in accordance with the Roads and Maritime Services (RMS) guideline for *Preparation of a TMP* (2001).

A. DESCRIPTION OF PLAN

The Dee Why New Year's Eve fireworks are an annual event and will be held on Saturday 31 December. The fireworks display occurs at 9pm from a barge off Dee Why Beach and is approximately 10 minutes in duration. Approximately 10,000 – 15,000 people are expected to attend the event.

As a result of large groups of people attending the event, a temporary road closure will be put in place at Dee Why Beach.

While there is currently no intelligence indicating a direct threat, recent national and international incidents of vehicle-borne attacks targeting innocent people in mass gatherings have placed the NSW Police Force on 'high alert' for similar activities at major public events. In order to minimise this threat, Police have directed that road blocks be in place if vehicles attempt to drive into crowds of people enjoying the fireworks display. These road blocks (vehicles) will be placed across selected intersections to block any vehicular traffic from 4pm - 10pm on Saturday 31 December 2021.

NOTE: THERE WILL BE NO RESIDENT, BUSINESS OR TAXI VEHICLE MOVEMENTS PERMITTED ALONG THE CLOSED SECTION OF THE STRAND DURING THE ROAD CLOSURE PERIOD. ONLY EMERGENCY AND EVENT-RELATED VEHICLES WILL BE PERMITTED AT THESE TIMES.

Howard Avenue and The Strand

Barricades and barriers to be positioned across Howard Avenue at The Strand (west side next to pedestrian crossing) to stop any eastbound vehicle access into The Strand. Two Police and Traffic Controllers in position to ensure compliance.

Howard Avenue and Clyde Road





REPORT

BACKGROUND

Council has received ongoing concerns from local residents regarding long term parking of campervans, box and boat trailers in Holmes Avenue and Monash Crescent, Clontarf.

Council's Traffic Committee approved the introduction applying 7am - 7pm Everyday with 90degree angle parking and Front to Kerb Only restrictions on the northern side of Holmes Avenue between Amiens Road and Monash Crescent and on the western side of Monash Crescent between Holmes Avenue and No.31 Monash Crescent, Clontarf.

The above proposal was installed on 22 September 2022, as a result, some trailers have moved to the southern (residential) side of Holmes Avenue affecting sightlines and parking opportunities for residents and visitors.

LOCATION

- Holmes Avenue and Monash Crescent, Clontarf are two-lane roads with a posted speed limit of 50km/h. Holmes Avenue is in an east/west direction between Amiens Road and Monash Crescent, Clontarf. Monash Crescent is in a north/south direction between Holmes Avenue and the cul-de-sac at the end of Monash Crescent, Clontarf.
- On-street parking is generally unrestricted on Holmes Avenue and Monash Crescent; however, No Parking restrictions are located on the western side of Monash Crescent which merges into No Stopping through to the cul-de-sac.
- Adjacent land use consists of low to medium density housing and Clontarf Reserve.
- Monash Crescent Track is part of the Spit Bridge to Manly Walk.
- A monument and pine tree are located at the intersection of Holmes Avenue and Monash Crescent, Clontarf.

ISSUES

- Boat trailers, trailers and campervans are parked long term affecting available parking for residents and visitors.
- The parking of the trailers affects the visibility of pedestrians.
- The number of boat trailers in the area is an eyesore.

- Install No Parking (Motor Vehicles Excepted on the Eastern Side of Monash Cresent from the Existing 'NO STOPPING' UNBROKEN YELLOW LINE to 1m from the northern side side of the driveway of No. 38 Monash Cresent.
- iii. Extend the Existing 'NO STOPPING' UNBROKEN YELLOW LINE at the intersection of Amiens Road to the eastern side of the driveway of No. 1 Holmes Avenue.

REPORT

BACKGROUND

Council has received concerns from local residents regarding an increased proliferation of boats, trailers and caravans parking along a section of Edgecliffe Boulevard, Collaroy Plateau. Concerns were expressed regarding the boats and trailers lowering the general appearance of the area and restricting parking opportunities for local residents and visitors.

LOCATION

- Section of the road under consideration lies between Telopea Street and Hilma Street, Collaroy Plateau.
- The section of Edgecliffe Boulevard, is a local road with a 50km/h speed limit.
- Between Telopea Street and Hilma Street, Edgecliffe Boulevard has a measured carriageway width is 9.9-metres and caters for two-way traffic.
- Parking is generally unrestricted on both sides of Edgecliffe Boulevard, except near the intersection with Telopea Street and Hilma Street.
- A constructed 2-metre footpath is located along the eastern side of the road only.
- The land use of the surrounding area is predominantly low-density residential housing.
- There are no bus services that operate on this section of Edgecliffe Boulevard.

ISSUES

- Historically, it can be observed that predominantly boats, trailers and non-motorised vehicles are consistently parking on Edgecliffe Boulevard.
- Parking for residents, visitors and those seeking parking for uses associated reserve and nearby walks are limited due to the number of non-motorised vehicles on the section of the road.
- It can be observed that eleven (11) boats, trailers and caravans found to be occupying a significant proportion of the available kerb space on Edgecliffe Boulevard, between Telopea Street and Hilma Street.

- Residents have reported that the boats, trailers and non-motorised vehicles are restricting through access for larger vehicles and interfering with property access.
- Many non-motorised vehicle owners could potentially relocate these trailers to other areas such as nearby reserves, industrial and residential areas.

PROPOSAL

Council has undertaken a review of the location and proposes to install 'No Parking Motor Vehicles Excepted' signs along the northern side of Edgecliffe Boulevard, Collaroy Plateau, between Telopea Street and Hilma Street.

The proposal will effectively restrict the on-street parking of non-motorised vehicles, such as trailers, boats and caravans on the section of the road. The proposal will facilitate parking availabilities for residents and visitors attending or living in the area.

PEDESTRIAN AND CYCLIST IMPACT STATEMENT

This proposal will have the following impact(s) on pedestrians and people cycling:

- Edgecliffe Boulevard, is not part of the Road or Safe Cycling Network.
- The proposal will have no impact on people cycling and does not affect any future planned facilities.
- The proposal does not affect pedestrian facilities or impact on walking paths.

CONSULTATION

- Consultation letters have been distributed to 28 properties within the immediate vicinity of the location providing notification of the proposed changes. The responses are noted in Attachment 2 – Table of Consultation.
- A total of 22 submissions were received with 16 letters of support and 6 objections to the proposal. The main objection raised was in relation to the loss of on-street parking for boats and trailers and to allow boats and trailers to park on Edgecliffe Boulevard. Minimum road widths are maintained as width of all parked vehicles (including any trailers) do not exceed the regulated 2.5-metres.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the:

A. Installation of 'No Parking Motor Vehicles Excepted' on both kerb sides of Edgecliffe Boulevard, Collaroy Plateau, between Telopea Street and Hilma Street.



REPORT

BACKGROUND

At the November meeting of the LocalTraffic Committee, the representative from Keolis Downer Northern beaches raised a concern about the location of the Electric Vehicle Charging Station on Dowling Street, Freshwater near its intersection with Lawrence Street. When a vehicle was parked at the charging station, buses were unable to pass without crossing the centrelines.

Council's Transport Network Manager undertook to have the matter investigated and reported back to the Traffic Committee

LOCATION

Dowling Street is a local road of approximately 11m in width and is well used by local traffic as a link between the Freshwater Village and the Freshwater and Queenscliff residential areas. The 167 bus route which passes between Warringah Mall and Manly via Curl Curl & Freshwater, proceeds in both directions along Dowling Street on a 20 minute frequency.

ISSUES

- In early 2022, Council introduced an Electric Vehicle Charging Station on the east side of Dowling Street. This was achieved by converting an existing 1P parking space to a "No Parking Electric Vehicles Excepted Only When Charging Limit 1 hour". The selected location was adjacent to an existing electricity sub-station which was converted to allow for the charging of vehicles.
- There is a high and increasing demand for publicly accessible electric vehicle charging points and Council is therefore, reluctant to remove the charging station.
- If poorly parked at the Electric Vehicle Charging Station, a vehicle can be within 3m of the centreline,s leaving insufficient room for traffic and particularly buses to safely and legally pass.
- The space occupied by the Electric Vehicle Charging Station was always a parking space, however, the green pavement to denote the Electric Vehicle Charging Station extends some 2.7m-2.8m from the kerb alignment gutter, which may have the unintended consequence of resulting in vehicles parking further from the kerb than they previously did.

PROPOSAL

Council has undertaken a review of the location and issues and proposes to shift the centreline in a westerly direction to provide additional road space for a bus to turn from Lawrence Street left into Dowling Street. A southbound travel lane of 3.7m will be created leaving a 4.6m northbound travel lane on approach to Lawrence.


