4.0 MAYORAL MINUTES

4.1 MAYORAL MINUTE 1/2016 PROPOSAL UNDER LOCAL GOVERNMENT ACT 1993

BACKGROUND

It is certainly clear that there is little to no support for the proposals being put forward by the State Government to split Warringah and the Northern Beaches.

Last night I attended a community meeting of at least 600 passionate local residents. Residents who believe the government is not hearing their concerns under the current local government reform process. The response from the public has been overwhelming and this meeting was no

different. In fact, the strength of response from the public meant that we had to hold another meeting in the car park, as the RSL was overflowing with people who were turned away as the room was full to capacity.

This is in addition to the 400 plus community members who braved storms to speak out at another meeting in Curl Curl earlier this month. They spoke strongly about how they felt the process did not reflect their community's view. I would also like to be clear and on record to say these meetings were all organised by the community for the community. Our community is being united, by the very proposal to divide us. We are One Northern Beaches.

At the meeting the community resolved to:

- Reject the NSW Government's current proposal of splitting Warringah and having two Councils (Greater Pittwater / Greater Manly)
- Support One Northern Beaches Council covering Pittwater, Warringah and Manly (and not including Mosman).

The message was also loud at the public hearings in Mona Vale and Manly. At those meetings I requested that the hearings also be held in Warringah to give our residents an equal voice in the reform process. Residents expressed concern they are being disadvantaged in the debate and their AR Bluett Award winning council area is being split into two pieces. At this point, I am not aware that there is to be any further hearings scheduled.

The community has spoken out and want the NSW Government to listen.

As we draw closer to the deadline for submissions to the Council Boundary Review, I have become aware of an option under the Local Government Act 1993 for Warringah Council to initiate a proposal directly to the Minister for our preferred option being One Northern Beaches Council.

I have been approached now by a number of residents in relation to Section 218E of the Local Government Act 1993 which states:-

218E Who may initiate a proposal?

- (1) A proposal may be made by the Minister or it may be made to the Minister by a council affected by the proposal or by an appropriate minimum number of electors.
- (2) An appropriate minimum number of electors is:
- (a) if a proposal applies to the whole of one or more areas, 250 of the enrolled electors for each area or 10 per cent of them, whichever is the greater, or
- (b) if a proposal applies to part only of an area, 250 of the enrolled electors for that part or 10 per cent of them, whichever is the lesser.

Essentially Warringah is able to initiate its own proposal directly to the Minister for Local Government and I would suggest that this would be based on the submission Council prepared in June 2015 and submitted to the Independent Pricing and Regulatory Tribunal (IPART) in accordance with the Independent Local Government Review Panels (ILGRP) recommendation for One Northern Beaches Council. It would then require the Minister to refer the proposal directly to the Office of Local Government or the Boundaries Commission for consideration separate to the current Boundary Review process.

This will allow Council on behalf of the community to have a further say under a different process.

I am advised that funding to prepare this proposal is nominal and available within current operational budgets.
