REPORT

PURPOSE

To suspend an Alcohol Free Zone within the Manly CBD from 1 to 3 October 2016 during Manly Jazz to allow a licensed 'wine garden' on The Corso.

BACKGROUND

Manly Jazz, now in its 39th year, will be presented in the Manly CBD with free outdoor stages positioned at the Manly beachfront, along The Corso and in Sydney Road. A road closure along North/South Steyne from Raglan Street to Wentworth Street will be in place.

The pop-up 'wine garden' at Manly Jazz was first trialled in 2014 with great success. The wine garden was again successfully run in 2015 by a local business. The 'wine garden' will occupy a space approximately 14m x 40m on Manly Corso near the intersection with Sydney Road pedestrian area.

The 'wine garden' is proposed to sell wine, boutique beer, cider and non-alcoholic products. It would operate under a liquor licence from 11.00 a.m. to 8.00 p.m. daily through the festival.

The location of the 'wine garden' on The Corso is situated within the current Alcohol Free Zone and as such, people who consume alcohol in this area would be committing an offence.

Under the provisions of section 645(1) of the Local Government Act 1993, Council "may, at the request of any person or body or of its own motion, suspend the operation of an alcohol-free zone by publishing notice of the suspension in a newspaper circulating in the area as a whole or in a part of the area that includes the zone concerned".

Council has worked and continues to work closely and successfully with Northern Beaches Police to ensure the safe operation of the area during these events. The suspension of the zone in the past has not posed any problems for Police or Council.
