



Companion Animal Management

For the quarterly period of October – December 2022, 84 dog attacks were reported to Council, with 29 attacks occurring on public land and 7 attacks on private land. 15 attacks were on other dogs and 33 attacks on people. Each of these incidents are subject to an investigation.




Over the same period, 11 infringements were issued in relation to dog attack matters, and one menacing dog declaration was made. 20 investigations were finalised, and 18 matters are currently under investigation.





The main dog breeds found to be involved in attacks are as follows:



Proactive actions

In response to community feedback regarding the management of dogs in public spaces, the Ranger team commenced a proactive campaign from Saturday 26 November until Friday 6 January 2023, focusing on peak use times (6am – 10am and 4pm – 8pm) and throughout the day over weekends. The program focused on patrols of key areas during weekday peak time (6am – 10am and 4pm – 8pm) and all day on weekends.

To date, Rangers have engaged with 384 dog owners to provide advice and education and taken enforcement action where breaches were observed, with 22 penalty notices and 31 formal cautions were also being issued. The Ranger presence will continue, with a focus on engagement and education, and enforcement action will also be taken where necessary.

Council's website has also recently been updated to provide additional helpful information to dog and cat owners in relation to their companion animals.

Alcohol Prohibited Areas - Manly

The Rangers continue patrols of the alcohol prohibited areas around Manly, with the instances of remedial actions increasing in December for this quarterly period.

Real estate signs

A further mail-out to estate agents is being undertaken to reiterate the planning requirements for exempt signage. A recent audit of signs has found the majority compliant, although a few agencies require further prompting.

Patrols of school zones

Patrols on school zones were carried out over the last school term and will continue this year. Parking officers actively patrolled the following schools, Narrabeen Lakes, Manly Village, Balgowlah Heights, Avalon, North Narrabeen and Dee Why.

Arbovirus surveillance program

The Environmental Health team's arbovirus surveillance program for the 2022 season is reaching its halfway point. To date, traps have had predominantly low mosquito numbers for the season with no arbovirus detections. Low numbers of mosquitoes and no detections during this part of the year is not unusual as typically we do not receive detections until the end of the season.

Climatic conditions have resulted in above average rainfall in the Murry darling basin which has resulted in a large number of migratory birds remaining in the area, which has consequentially reduced the numbers of amplifying hosts.

Murry Valley Encephalitis was detected in regional areas at Menindee and Griffith. NSW Health have provided a media toolkit to assist with community messaging should any detections be encountered.

ISSUE

To update the Community Safety Advisory Committee on the Manly Place Plan and seek input on community safety related impacts.

BACKGROUND

This matter aligns with the following Community Safety Plan actions:

- Consult with the NSW 24 Hour Economy Commissioner to develop night time economy strategies to activate vibrant, inclusive and safe open spaces. (Priority Area: Safe Open Spaces)
- Ensure that night activation strategies and events that attract tourism are conducted safely. (Priority Area: Safe Visitors)

Place planning is a strategic approach to planning, designing, and managing physical infrastructure and services. A Place Plan establishes a vision for an area as it grows incrementally over time, in line with the needs of our community. The Manly Place Plan aims to deliver a place-based strategy to address the current and future needs of the Manly strategic centre. A key element of this Plan is the night-time economy of Manly and its designation as the only designated late night entertainment precinct in the Northern Beaches.

At its meeting of 18 November 2021, the former Community Safety Committee was informed of the Manly Place Plan including the preparation of a Night-Time Economy Study for Manly (the NTE Study). A copy of the report to the former Committee is included (Attachment 1). Consultants engaged by Council consulted with relevant Crime Prevention Officers (NSW Police Force – Northern Beaches Police Area Command) and Council's Community Safety Coordinator, in preparing the NTE Study.

DISCUSSION

Since that time, the NTE Study has been completed and provides key recommendations that has informed the Manly Place Plan, including to:

- Diversify night-time economy activities in specific locations including designation of nighttime economy clusters
- Support businesses in the night-time economy
- Encourage live music and performing arts
- Facilitate a safe and vibrant environment
- Ensure public needs are complementary to night-time economy activations
- Introduce acoustic controls including requirements for new sensitive receivers such as new residential development.

Central to the night-time economy strategy is implementing the 'agent of change' principle as an approach responding to:

- Alcohol related violence
- Antisocial behaviour
- Tension between competing land uses.

The intention is for all users (business operator, residents and visitors) to be aware that the nature of night-time economy venues and events may affect their future and ongoing use and enjoyment of land due to operating hours, noise and other measures of these venues and events.

Additionally, one of the key changes to The Corso is creating opportunities for people to 'dwell' in this main feature of the Manly Town Centre. This is a change from The Corso being seen as just a thoroughfare and vista from cove to beachfront.

The NTE Study includes the strategy recommendations for Manly and its night-time economy (the 'NTE Strategy') and is a reference document for the draft My Place: Manly. Specific feedback on the NTE Strategy is not being sought at this time.

These recommendations and principles have all informed the development of the draft My Place: Manly which will be reported to Council in first half of 2023, before being placed on public exhibition. A key activity of the public exhibition phase is consulting with a range of stakeholders. The NSW Police Force will be consulted on key matters that could affect the success of the Plan, such as liquor licensing, night-time economy activities, alcohol related crime and antisocial behaviour.

Input is being sought from Committee members regarding the following:

- the impact of the Manly Place Plan on community safety, including alcohol related crime and antisocial behaviour
- opportunities to facilitate a safe environment for the community and businesses
- balancing public safety needs and night-time economy activations
- the diversification of night-time economy activities and designation of night-time economy clusters.

Members of the Community Safety Advisory Committee may also wish to provide comments when the draft My Place: Manly is on public exhibition.

- A. Note the update on the Manly Place Plan and the opportunity to provide feedback on the draft Plan when it is on public exhibition.
- B. Consider community safety related impacts of the Manly Place Plan.

ISSUE

To inform the Community Safety Committee of the Manly Place Plan Project and the Night Time Economy Project.

BACKGROUND

Place Planning

Northern Beaches Council is working to create great places that are vibrant, safe, inclusive and sustainable right across the Northern Beaches. We actively undertake place-based planning approaches throughout the Northern Beaches to support the planning, design and management of local town centres.

Place planning is a strategic approach to planning, designing, and managing the physical infrastructure and services around us. A Place Plan establishes a vision for the area and helps allow our places to grow incrementally over time, in line with the needs of our community.

Council's place planning framework focuses on working with the community to develop plans for our places grounded in our residents' connection to local villages and neighbourhoods.

Manly Place Plan Project

The Manly Place Plan project formally commenced on 1 July 2021. The objective of this Plan is to deliver a place-based, tactical oriented strategy to address the current and future needs of the Manly Strategic Centre.

The study area for the Manly Place Plan is shown at Attachment 1.

Place planning will involve:

- extensive community engagement activities to canvas the current values and concerns
 of the community and identify what that they believe Manly should be like in the future,
 from social, natural, environment, economic and cultural perspectives
- developing an evidence based framework to enhance the physical and social aspects this 'place'
- incorporating all the feedback obtained for other projects, for example the recently exhibited Plan of Management and Masterplan for Ivanhoe Park
- incorporating Council's strategic documents such as the Move Strategy and Action Plans, the LSPS and associated technical studies

- seeking further community opinion on practical ways for the Place Plan to be implemented
- working with the community to address the current and future needs of the Manly strategic centre.

Place Plans sit within a broader strategic planning framework that includes the Greater Sydney Region Plan, North District Plan, Council's Local Strategic Planning Statement Towards 2040 and other local policies such as local environmental plans and development control plans.

The Place Plan centres on public domain improvements and programs that aim to support and build capacity within the local community.

Priority 26 of Council's <u>Local Strategic Planning Statement</u>, <u>Towards 2040</u> (Attachment 2), Action 26.3 states the intention to:

Prepare a place plan for Manly and develop LEP and DCP controls to respond to LEP studies, thematic history study, West Esplanade heritage activation plan, destination management plan and night-time economy to balance competing plans.

Places for People is also a key Community Outcome of Council's Community Strategic Plan, Shape 2028.

Manly Night Time Economy Project

The Manly Night Time Economy (NTE) project will provide important input to the Manly Place Plan project.

Priority 30 of the <u>Local Strategic Planning Statement</u> (Attachment 3), Action 30.3 identifies the need to diversify the Night Time Economy:

Prepare place plans, precinct plans and activation plans that support social practical and functional activities in the evening and night-time, including:

• Manly place plan to respond to alcohol-related violence, anti-social behaviour and tension between competing land uses.

Local government can influence the Night Time Economy though:

- · Planning controls
- Regulation and compliance
- · Funding or delivering events
- · Availability and quality of public space
- Providing cultural and recreational venues community centres, libraries, pools, art galleries, theatres
- · Marketing and promotion
- · Advocating, collaborating and partnerships.

Crime and antisocial behaviour impact negatively on the experience of participants in the Night Time Economy. A safe night time environment attracts a greater diversity of participants and supports an enjoyable experience.

The Night Time Economy project will canvass a range of issues which relate to community safety including:

- · Night time trading
- · Licensed premises
- · Outdoor alcohol restrictions (i.e. Alcohol Free Zones and Alcohol Prohibited Areas)
- · Transport and access
- · Crime mapping
- Events

Consultants

A consultant Masterplanner, Ethos Urban, has been engaged to prepare the Manly Place Plan. HillPDA Consulting has been engaged to undertake a Night-Time Economy Study of the Manly Strategic Centre. Targeted stakeholder engagements are a key element for both consultants.

The scope of works for the Masterplanner and Night-Time Economy Study are summarised in Attachment 4. This includes consideration of:

- Alcohol-related crime and anti-social behaviour issues occurring in the Manly Strategic Centre
- · Night-time economy activities
- Community safety and crime prevention through the future design of spaces in the Manly Strategic Centre.

ISSUE

To brief the Community Safety Advisory Committee on the outcomes of the Forestville Library 24/7 trial and seek input on potential or perceived community safety issues relating to the scoping and potential implementation of 24/7 libraries at further locations.

BACKGROUND

This matter aligns with the following Community Safety Plan action:

 Ensure community facilities are accessible, flexible and functional shared spaces for the community. (Priority Area: Safe Neighbourhoods)

In response to growing feedback from the community about opening hours, access and use of library spaces, Library Services reviewed and explored opportunities for the provision of unstaffed access to spaces and services. In 2020, Forestville Library was selected to pilot unstaffed 24/7 public access.

Following two years of research, development and refurbishments, in August 2022 Forestville Library became one of the first public libraries in Australia to trial 24/7 access for library members. Forestville Library continues to provide a full range of services and remains staffed during standard business hours but provides access outside of standard opening hours, with self-service check-outs and kiosks installed.

Library members must be 16 years and over and attend an onsite induction prior to accessing 24/7 services. Afterhours access to the Forestville Library can only be gained through a secure door, by scanning a valid library card and entering a PIN number with added security measures once inside including CCTV, hold-alarms and a refurbished space to provide clear lines of sight for all community members.

Over the trial period of 13 weeks, 655 community members registered for 24/7 access, visiting the library over 7,500 times representing 21.5% of overall visitation during the period. Of those who visited, more than 52% utilized the library outside of standard hours on more than three occasions.

Membership increased by 11% with 56% being adults under 30 years as evidenced by a significant increase in visitation during the October 2022 HSC period. Demand was highest during evenings, Sundays and on the Queens Memorial public holiday; a date on which other public library services were closed. During the trial period, Forestville Library experienced an average monthly visitation increase of 254% in comparison to previous years.

Providing a safe experience was one of the primary objectives of the trial and qualitative feedback was sought from participants in respect to feedback and perceptions of safety. Responses were overwhelmingly positive with the community self-policing to ensure good behavior by all library members. The community became a significant asset in ensuring the success of the trial with Forestville Library experiencing no vandalism, and only a few minor infractions of the terms and conditions of access. Surveys found that 95% of survey respondents felt 'very safe' or 'safe' using the library outside of staffed hours.

Impact statements from trial participants included;

"24-hour library is literally the best thing that happened to the Northern beaches since the B-line. I used to have to travel 1.5hrs to Macquarie Uni library to use a library after 8pm (when Dee Why library closed), now its 30 minutes which has improved my uni marks and really helped me managed my time."

- "Thank you for making this happen. And to include the ability to borrow books. This has redefined how easy it is for me and my child to borrow books from the library. Now we can borrow books on our way home on the weekend, without having to rush there within a small-is range of opening hours. It also means we can visit when car parking is much easier. Thanks again for the initiative. This is easily the best council initiatives that makes a positive impact to me in recent years (last one being the combined beach parking sticker for the entire northern beaches)."

DISCUSSION

Following the success of the Forestville 24/7 trial, a full launch is planned for 16 March 2023 establishing 24/7 access as a standard service offering moving forwards.

The positive impact of the trial has led to community expectation of expansion of the 24/7 concept at other branches. There is now considerable scope and mandate to explore opportunities at other Northern Beaches Council Libraries.

Input is being sought from Committee members regarding potential or perceived community safety issues relating to the scoping and potential implementation of 24/7 libraries at further locations.

RECOMMENDATION

That the Committee:

- A. Note the outcomes of the Forestville 24/7 trial.
- B. Consider community safety issues relating to the scoping and potential implementation of 24/7 libraries at further locations.

ISSUE

Update report on the progress and actions of the Northern Beaches Suicide Prevention Working Group.

BACKGROUND

At the 24 November 2022 meeting of the Community Safety Advisory Committee, it was requested that Council staff report on the progress and actions of the Northern Beaches Suicide Prevention Working Group as a standing Agenda item.

DISCUSSION

The Northern Beaches Suicide Prevention Working Group met on the 9 November 2022. Items discussed included Northern Sydney regional updates on the Regional Leadership Group, the Joint Regional Mental Health, Suicide Prevention, Drug & Alcohol Strategic Plan, the Northern Sydney Youth Suicide Prevention Plan, and the Northern Sydney Regional Suicide Communication Protocol (Attachment 1).

The new strategic direction of the Northern Beaches Suicide Prevention Working Group was also confirmed to reduce meetings to twice per year alongside these increased regional developments.

A regional service directory commissioned by Bright Agency called Headstart was shared: https://headstart.org.au/northern-sydney/.

The consumer facing mental health service directory features Northern Sydney PHN region programs and services. Anyone can submit service information via the website which will be moderated and if approved, added to the website: https://headstart.org.au/northern-sydney/local-service-submission/

The working group endorsed establishing a subgroup with proactive action to engage with older males. This subgroup met on 7 December 2022 to commence refining its scope and identified actions with the next subgroup meeting scheduled for February 2023.

The next Suicide Prevention Working Group meeting will be in April 2023.

ISSUE

This is a standing item on the agenda for the Community Safety Coordinator to provide an update.

BACKGROUND

1. Sexual Assault Prevention and Response Working Group

The Working Group was established and met on 14 November 2022. Priority areas for action were discussed, however, the Northern Sydney Sexual Assault Service (SAS) will attend the next Working Group meeting on 1 March 2023 to assist in determining priority actions. In the interim, a draft guide is being prepared with the intention of providing services with clear information on:

- 24/7 referral points for victims of sexual assault
- Reporting options for victims.

It is intended this guide will lead to a landing page on Council's internet with more information and links for services and victims.

2. Police and Council Operational meeting

A meeting was held on 1 December 2022 with the following key topics of discussion:

- East Esplanade Community Safety Management Plan
- Events to be held over the summer holiday period
- Proposed liquor licensing reforms which impact planning and protections for young people
- Actions taken following of Safety Audits and in response to graffiti, vandalism and antisocial behaviour at various locations including Village Park Mona Vale, Winnererremy Bay Mona Vale, Plateau Park Collaroy and Dee Why Lagoon. Noted general low level of activity at that time.
- Homelessness
- The draft Youth Voice Action Plan has been developed in consultation with stakeholders and the community and lays the framework for supporting young people in our community over the next 5 years. The draft Plan will be on public exhibition from 1 December 2022 to 28 February 2023.
- Safety on public transport (Community Safety Plan action)
- Retail theft (Community Safety Plan action).
