ISSUE

Council's Resilience and Emergency Management Coordinator will present a brief overview of natural hazards and shocks in the Northern Beaches and the emergency management frameworks in place to address them.

BACKGROUND

This item relates to the following Community Safety Plan action:

Prepare and strengthen our community and enable us to withstand, adapt and transform in the face of adversity (Priority Area 10: Safe Supports).

The Plan also states Council's intention to continue to:

Build the collective resilience of our community from a range of shocks and stressors that affect the Northern Beaches (Priority Area 6: Safe Residents).

There is a range of natural hazards and shocks that have the potential to impact Northern Beaches communities. Disasters including major flooding, landslides, storms, damaging winds, coastal inundation, and pandemic have all had material physical, economic, environment and psychosocial impacts across the LGA in recent years.

These rapid onset 'shocks' are increasingly being considered in conjunction with long term stressors. Council's Resilience Strategy 'Withstand. Adapt. Thrive.' provides a robust framework to better understand the relationship between short term shock events and long-term stressors, as well as identifying actions that Council and our communities can undertake to address them.

There are also several key plans and frameworks in place which outline emergency response and recovery arrangements for the Northern Beaches. Council has the capability to activate an Incident Management Team to ensure a coordinated approach to a range of emergency events. Council plays a critical role in supporting the Local Emergency Management Committee to ensure strong working relationships and the development of pre-event plans with various emergency service agencies.

Community safety is a primary focus of all resilience and emergency management activities. This presentation, and proceeding discussion, will look to identify and highlight common objectives and opportunities to enhance the resilience of Council and our community.

4 Current Alcohol Prohibited Areas

ISSUE

To consider the outcomes of a review into Alcohol Prohibited Areas (APAs) throughout the Northern Beaches Local Government Area (LGA) and the resulting proposal to establish three new 24 hour APAs and make the hours of restriction consistent for all APAs (except designated 24 hour APAs) to assist in managing alcohol related anti-social behaviour.

BACKGROUND

This proposal provides an update on the recommendation of the Community Safety Committee on 6 December 2018, and noted by Council on 26 February 2019 (Attachment 1), to:

Endorse that all Alcohol Prohibited Areas in the Northern Beaches be designated as 8pm-8am or 24 hours unless otherwise requested by Police.

This proposal also relates to:

- Council resolution 142/21 (Attachment 2):
 - ... staff report on establishing a 24 hour APA at Wingara Reserve, Belrose.
 - Consultation occur about establishing a 24 hour APA at Wingara Reserve.
- Council resolution 249/21 (Attachment 3):
 - Wingara Reserve to be considered as part of the broader review of APAs across the LGA, which will include community engagement.
- The Community Safety Plan action to:

Conduct a full review of alcohol restricted zoning. (Priority Area 1: Safe Open Spaces)

Section 632A(4) of the Local Government Act enables Councils to declare any public place or part of a place to be an Alcohol Prohibited Area, except those places (public roads, footpaths and car parks) which are to be dealt with under the Alcohol Free Zone provisions of the Act.

The intention of this action is to prohibit alcohol consumption in public places to reduce antisocial behaviour and crime. Public places or parts of places may be declared alcohol prohibited at all times, or only for specific days, times or events. For example, a Council may choose to make a park alcohol prohibited from dusk until dawn, or for the period 6pm on 31 December to 6am on 1 January each year.

Section 632A(8) of the Act provides that an Alcohol Prohibited Area cannot be established without the approval of the Police Area Commander in which the proposed Alcohol Prohibited Area is situated. Councils must seek and obtain this approval prior to establishing a new Alcohol Prohibited Area.



ITEM NO. 6.4 - 16 NOVEMBER 2023

Confiscation and 'tip out' powers apply to Alcohol Prohibited Areas. In circumstances where a person does not cooperate with a request by the Police or an authorised council enforcement officer to hand over alcohol in an Alcohol Prohibited Area they can be charged with obstruction under the Local Government Act 1993, which carries a maximum penalty of \$2,200.

Adequate signs must be erected by Council which make clear any time restrictions, and make clear that the consumption of alcohol is prohibited in that public place (section 632A(7) refers).

DISCUSSION

In response to the recommendation of the Community Safety Committee, the Community Safety Plan action and Council resolutions, a desktop review of Council's APAs has been undertaken and relevant sections of applicable Plans of Management were reviewed. Signs at many locations were inspected and an online sign audit tool created. Most beaches are signposted as 24 hour APAs.

It is noted that Council's existing APAs reflect the approaches of the former Councils, that is:

- Former Manly Council established 24 hour and other timed APAs in specific locations.
- Former Warringah Council established APAs in all parks and reserves from 10pm to 8am and 24 hour APAs in specific locations.
- Former Pittwater Council established timed APAs in specific locations.

Discussions were held with the Northern Beaches Police Area Command in relation to APAs generally and the locations at Village Park, Mona Vale, Howard Ave Reserve (colloquially known as St Davids Park, Dee Why) and Wingara Reserve, Belrose. It was determined that APAs provide NSW Police and Council's Rangers with a useful tool to help remove alcohol from public situations that could escalate to antisocial or violent behaviour.

NSW Police have reaffirmed that their intention is to use these powers with discretion and the purpose is not to use them to remove the use of alcohol from otherwise benign social gatherings of people.

A list of current APAs across the Northern Beaches is included at Attachment 4.

The findings of the review include that:

- APAs remain inconsistent across the LGA (including signage at some locations) and that information about APAs is not easily accessible, due to their inconsistency, for staff (for bookings, events and compliance) or NSW Police.
- Police have requested a 24 hour APA for Village Park, Mona Vale, a 24 hour APA for Howard Ave Reserve, Dee Why and a uniform approach to APAs across the Northern Beaches.
- NSW Police have endorsed the proposal to make Wingara Reserve, Belrose a 24 hour APA.

In response to the review it is proposed to present a report to the February 2024 Council meeting seeking approval to:

- Establish three new 24 hour Alcohol Prohibited Areas for Wingara Reserve at Belrose, Village Park at Mona Vale and Howard Avenue Reserve (also known as St Davids Avenue Park) at Dee Why.
- Establish all Council reserves and parks within the Northern Beaches LGA as Alcohol Prohibited Areas 8pm to 8am, except for 24 hour Alcohol Prohibited Areas.
- Confirm all Council beaches as 24 hour APAs.



ISSUE

Provide an update on the draft Championing Diversity - Multicultural Inclusion Plan 2029.

BACKGROUND

The Better Together 2040 Social Sustainability identified an action to develop a plan to support people from multicultural communities to feel safe, included and connected on the Northern beaches.

In response, the draft Championing Diversity - Multicultural Inclusion Plan 2029 (the draft Plan) has been developed with the community in 2023 to ensure that all people have a sense of belonging on the Northern Beaches.

When the Community Strategic Plan was reviewed and updated in late 2022, the community vision was amended to include the word diverse – *A safe, diverse, inclusive, and connected Northern Beaches that lives in balance with our extraordinary coastal and bushland environment.*

The draft Championing Diversity - Multicultural Inclusion Plan 2029 will contribute to achieving our community's vision for the Northern Beaches.

DISCUSSION

During an extensive consultation process, including over 500 community members, the multicultural community expressed a deep desire to participate and share their unique ways of thinking, doing, and sharing with others. Overall, the community wants everyone who lives in the community to feel that they belong.

The Northern Beaches has always been home to a diverse multicultural community and continues to be called home by both established and emerging multicultural communities. More than 30% of our community were born overseas and over 120 countries of ancestry are represented within the community.

The purpose of the draft Plan is:

To ensure the Northern Beaches is a place where those from multicultural communities feel welcome and can participate in community life.

Developed in consultation with the multicultural community and the broad community, the draft Plan will set the direction and prioritise action for the next 5 years, across two strategic directions that represent the two areas of greatest significance to the community.

Direction 1: Welcoming

The Northern Beaches celebrates diversity and cultural expression.

Direction 2: Participating

The Northern Beaches is a place where everyone feels safe, connected, and included in community life.

Baringa Reserve, Seaforth

Council is aware of ongoing issues of antisocial behaviour at Baringa Reserve (also known as The Grove) and is continuing to implement actions to address this situation including:

- Installation of signage with clear iconography that no fires are permitted
- Consultation with youth services
- Communication to nearby residents regarding recent high risk activity
- Removal of some vegetation that will improve sightlines into the reserve and remove very combustible vegetation that has died or dried if it is not native
- Youth Outreach services are attending
- Monitoring via Police Council Operational meetings will continue.

Sexual Assault Prevention and Response Working Group

The Working Group met on 26 October 2023 to finalise the development of a:

- Support Guide for local service providers and victims/survivors outlining referral pathways.
- New Council webpage with resources for victims/survivors of sexual assault, and services responding to disclosure of sexual assault.
- Discreet card to direct community members and service providers to the new webpage.

The Working Group also progressed arrangements for a Webinar in 2024 for service providers. The next meeting will be held on 1 February 2024.

Suicide Prevention Working Groups Update

The Northern Sydney Suicide Prevention Working Group met on 20 September to progress feedback towards endorsing a new Terms of Reference for improved Collaborative Governance. The Group also discussed challenges engaging diverse cultural communities and shared key resources including Partners in Wellbeing CALD Advisory Group Report and The Framework for Mental Health in Multicultural Australia.

The Northern Sydney Local Health District has commenced a new process for sharing suicide monitoring data (SuMS Data) with partner organisations with an identified need for access. Council has become a partner organisation.

The next meeting is scheduled for 15 November which includes the Northern Beaches Suicide Prevention Working Group.

The Northern Beaches male focused subgroup met on 20 September 2023 to finalise a resource on local men's groups and services that was promoted and distributed at the Men's Breakfast 'You'll be right, mate' run by Lifeline Northern Beaches on Wednesday, 11 October as part of


