#### 5.2.12 - Item 6.5

#### Oxford Falls Road/ Dreadnought Road, Oxford Falls – pedestrian safety improvements, should read:

Sally enquired whether it is possible to amend the Minutes to better reflect the status decided at the last meeting, which was that any study and work on the lower end (i.e. around Dreadnought Rd and Oxford Falls Grammar) would be done after the Wakehurst Parkway section was fixed, and work around the upper end (e.g. near Iris Street) would have studies done, due to be completed 31 March and put to community consultation shortly after this, as discussed.

Sally also requests for the upper end works to remain on the Agenda, but agreed for the lower end works to be taken off the Agenda from the next meeting, as currently the Minutes state her querying Section 5.12.23 6.5 which states Dreadnought Road (i.e. the lower end) - for this to stay on the Agenda, and agrees that this lower end can go off the Agenda from next meeting.

# 3.0 REPORTS TO PROCEED TO COUNCIL FOR APPROVAL

#### ITEM 4.11 – ISOBEL CLOSE, MONA VALE – No Parking

A Speaker – Mr Bob Pell was invited into the meeting to address the Traffic Committee meeting.

Mr Pell addressed his concerns regarding the proposal, noting that:

- He did not believe the "No parking" signs and zone was required
- The "No parking" zone would negatively impact street users
- Congestion and street access had never been a problem apart from one garbage truck driver

Mr Pell asked the committee not to support the proposal as presented.

Cr Jose Menano-Pires thanked Mr Pell for addressing his concerns to the Local Traffic Committee and advised him that the Traffic Committee will discuss the matter further and get back to him.

The Traffic Committee discussed this matter further (see Proceedings in Brief and the Recommendation to the Committee in Minute Item 4.11).

### 4.0 REPORTS FOR APPROVAL BY COUNCIL DELEGATION

# 4.1 CURL CURL WARD - CONSUL ROAD BROOKVALE - NO PARKING MOTOR VEHICLES EXCEPTED

#### PROCEEDINGS IN BRIEF

Phil Devon spoke to the matter of trailer parking occurs in this narrow road and residents are finding it difficult to park their cars.

The Traffic Committee agreed to support the Recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

1. Introduction of No Parking Motor Vehicles Excepted restriction in the indented parking space in front of No.2 Consul Road, Brookvale.

#### 4.2 CURL CURL WARD - HARBORD ROAD, FRESHWATER - EXTENSION OF NO STOPPING UNBROKEN YELLOW KERB LINE

#### PROCEEDINGS IN BRIEF

Adele Heasman requested that the wording "and Martin Street, restricting" be added in the "Issues" section of the Agenda report to read: "Parked vehicles in this location impede visibility for traffic

exiting Lawrence Street and Martin Street, restricting the road width for buses and the larger vehicles proceeding north on Harbord Road".

The Local Traffic Committee agreed to support the Recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

1. Extension of the 'No Stopping Unbroken Yellow Kerb Line' in front of No.44 Harbord Road, Freshwater by approximately 11m, terminating at the driveway to No.42 Harbord Road, Freshwater.

# 4.3 CURL CURL WARD - OLD PITTWATER ROAD, BROOKVALE - TIMED PARKING

#### **PROCEEDINGS IN BRIEF**

Phil Devon spoke to the matter of businesses finding it difficult for customers to park their cars along the road, as this area is a Business Park, with trailers and long-term parking of vehicles reducing turnover in this area. This area adjoins an area where time restrictions have been in place for some time. Previously this area was affected by trailer parking, and this does not relate to other changes in the precinct.

The Local Traffic Committee agreed to support the Recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

A. Installation of a Two Hour (2P) 6am-6pm MON-FRI timed parking restriction to begin on the southern side outside of the northern driveway at No.98 Old Pittwater Road, approximately eighty-six (86) metres in length to the existing power pole outside No.98 Old Pittwater Road, Brookvale.

#### 4.4 MANLY WARD - BEATRICE STREET, CLONTARF - NO PARKING

#### **PROCEEDINGS IN BRIEF**

Adele Heasman advised the Traffic Committee that she does not support the recommendation in its current form and asked if a further review could be undertaken.

James Brocklebank spoke to the rationale and noted it was an ongoing matter.

Campbell Pfeiffer suggested to defer this matter to next month's Local Traffic Committee Meeting, so that an investigation can be carried out.

The Local Traffic Committee agreed to defer approval of the Recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee defer the recommendation: *"Installation of 'No Parking' restrictions along the eastern side of Beatrice Street"* until an investigation has been carried out and discussed at next month's Local Traffic Committee Meeting being held on 7 May 2024.

#### 4.5 CURL CURL WARD - CALDER STREET AT MAKIM STREET, NORTH CURL CURL -NO STOPPING UNBROKEN YELLOW KERB LINE RESTRICTIONS

#### PROCEEDINGS IN BRIEF

The Local Traffic Committee agreed to support Recommendations No's 1-4 and add the following wording to the end of the line Recommendation No.4: *"to return 2 spaces, removing 1 space in total".* 

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Local Traffic Committee supports the:

- 1. Installation of 'No Stopping Unbroken Yellow Kerb Lines, at the intersection of Calder Street at Makim Street, North Curl Curl.
- 2. On the western side of the intersection, install a statutory 10m No Stopping Unbroken Yellow Kerb Line and extend it an extra 15 metres to terminate at the eastern side of the driveway serving No.3 Makim Street.
- 3. On the eastern side of the intersection, install a statutory 10m No Stopping Unbroken Yellow Kerb Line and extend it to a point 13m east of the intersection with Calder Street.
- 4. Relocation of the existing No Parking (L) sign on the northern side of Makim Street by approximately 10m west of the driveway serving No.6 Makim Street, **to return 2 spaces**, **removing 1 space in total.**

### 4.6 MANLY WARD - CONDAMINE STREET, BALGOWLAH HEIGHTS - TIMED PARKING PROCEEDINGS IN BRIEF

Phil Devon spoke to the matter of trailers parked along this road, which is affecting resident's car parking.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Local Traffic Committee supports the:

- A. Installation of an Eight Hour (8P) 7am-7pm Everyday Timed Parking restriction, approximately 60m in length, along the eastern side of Condamine Street, between Clarence Street and Lower Beach Street.
- B. Council Rangers to monitor implementation of parking restrictions.

#### 4.7 MANLY WARD - HOP, SKIP AND JUMP BUS SERVICE - PROPOSED BUS STOP RESTRICTIONS

#### **PROCEEDINGS IN BRIEF**

Recommendations A, B, F and G. were approved without discussion; however, it was agreed that Recommendations C, D and E be amended as follows:

Recommendation C - Hilltop Crescent, Fairlight -

The Local Traffic Committee noted that the proposed bus zone in Hilltop Crescent has been

# reviewed and reduced in length, based on the community response to consultation and discussions with affected residents.

Recommendation D - 279 Sydney Road, Fairlight -

The Local Traffic Committee agreed to add the words: "Council Rangers to monitor this road".

**Recommendation E** - 138-146 Addison Road, Manly – Installation of No Parking restrictions. – Mr James Griffin MP does not support this recommendation and has requested this matter be deferred pending investigation of the location.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports:

- A. 29 Osborne Road, Manly
  - i. Installation of 'No Parking' restriction between No.23 to No.29 Osborne Road, Manly.
- B. 53 Wood Street, Manly (on Marshall Street).
  - Installation of 'No Parking 7AM-6:30PM MON-FRI 9AM-6PM SAT-SUN' restriction on the south side of Marshall Street, north of the intersection with Wood Street.
- C. 23 Hilltop Crescent, Fairlight
  - i. Installation of 'Bus Zone 7AM-6:30PM MON-FRI 9AM-6PM SAT-SUN' restriction at the existing school bus stop, adjacent to the intersection of Hilltop Crescent and Krui Street, Fairlight.
- D. 279 Sydney Road, Fairlight (on Hill Street)
  - i. Installation of 'Bus Zone 7AM-6:30PM MON-FRI' restriction at the existing school bus stop, adjacent to the intersection of Sydney Road and Hill Street, Fairlight.
  - ii. The Local Traffic Committee requested that Council Rangers are to monitor this road.
- E. 138-146 Addison Road, Manly
  - Installation of 'No Parking 7AM-6:30PM MON-FRI' restriction on the south side of Addison Road, south of the intersection with Reddall Street, Manly. The Local Traffic Committee agreed to defer this matter until it has been investigated.
- F. 22-26 Roseberry Street, Balgowlah.
  - i. To convert 10-metre of existing 'No Stopping' restriction into 'Bus Zone 7AM-6:30PM MON-FRI' and 'No Stopping all other times' restrictions on the east side of Roseberry Street, along the frontage of No's 22-26 Roseberry Street, Balgowlah.
- G. 47 Osborne Road, Manly
  - i. Installation of 'No Parking 7AM-6:30PM MON-FRI 9AM-6PM SAT-SUN restriction on the north side of Osborne Road, north-west of the intersection with Marshall Street, Manly.

#### 4.8 MANLY WARD - WILLYAMA LANE, FAIRLIGHT - NO PARKING RESTRICTION

#### **PROCEEDINGS IN BRIEF**

Adele Heasman enquired whether there is an accident history report available to view for this area. Adele advised she is not in support of parking restrictions on the southern side of the lane.

James Brocklebank spoke to the matter and rationale.

The Local Traffic Committee agreed to support the Recommendation, however, amending it by deleting the words "and northern sides" – to read: *"Installation of "No Parking" restrictions along the eastern side of Willyama Lane.* 

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Local Traffic Committee supports the:

A. Installation of 'No Parking' restrictions along the eastern side of Willyama Lane.

#### 4.9 NARRABEEN WARD - NARRABEEN PARK PARADE, NORTH NARRABEEN - BUS STOPS REMOVAL & RELOCATION

#### **PROCEEDINGS IN BRIEF**

Phil Corbett advised that In the LTC meeting of 10 October 2023, James Makasiale from Keolis Downer requested whether buses can be re-routed to go up further into Cook Terrace and past the hospital (travelling north) due to safety concerns.

Cr Jose Menano-Pires noted that bus routes are the responsibility of TfNSW, Council is only responsible for changing bus stops.

Rob Markie from Keolis Downer advised that when TfNSW approves the re-routing of an established bus route, Council can then approve where bus stops can be located on Council roads and advised that the northern direction bus route could potentially be re-routed to Melbourne Avenue.

Cr Jose Menano-Pires advised that he has discussed this matter with the Member for Pittwater, Mr Rory Amon MP, who suggested an alternative bus route, i.e.: the buses proceed to the bus stop in Melbourne Street instead of in Cook Terrace, so that residents can park in their own street, which also services the Mona Vale Emergency Care Hospital in Coronation Street.

The Local Traffic Committee agreed to support both Recommendations 1 and 2 - Phil Devon advised that this is pending approval of Bus Planning Team - Melbourne Avenue Reserve.

Keolis Downer also agree with Option 2, using Melbourne Avenue as the preferred option for buses travelling in the northerly direction.

Samantha Morley advised that she will discuss this matter with TfNSW's Bus Planning Team.

The Local Traffic Committee agreed to support both Recommendations 1 and 2 – using Melbourne Avenue as the preferred option pending TfNSW approval.

Council will inform the Local Traffic Committee Voting Members, local Members of Parliament, and the Police in regard to this decision.

#### **RECOMMENDATION OF TRAFFIC COMMITTEE**

That:

A: The Traffic Committee supports both Options 1 and 2 with the final decision on the route to be made by Transport for NSW and;

B: Council be informed of the approved option by TfNSW to enable the implementation of the related bus stop infrastructure.

#### Option 1:

- 1. Notes the impact on residents of proposed re-routing of northbound buses from Narrabeen Park Parade to Melbourne Avenue and Cook Terrace.
- 2. Supports the relocation of the bus stop at No.146 Narrabeen Park Parade to No.18 Melbourne Avenue and installation of a Bus Zone of approximately 26m in length between the driveways to No.16 and No.20 Melbourne Avenue
- 3. Supports the relocation of the bus stop on the Narrabeen Park Parade frontage of No.37 Cook Terrace to the Cook Terrace frontage of No.48 Cook Terrace and installation of a Bus

Zone extending between the driveway serving No.48 Cook Terrace and Narrabeen Park Parade.

- 4. Reinstatement of kerbside parking in place of the removed bus zones on Narrabeen Park Parade.
- 5. Installation of 'No Stopping' Yellow Unbroken Line along the east side of Narrabeen Park Parade adjacent to the landscaped kerb blisters, north of Cook Terrace.
- 6. Extend the existing No Stopping' Yellow Unbroken Lines on both sides of Cook Terrace at Melbourne Avenue by approximately 6m in an easterly direction

#### Option 2:

- 1. Notes the impact on residents of proposed re-routing of northbound buses from Narrabeen Park Parade to Melbourne Avenue.
- 2. Supports the relocation of the bus stop at No.146 Narrabeen Park Parade to No.18 Melbourne Avenue and installation of a Bus Zone of approximately 26m in length between the driveways to No.16 and No.20 Melbourne Avenue.
- 3. Supports the relocation of the bus stop on the Narrabeen Park Parade frontage of No.37 Cook Terrace to Melbourne Avenue opposite the Melbourne Avenue frontage of 1 Coronation Street and installation of a Bus Zone extending from the existing No Stopping sign at the intersection approximately 27 metres to the power pole opposite the driveway of No. 1 Cook Terrace.
- 4. Reinstatement of kerbside parking in place of the removed bus zones on Narrabeen Park Parade and Coronation Street.

# 4.10 NARRABEEN WARD - ORLANDO ROAD, CROMER - TIMED PARKING AND NO STOPPING

#### **PROCEEDINGS IN BRIEF**

Phil Devon spoke to the matter that Orlando Rd is a high-demand road in Cromer's industrial area and signs are proposed to be installed to alert drivers to the timed parking and no stopping restrictions.

The Local Traffic Committee agreed to support the Recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

- 1. Introduction of 8P timed parking restrictions applying on both sides of Inman Road between Villers Place and Orlando Road. The restrictions to apply 8am-6pm Every day.
- 2. The extension of No Stopping zones from the statutory 10m to 20m on the east side of Inman Road, north and south of its intersection with Orlando Road.

### 4.11 PITTWATER WARD - ISOBEL CLOSE, MONA VALE - NO PARKING

#### PROCEEDINGS IN BRIEF

Phil Devon advised that another Recommendation be added:

B) Installation of 10m statutory yellow No Stopping painted lines on the corner of Isobel Close, Mona Vale.

The Local Traffic Committee agreed not to support the Recommendation of the installation of No

B) Installation of 10m statutory yellow painted lines on the corner of Isobel Close, Mona Vale.
