Commencing at 6pm for the purpose of considering items include ed on the Agenda.



SUMMARY

The KPMG Due Diligence Report on the Oval Carpark dated 16 December 2013 was published online on 20 December 2013 together with subordinate reports prepared by HILLPDA (Economic Assessment) and Bitzios Consulting (Parking Demand).

REPORT

By its Resolution 76/13, Council, inter alia resolved, to obtain "Due diligence review of the Manly Oval and Whistler Street Triangle components of the Manly 2015 Plan by an appropriate external, independent consultant and the report be made available to Councillors the public and the website"

KPMG was engaged to undertake an independent review of the Oval Carpark component of the Masterplan. Their review report dated 16 December 2013 was made available online and to Councillors soon thereafter in accordance with the Resolution of the Council and are circulated separately.
