

Background

In February 2016 changes were made to the existing parking meters at North and South Steyne Manly Beachfront, Shelley Beach, Clontarf Reserve, Sandy Bay Road and Battle Boulevard so that residents holding a valid Digital Designated Parking Permit were no longer required to place a ticket on their vehicles windscreen when using their free time.

Recently claims have been made in the media that the system is flawed and that residents and visitors have been unfairly fined.

Councillor Cathy Griffin will move:

That Council:

 Writes to the NSW Premier and the Minister for Resources and Energy requesting that the CSG exploration and Extraction licences PEL 238 in the Pilliga State Forest area be withdrawn and cancelled; and

2. Seeks an update from the NSW Premier and Minister for Resources and Energy on the cancellation of all the CSG exploration and extraction Licences in NSW and seeks assurances that the Government is listening to the people of NSW.

Background

In a recent survey (published on the Nature Conservation Council website) it was revealed that a majority of people in NSW think that the coal and coal seam gas industry are doing NSW communities more harm than good. Independent company ReachTEL conducted the survey on March 14 of this year to test community attitudes to the coal and coal seam gas industries in NSW, and to the Baird government's management of the sector.

KEY FINDINGS of ReachTel survey

For the first time, most people think coal does NSW more harm than good. Today, more than 56% of people say coal mining is having a negative impact on NSW communities, while 44% say it is having a positive impact. This result is the reverse of the results of the survey in 2013, and represents a very significant shift in community attitudes.

More people want environmental protections from coal and CSG now than in 2014. The solid majority that wanted farmland, water and the environment protected from coal and CSG in 2014 (74%) has increase significantly to 84%. This shift has occurred despite the government's assurances it is properly managing these matters (for example, through the Gas Plan, CSG licence buybacks, etc.)

Premier Mike Baird hasn't done enough to stop environmental harm from coal and CSG. 62% of people think Premier Baird still has not done enough to protect farmland, water and the environment from coal and CSG. This is despite two years of government propaganda, policy tweaking, CSG buybacks, and advertising campaigns by the coal sector (<u>Coal is Amazing</u>).

Manly Council reiterates its declaration of support for calls to the NSW Government to protect our environment and ban CSG exploration and extraction in NSW.

Twelve months ago Manly Council declared its support for a safe and secure water and food supply for the residents of Manly and the Northern Beaches and expressed Council's deep concern regarding the continuation of Coal Seam Gas Mining in NSW.

However since then Santos continues its plans to develop a coal seam gas field within their exploration lease covering over 800,000 hectares of the Pilliga Forest. In 2011 Santos bought Eastern Star Gas who proposed to drill 1,100 gas wells and clear 1,000 km of pipeline, fragmenting

85,000 hectares of Pilliga Forest and turning the iconic and significant habitat refuge into an industrial coal seam gas field.

The 2010 Preliminary Environmental Assessment for the proposed gas field development found all of the following risks to be "probable".

- Increased risk of bushfires
- Reduced habitat availability for State listed threatened species, populations or communities resulting from vegetation clearance
- Loss and/or fragmentation of native vegetation resulting from clearing for wells, gas plant and water infrastructure
- Drawdown of surface aquifers resulting from dewatering of coproduced water during gas extraction
- Contamination of surface waters resulting from storage of saline coproduced water or brine
- Reduced opportunity for recreation in areas of Pilliga East State Forest
- Potential contamination of land resulting from brine storage or disposal
- Erosion and deposition of exposed soils and release of sediment laden runoff into creeks and rivers

Already, the coal seam gas exploration drilling in the Pilliga Forest has caused massive environmental damage. Santos now plans to drill 50 more exploration wells in the region. Over 20 environmental incidents have been reported including a large spill of untreated coal seam gas water: a toxic cocktail of heavy metals (arsenic, lead and chromium), salts and petrochemicals.

Activities to date have also caused ecological problems and directly destroyed at least 150 hectares of habitat. 1,700 hectares of native vegetation has been heavily fragmented, impacting sensitive plant and animal populations and causing weed invasions.

Chemical and diesel pollution events have occurred, killing many further hectares of forest. Native wildlife has been found dead at saline drill ponds.

I have circulated separately to all Councillors a copy of a statement in lieu of a Public Address to Council tonight provided to me by Ms Sarah Ciesiolka from Narrabri, which I will reference in my address.

That Manly Council work with Warringah Council to seek joint concessional purchase or transfer of the Sydney Water land adjacent to the Manly Warringah War Memorial Park into the Park.

That letters be sent to the local member and relevant ministers outlining council's desires to see this outcome, including brief details of the history of the site and other relevant supporting information.

Background

Previously Sydney Water attempted to sell the land around their storage tanks at Bantry Bay that they consider "surplus". This land was originally part of the Manly Dam site, most of which was turned into the Manly Warringah War Memorial Park. Like other sites sold by Sydney Water, the land was originally held for future water storage expansion. However it has not been needed so far and the site thus remains undeveloped and close to its original natural bushland state.

Sydney water continues to sell other "surplus" land in the MWP area around its storage tanks, and within the Manly Council area at its closed reservoir site at Fairlight.

Due to the undeveloped Bantry Bay site being adjacent the War Memorial Park it has a high conservation value and steps need to be taken to secure the site into the reserve for posterity.

SUBJECT: Improvements to North Head Waste Water Treatment Plant WTP- funding two

digesters

Councillor Hugh Burns will move:

That Manly Council write to the local member and Premier Mr Mike Baird, and the relevant ministers calling for the State government to fund the installation of two digesters as sought by Sydney Water at the North Head Plant within the next 18 months, to assist resolving the ongoing odour problems from the plant and also from the trucks leaving the plant.

The letter should mention that the community is sufficiently concerned that it is prepared to mount a political campaign similar to the one run to close the incinerators at North Head, to encourage prompt and proper action from the government on this matter.

Background

Currently Sydney Water and IPART are struggling over the issue of the approval to fund the capital project of installing two additional digesters at North Head. Sydney Water wants funding of two and IPART wants them to only install one to minimise the impact on the public's water bills.

The issue is that one is required for expansion of Sydney Water's network over time and the other is required to improve availability and reliability of the existing three digesters. In its reply to IPART Sydney water notes the two digesters to reduce the odour problem at the plant (NH has 30% more complaints than other similar plants) and also reduce the odour emitted by the tracks carting the biosolids away from the plant through the streets of Manly.

Currently the plant is having an adverse effect on the amenity of the suburbs and residences close to the plant due to strong odour emissions - the severity of which is often determined by the wind direction and the functioning of the plant.

The Sydney Water response to IPARTs draft report can be read via this link – it outlines the clear need for the digesters as a case study.






