Manly Community Strategic Plan Beyond 2025 (MC/15/35120) SUMMARY

It is the recommendation of this report to adopt and exhibit for the required statutory period, the integrated Manly Community Strategic Plan Beyond 2025, including the Community Strategic Plan (Part 1), Resourcing Strategy (Part 2), Four Year Delivery Program 2013 -2017 (Part 3) and One Year Operational Plan 2015-2016 including Revenue and Financial Plan and Fees and Charges 2015-2016, Operational Plan and Budget 2015-2016.

Council's Draft Waste budget as presented has provided for the combination of the Waste Education Program as part of the Council's ongoing commitment to waste minimisation and waste avoidance.

This report also relates to the Draft Waste Services Budget for 2015/2016 including all disposal and levy increases.
