What is PIR?

- ▶ PIR has 2 major aims:
 - ▶ Supporting **INDIVIDUALS** experiencing severe and persistent mental health conditions, their families, and their support networks, to access holistic support, when and where they need it.
 - ▶ Creating and supporting **SYSTEMS** that work together to respond collectively to the needs of people with severe and persistent mental health conditions.

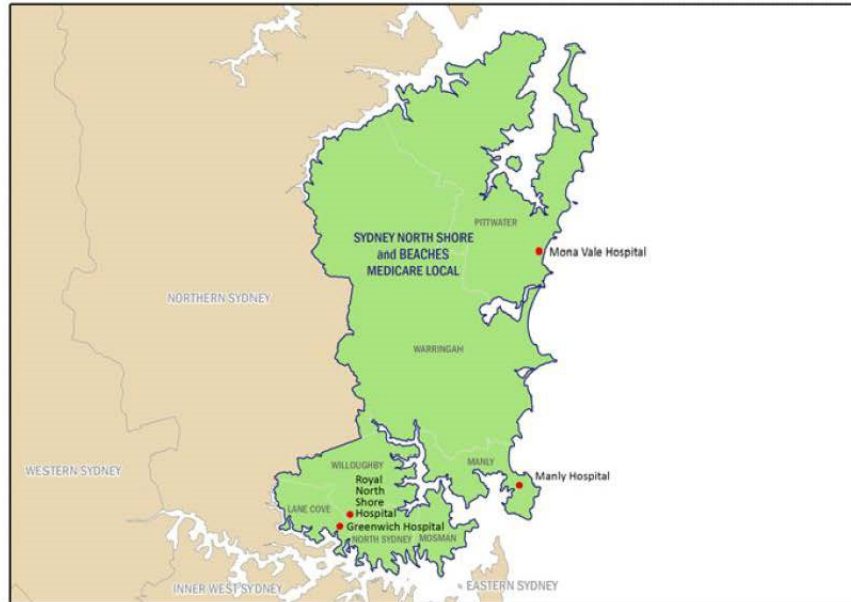
PIR Objectives

The ultimate objective of PIR is to improve the system response to, and outcomes for, people with severe and persistent mental illness who have complex needs by:

1. Providing coordination of supports and services to deliver support individually tailored to the person's needs
 2. Building better links between various support organisations
 3. Improving referral pathways between services to provide access to a full range of services
 4. Promoting a community based recovery model to underpin all support services

The PIR Region



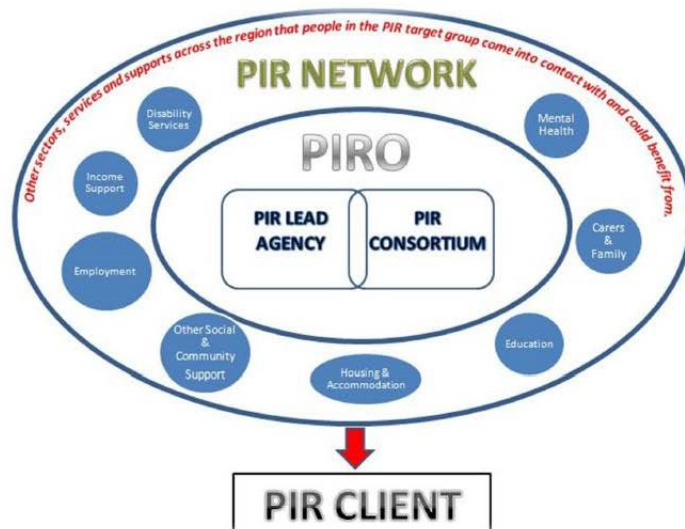
What is a severe and persistent mental health condition?

- ▶ “The experience of persistent symptoms, significant functional impairment and psychosocial disability”

Or from a Consumer’s definition:

“Severe mental illness is when your condition impacts on your right to a meaningful, dignified and purposeful place in society due to a continual reoccurrence of symptoms”

How will PIR work?



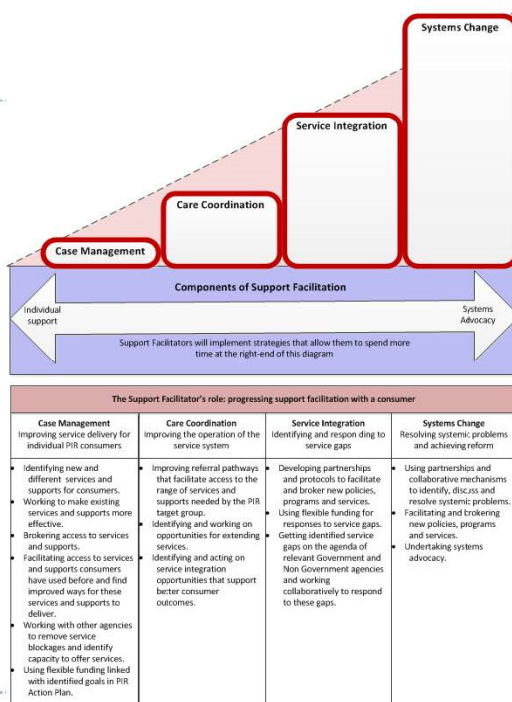
Support Facilitation

Opportunities

For Consumers and families:

- ▶ Focused approach to coordination of existing supports
- ▶ Single facilitator to minimise access confusion/complexity
- ▶ Capacity to access timely flexible funds to meet immediate needs
- ▶ Opportunities to shape the system through consultation and specific consumer and carer advisory roles

For the sector:

- ▶ Improved referral pathways and system level partnerships/MoUs
 - ▶ Capacity to support individuals holistically through shared support models and flexible funding
 - ▶ Sector training and development opportunities
 - ▶ Funding to provide facilitator functions
 - ▶ Opportunities to work together to build a better system of support

The Gaps we need to start working on...

- ▶ Housing and Accommodation
 - ▶ Homelessness
 - ▶ Community Transport
 - ▶ Severe Social Isolation
 - ▶ Lack of assertive outreach services
 - ▶ Linkage with Physical Health system
 - ▶ Access to narrative therapies
 - ▶ Recovery and trauma informed service design and training
 - ▶ Privacy and Confidentiality
 - ▶ No wrong door culture
 - ▶ Respite services and resources
 - ▶ Access to information and service

Some initial success...

- ▶ Delivery of \$60k of blended mental health and recovery training to broader range of partners in region in 2014
- ▶ Significant work in recovery and reconciliation for Australian First People in our community
- ▶ Partnerships and relationship developed outside of PIR
- ▶ Visited and presented to 150 services
- ▶ Access to 200 referrals of severe and complex nature
- ▶ 150 client accepted onto PIR in 2014
- ▶ Expansion of outreach work in community for isolated and marginalised
- ▶ Formation of regional Homelessness and Squalor and Hoarding task force
- ▶ Supporting Northern Beaches Recovery Forum in October
- ▶ Sponsoring access to online resource directories

HUB B - Harkieith Street and pedestrian walkways to Darley St and including Mona Vale Hotel Walkway.



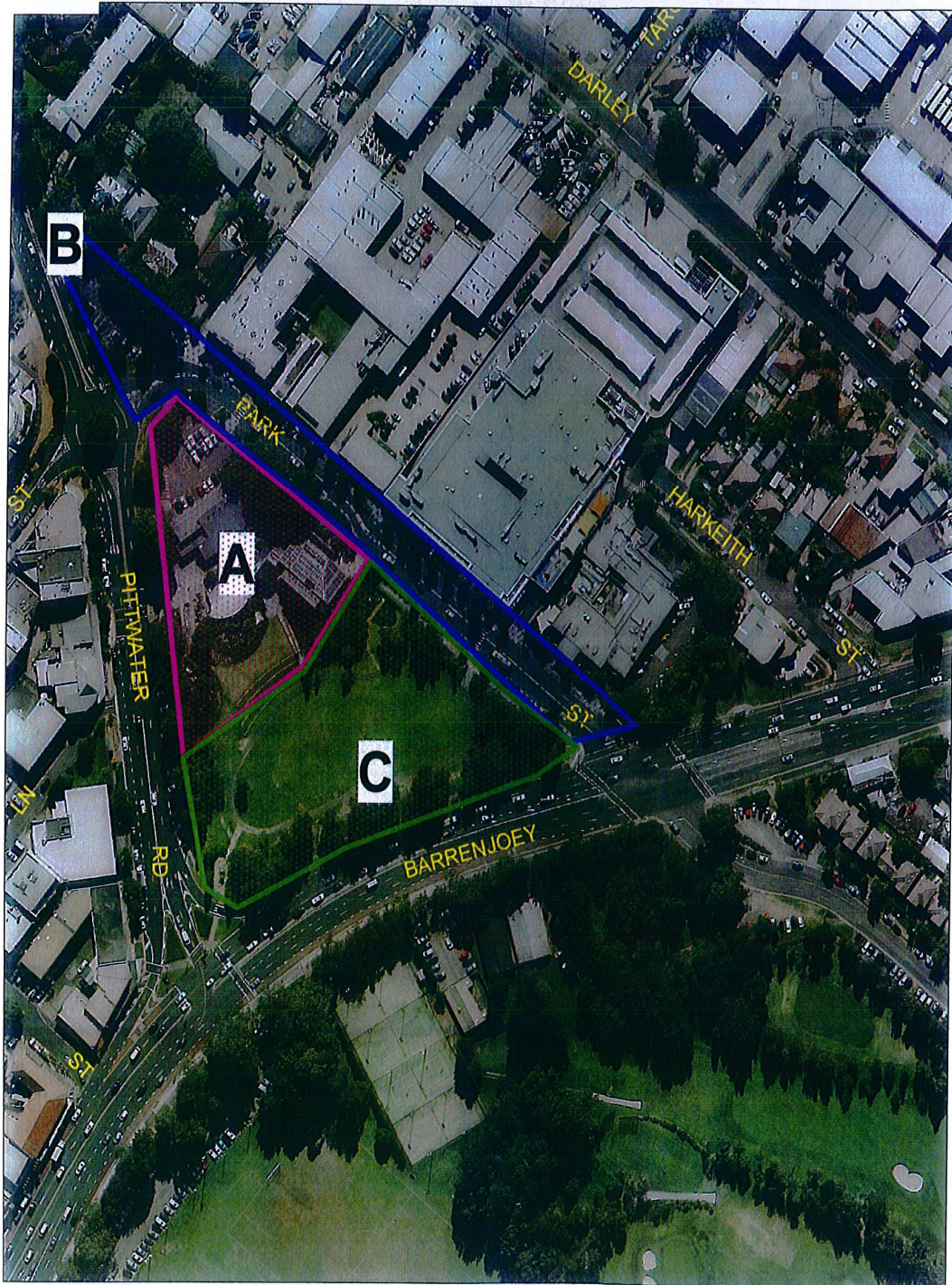


2 - PARK STREET PRECINCT

HUB A - Library, The Inch and walkway between library and community hall and carpark.

HUB B - Carpark at western end of Park Street and whole length of Park St (East).

HUB C - Village Park and surrounding footpath along Barrenjoey Road and Pittwater Road.





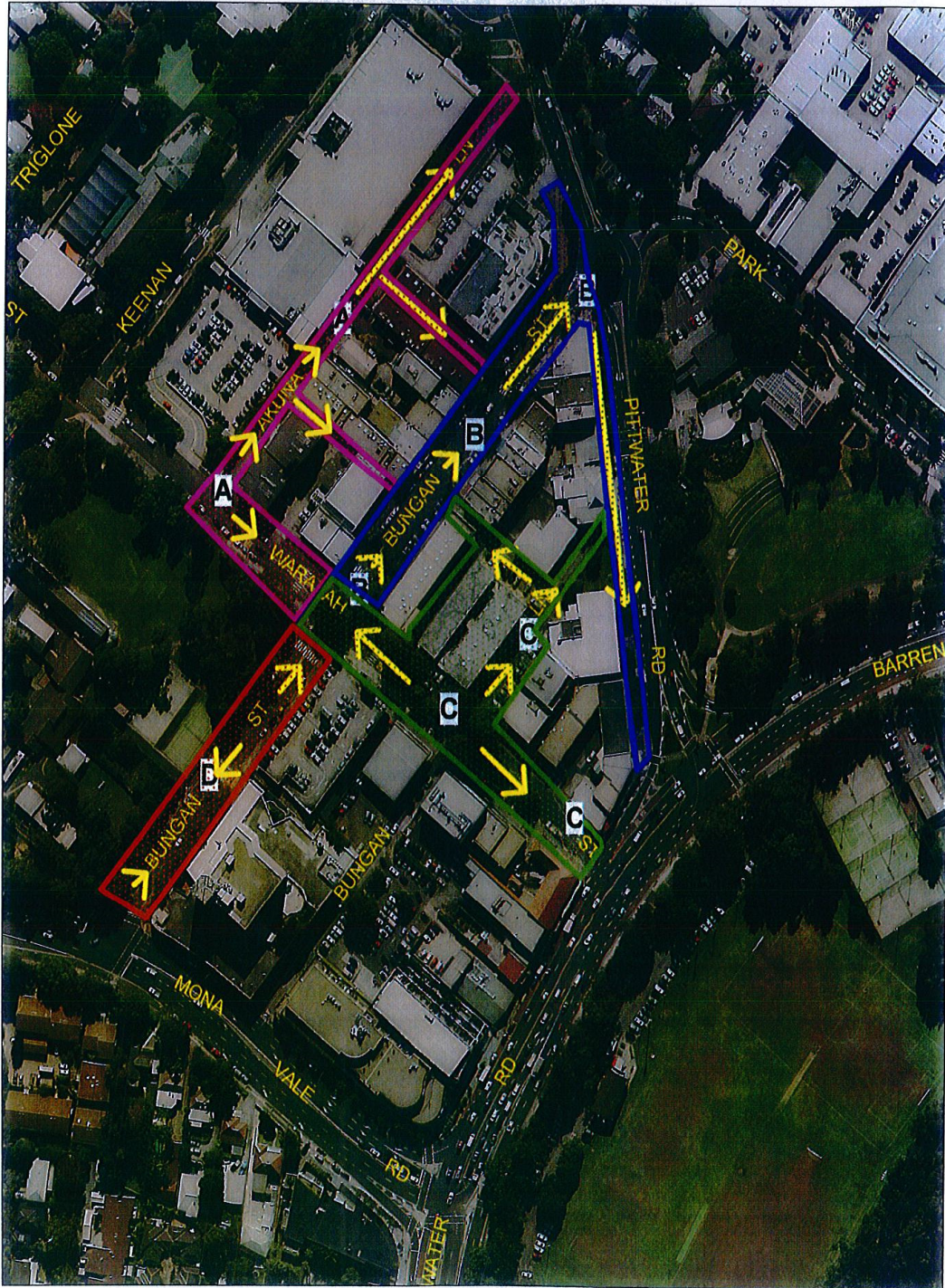
3 - UPPER MONA VALE PRECINCT

HUB A - Akuna Lane & Laneways adjoining Bungan Street & Akuna Lane and Waratah Street (West end).

HUB B -Bungan Street (from Waratah St to Pittwater Rd) and along Pittwater Rd to Barrenjoey Rd.

HUB C - Waratah St (Eastern end) to Bungan St - Bungan Lane from Waratah St to Pittwater Rd including Waratah Court.

HUB D- Bungan St from Waratah St to Mona Vale Rd.

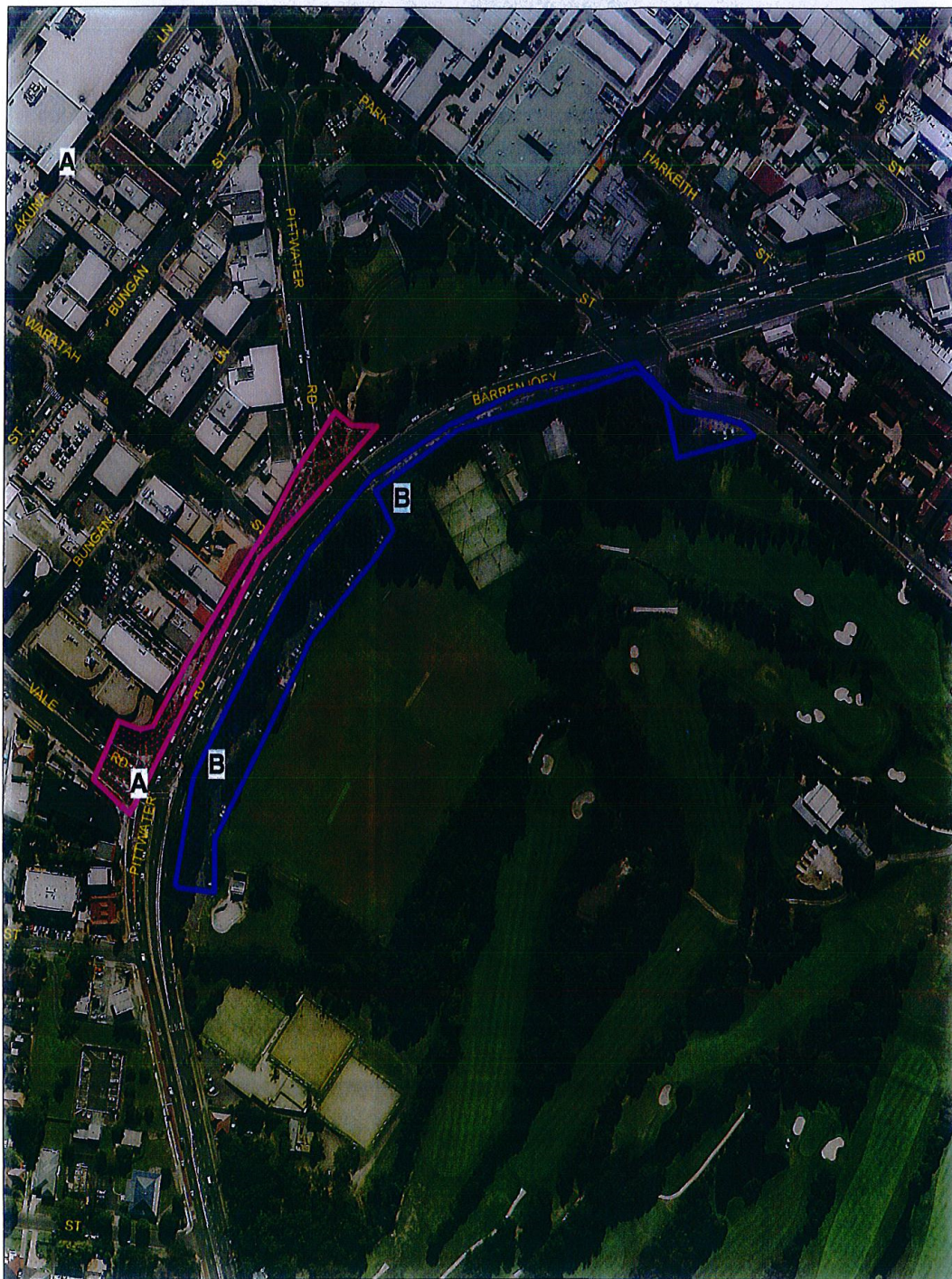




4 - TRANSIT PRECINCT
