REPORT

BACKGROUND

Council has received a request from a resident to provide disabled parking at Little Manly Beach, Craig Ave, Manly. The resident has also raised this issue with the Disability Discrimination Commissioner. An investigation was conducted on the feasibility of providing disability parking and associated parking layout modifications.

LOCATION

Little Manly Beach off-street carpark, Craig Ave, Manly.

ISSUES

- Currently there are eight (8) spaces of 60⁰ angle parking with varying dimensions that are available for vehicles under 6m. Parking bays have been marked. Additional parking for trailers is also available.
- The parking proposal maintains that the total number of parking spots for vehicles under 6m includes:
 - One (1) disabled parking space which complies with Australian Standards AS 2890.6
 - Seven (7) 90[°] angle parking spots.
- The existing driveway cannot be used effectively due to its proximity to an informal boat storage area beyond it. It is therefore proposed to relocate it 4.8m in a south-west direction.
- A vehicular crossing shall be constructed without a lip to facilitate disabled access from the driveway to the footpath while maintaining use of the ramp as a vehicle crossing. The area in front of the driveway will be hatched as per AS 2890.6 to denote its use as a disabled unloading area.
- Existing bay markings will be removed and new bay markings at a 90[°] angle will be added to facilitate ease of access to the parking bays. Associated signs and pavement markings will also be updated.
- An existing redundant 'No Parking' (Right) sign will be removed.



CONSULTATION

All properties in Craig Avenue and on both sides of Stuart Street, within approximately 75m of the carpark, have been advised of the change and invited to submit comments. A summary of any feedback received will be available at the Traffic Committee meeting.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee support the proposed parking modifications at the Little manly Beach carpark including:

- A. Modification of parking from a 60° to 90° angle.
- B. Creation of a disabled parking bay and associated signs and pavement markings.
- C. Relocation of the vehicular crossing.
- D. Creation of a combined disabled ramp and vehicular crossing.
- E. Removal of existing 'No Parking' (Right) sign.




Figure 2: Arial View

BACKGROUND

Council has received complaints from parents that it is very dangerous crossing South Creek Road, Wheeler Heights, when taking their children to the St Matthews Farm Reserve Skate Park. They say vehicles are travelling too fast past the Skate Park and it is dangerous crossing South Creek Road with their children to and from the Skate Park.

Parents taking their children to 'The Spot Day Care Centre' at 3/178 South Creek Road have also complained about the speed of traffic on South Creek Road and their difficulty crossing South Creek Road with their children.

LOCATION

South Creek Road from Middleton Road to Penrith Avenue, Wheeler Heights.

ISSUES

- Traffic speeds on South Creek Road past the newly opened St Matthews Farm Reserve Skate Park. Results of a traffic and speed count survey, conducted10 June 2017, were a combined traffic count of 9,496 AADT and an 85th percentile traffic speed of 54 km/hr.
- Parents and children crossing South Creek Road to and from the Skate Park, and two local day care centres near Penrith Avenue, complain that there are no safe places to cross because of traffic speeds and that they cannot clearly see approaching traffic.
- Parents and children are crossing South Creek Road along the whole frontage of the Skate Park. It would be preferable if parents and children could be encouraged to cross South Creek Road at either end of the Skate Park. This could be arranged by building a fence along the frontage of the Skate Park between the Skate Park and South Creek Road.
- To make it easier for parents and children to cross South Creek Road it is proposed to construct a Pedestrian Refuge on South Creek Road about 10m south of Waroon Road which is the access to about 50 off-street parking spaces.

RECOMMENDATION TO TRAFFIC COMMITTEE

That a pedestrian refuge be installed at the location shown on the attached plan approximately 10m south of the entrance to the carpark on Waroon Road, Cromer. Kerb measurements indicate there is approximately 30m between the southern kerb of Waroon Road and the next driveway south of Waroon Road at No.174 South Creek Road. This provides sufficient space for the proposed pedestrian refuge and still allows vehicle access to the driveways at No.172 and No.174 on South Creek Road.

BACKGROUND

Council has received a request from Council's Waste Service Officer to install 'No Parking' signs on Karingal Crescent, Frenchs Forest, from Fitzpatrick Avenue East to Akora Street to assist with the collection of domestic waste in Karingal Crescent.

Council's waste collection day for Karingal Crescent is Mondays.

LOCATION


The eastern side of Karingal Crescent from the southern boundary of No.3 to the northern boundary of No.7 Karingal Crescent.

ISSUES

- Parallel parking is unrestricted on both sides of Karingal Crescent from Fitzpatrick Avenue East to Akora Street.
- If vehicles are parked on both sides of Karingal Crescent, around the curve in the road between No.3 and No.7 Karingal Crescent, Council's waste collection vehicles cannot travel along that section of Karingal Crescent.
- To ensure the area is clear of parked vehicles for waste collection and other emergency vehicles it is proposed to install 'No Parking Mondays 6:00am to 4:00pm' signs.
- Local residents were notified by letter of Council's proposal to ban the parking in front of No.3, No.5 and No.7 Karingal Crescent. Residents at No.5 & No.7 Karingal Crescent accepted the proposal. The resident at No.3 was against the proposal because they would be required to relocate their boat parked on the road outside their residence every week.

RECOMMENDATION TO TRAFFIC COMMITTEE

That Traffic Committee support the installation of 'No Parking Mondays 6:00am-4:00pm' signs on the eastern side of Karingal Crescent, from the southern boundary of No.3 to the northern boundary of No.7 Karingal Crescent to assist with waste collection in the street.

BACKGROUND

Council has received a complaint from a local resident that a large advertising trailer is parking for days/weeks on the southern side of Tramore Place (northern leg), from Starkey Street to the north south section of Tramore Place, and causing a safety issue for vehicles turning off Starkey Street into Tramore Place.

The resident mentioned a recent accident where a car hit the trailer when turning the corner.

LOCATION


The southern side of Tramore Place (northern leg) Killarney Heights from Starkey Street to the north south section of Tramore Place.

ISSUES

- There is 14m of unrestricted parking on the southern side of Tramore Place between the two 10m statutory 'No Stopping' sections from either intersection.
- A large advertising trailer parks in the unrestricted parking space for extended periods of time which is causing a safety issue.
- The trailer is a safety hazard for vehicles turning off Starkey Street into Tramore Place.
- There is an anecdotal report of a vehicle recently hitting the advertising trailer.
- Tramore Place is a key access road to the Killarney Heights Public School, the local shopping centre car park, and the Carlile Swimming Centre.
- The proposal is to install permanent 'No Parking' signs between the two statutory 10m 'No Stopping' areas so that a vehicle can stop for up to 2 minutes to set down or pick up passengers.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the installation of 'No Parking' signs between the two statutory 10m 'No Stopping' sections from Starkey Street and from the north south section of Tramore Place.

BACKGROUND

The owner of the business at 5/5 Narabang Way, Belrose, has complained they are unable to receive truck deliveries when cars are parked close to either side of their driveway.

They say white lines painted either side of their driveway would not help as cars often ignore them. In the past they have been parking cars on the street either side of the driveway when they expect deliveries.

They can receive truck deliveries at any time so parking cars and then removing them when the truck arrives is not a good solution.

The two driveways to No.6 Narabang Way have 'No Stopping' signs installed approximately 6m either side of their driveways.

They say the maximum size truck is a normal delivery truck (about 8m) and not a semi-trailer.

Narabang Way, Belrose, is a two way divided road with a wide central unformed median. One-way carriageways are 6m wide.

The local area is the Belrose commercial area between Mona Vale Road and Forest Way.

LOCATION

Driveway to 5/5 Narabang Way, Belrose.


ISSUES

Normal delivery trucks are unable to enter the site when cars are parked close to their driveway.

RECOMMENDATION TO TRAFFIC COMMITTEE

Install 'No Stopping' signs for 6m on either side of the driveway to 5/5 Narabang Way, Belrose.

BACKGROUND

The Strata Manager for the new block of units at 16-22 Sturdee Parade, Dee Why, contacted Council on behalf of the residents in the units stating that the residents are having difficulty seeing approaching traffic on Sturdee Parade. They say traffic is moving fast and they feel very insecure when exiting the site.

They have requested 'No Stopping' signs be placed either side of the driveway.

LOCATION


16-22 Sturdee Parade, Dee Why.

ISSUES

- Lack of sight distance when exiting driveway.
- Driving into traffic moving fast and close to their driveway at speeds of 50km/h or higher.

RECOMMENDATION TO TRAFFIC COMMITTEE

Install 'No Stopping' signs 6m either side of the driveway to 16-22 Sturdee Parade, Dee Why.

REPORT

BACKGROUND

A resident in Oliver Street, Freshwater, contacted Council to complain of a safety issue when cars were exiting Raffo Lane, Freshwater, onto Oliver Street.

The resident mentioned that many children use the footpath across Raffo Lane and that cars were not slowing down when crossing the footpath. The high fence on the northern side of Raffo Lane severely restricts sight distance for drivers and pedestrians to only a few metres and hence vehicles should stop before driving across the footpath.

LOCATION


- Raffo Lane is an east west laneway west of Oliver Street and a short north south laneway north of Wyndora Avenue.
- Raffo Lane has a narrow 3m wide strip of asphalt in Raffo Lane which is 5m wide.

ISSUES

- Vehicles not stopping when crossing the footpath on Oliver Street.
- Very short sight distance from Raffo Lane along the Oliver Street footpath.
- Limited sight distance from Raffo Lane along the Wyndora Avenue footpath.

RECOMMENDATION TO TRAFFIC COMMITTEE

Install a STOP sign and associated pavement markings on Raffo Lane at either end of Raffo Lane at Oliver Street and Wyndora Avenue.

REPORT

BACKGROUND

A resident at 1 Sturdee Parade, Dee Why, has complained to Council that vehicles are using the entry/exit to their residential unit block to do a 'U-Turn' on Sturdee Parade. This is causing a safety issue for vehicles using the entry and exit driveway to the building.

LOCATION


The western end of Sturdee Parade, Dee Why, near the intersection with Pittwater Road.

ISSUES

Vehicles using the driveway to the unit block to do a 'U-Turn' in Sturdee Parade. It is proposed to extend the BB centerline from Pittwater Road because the Australian Road Rules do not permit a 'U-Turns' across a BB centerline.

RECOMMENDATION TO TRAFFIC COMMITTEE

Extend the existing BB centerline from Pittwater Road a further 60m to just before the driveway to No.7 Sturdee Parade, Dee Why.

BACKGROUND

The NSW Government is delivering transport improvements for the Northern Beaches which will include the delivery of a new B-Line bus service and the introduction of the Northern Beaches Bus Service Plan.

To improve operational efficiency, and to continue to provide a bus stop in the Mona Vale Town Centre for the 155 and 156 Bayview and Church Point service, bus stop (S210397) will be relocated to Pittwater Road, at the corner of Bungan Lane and at the site of the existing taxi zone.

A new bus stop to service outbound bus services is currently being constructed by TfNSW in Barrenjoey Road and will be located on the eastern boundary of Village Park.

This relocation will also provide passengers the opportunity to connect to bus services travelling north.

The full proposal submitted by TfNSW for consideration by the Northern Beaches Council Traffic Committee can be viewed in Attachment 1- TfNSW Taxi Zone Relocation Submission.

LOCATION

So that the Mona Vale Town Centre can continue to provide a taxi service for our community in a central and accessible location for both passengers and taxi drivers, the existing taxi zone on the southern side of Pittwater Road is proposed to relocate to the northern side of Pittwater Road, on the southern boundary of Village Park.

The site for the relocation of the taxi zone in Pittwater Road, Mona Vale, was identified in the Review of Environmental Factors (REF) that was paced on public exhibition by TfNSW.

Attachment 1 - TfNSW Taxi Zone Relocation Submission provides concept sketches and plans relating to the relocation of the bus stop and taxi zone.

ISSUES

Two options were presented to Council by TfNSW regarding the placement of the shelter at the site of the proposed taxi zone, which can be viewed in Attachment 1 - TfNSW Taxi Zone Relocation Submission.

Council has selected the location 'A' as the preferred location for the taxi shelter, as per the below recommendations by Place Planning:

- The shelter should be closer to where the potential future activities are. In this case, we are talking about activities at the town center.
- Although we do not expect a high concentration of people to queue for a taxi, we should consider the space required for the queue. As far from the intersection as possible is the better/safer option.

REPORT TO NORTHERN BEACHES COUNCIL LOCAL TRAFFIC COMMITTEE MEETING

ITEM NO. 4.9 - 01 AUGUST 2017

- Site A has less visual impact because it is placed amongst the trees and further from the heritage War Memorial site. There is a potential to upgrade public spaces around the War Memorial site. If the shelter is located near the Memorial site we may reduce our opportunity to create and improve the spaces around the Memorial in the future. We strongly believe this is part of the identity of Mona Vale.
- Although the Draft Place Plan is on-hold and could change, the intention is always to activate south side of the Village Park and Pittwater Road. Café or other uses on this side (closer to the center) is quite likely in the future. A taxi rank closer to activities such as this will increase opportunity for casual surveillance and maintain the relationship between the activities.
- Will have fewer impediments on the future potential of Village Park as a community 'hub' and 'people's spaces.
- Landscape concept plan relating to Village Park can be viewed in Attachment 2 Village Park Concept Plan.

Other items to note:

NORTHERN BEACHES

COUNCIL

- Bus stop S210397, which is proposed to relocate to the site of the existing Taxi Rank in Pittwater Road, will utilise the current length of the rank (33m) and the 10m draw out area at the corner of Bungan Lane. This will provide the required 40m space for buses to safely draw in and out of the zone.
- The six (6) existing 1P (one hour) car parking spaces located on the southern side of Pittwater Road will remain in their current location and will continue to provide short term and high turnover parking to support local business.
- Four (4) angled parking spaces will be removed on the northern side of Pittwater Road to provide space for the relocation of the taxi zone.
- The existing Telstra Phone box will be relocated to the proposed taxi zone site.
- The shelter located at the existing taxi zone will remain in place for bus passengers.
- A bus shelter will be relocated from a redundant bus stop to the site of the proposed taxi rank in Pittwater Road.

COMMUNITY ENGAGMENT

TfNSW undertook community engagement with local businesses, State Transit Authority (STA), NSW Taxi Council and the Mona Vale Chamber of Commerce, who all have provided approval and agreement for the relocation of bus stop (S210397) and the relocation of the taxi zone. Copies of their written acceptances are provided in Attachment 1.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Northern Beaches Council Traffic Committee:

- A. Supports the relocation of bus stop S210397 to the taxi rank located in Pittwater Road, at the corner of Bungan Lane, Mona Vale.
- B. Supports the relocation of the taxi zone to Pittwater Road and the installation of a taxi shelter in location 'A'.

To obtain approval from the Northern Beaches Council (NBC) Traffic Committee for the:

- relocation of bus stop # S210397 to the taxi rank located at the corner of Bungan Lane and Pittwater Road ÷
- 2. construction of a new taxi rank on the opposite side of Pittwater Road

Background

As part of the Northern Beaches B-Line Project (NBBP), Transport for New South Wales (TfNSW) is constructing a new outbound Mona Vale B-Line bus stop on the side of Village Park in Barrenjoey Road (please refer to Point A on the Mona Vale Map).

South of the junction between Pittwater Road and Barrenjoey Road is an existing outbound bus stop # S210397 (please refer to Photo # 1), which services buses running to Bayview and Church Point. For the purposes of operational efficiency at the new outbound Mona Vale B-Line Bus Stop it was decided to relocate bus stop # S210397 further along Pittwater Road. This location was identified in the Review of Environmental Factors (REF) that was places on public exhibition (please refer to Point B on the Mona Vale Map).



REPORT

BACKGROUND

Council has received a request from the Developer undertaking works at No.86 Rickard Road, North Narrabeen, to relocate the existing bus stop west of the new driveway location to minimise disruption to bus services during construction.

LOCATION

- Rickard Road is a collector road with a 50km/h speed limit and a pavement width of approximately 10m between kerbs.
- The section of Rickard Road under consideration has double separation lines installed along the centre of the road.
- Articulated buses service the 182 bus route, which operates in both directions along Rickard Road. The respective bus stops are located on opposite sides of the road and are sign posted 'Bus Zone 6:00am-8:00pm Mon-Sat'.
- There is an existing footpath on the southern side of Rickard Road, but no footpath on the northern side.

CONSULTATION

- Council has consulted with State Transit regarding the request who have advised preference for the Bus Zone, catering for articulated buses, to be relocated northwest clear of the proposed driveway.
- State Transit has also advised that as part of the Northern Beaches Bus Service Plan services will be increased from 6:00am to 9:00pm seven days a week and that the signage will need to be updated.
- Adjacent property owners will be notified of the recommendation prior to consideration of the matter by the Traffic Committee.


ISSUES

- The existing bus stop outside No.86 Rickard Road, North Narrabeen, needs to be relocated due to the impact of the proposed development and the Developer is seeking support of the Traffic Committee for the relocation of the bus stop to an appropriate location, clear of the future driveway.
- The existing Bus Zone on the northern side of Rickard Road is approximately 23m long, which is undersized for articulated buses.
- Buses must stop at and parallel to kerbs to ensure accessibility as required under the Commonwealth Disability Discrimination Act, in consideration of the needs of the elderly and less mobile passengers, and it is proposed that the Bus Zone be extended to cater for articulated buses.

- Council proposes to install a Bus Zone 32m in length with the entry Bus Zone sign located 28m northwest of the property boundary between No.86 and 88 Rickard Road. The new 'Bus Zone 6:00am to 9:00pm' restrictions will apply every day and includes the future driveway which will provide the necessary draw out lengths for an articulated bus. Bus Zone signs on the southern side of the road will also be replaced to cater for the increased bus services.
- It is considered that bus services and overall safety for all users would be improved by relocating the Bus Zone and installing the new 'Bus Zone 6:00am to 9:00pm' signage.

RECOMMENDATION TO TRAFFIC COMMITTEE

- A. That the Traffic Committee supports the relocation of the existing 'Bus Zone 6:00am-8:00pm Mon-Sat' outside No.86 Rickard Road, North Narrabeen, to provide a new 'Bus Zone 6:00am to 9:00pm' restrictions (32m in length) north of the future driveway.
- B. That the corresponding 'Bus Zone 6:00am-8:00pm Mon-Sat' signage for the Bus Zone located on the opposite side of the road be replaced with 'Bus Zone 6:00am to 9:00pm' signs.

COUNCIL

BACKGROUND

- Council previously approved the Church Point Parking Demand Management Strategy which outlines recommendations to manage parking in local streets as well as the existing Church Point Reserve car park and the new Church Point car park.
- The Local Street Concept Plan includes Eastview Road, Baroona Road and Quarter Sessions Road. One of the main objectives of the Strategy is to address safety issues in local streets as a priority while minimising the spots required to be removed. It is proposed that part of the road shoulder fronting No.19 Eastview Road be converted to motorcycle parking to prevent parking at this location.

LOCATION

- Eastview Road is not a through road, with low traffic volumes carrying only local traffic from Pittwater Road.
- No Stopping restrictions (indicated by a solid yellow line) were installed along narrower sections of Eastview Road, to prevent parking between Baroona Road and Quarter Sessions Road, and a white edge line was installed on the eastern side of Eastview Road.
- The existing road has no formal footpaths, with kerb and gutter only on the western side (high side).

CONSULTATION

Council has discussed the matter with the affected owner of property No.19 Eastview Road, explaining details of the proposal and necessary remedial works.

ISSUES


- There is a high demand for on-street parking in Eastview Road from visitors of residents and residents living on Scotland Island and Western Foreshore.
- Residents from Eastview Road have reported incidences of vehicles parking outside No.19 Eastview Road, encroaching on the white edge line on the eastern side of Eastview Road.
- The Road Rules require that the driver must position the vehicle so there is at least 3m of the road alongside the vehicle that is clear for other vehicles to pass.
- The road shoulder fronting No.19 Eastview Road was previously indicated as unrestricted • parking (minimum two car park space lengths) in the Church Point Parking Demand Management Strategy.


- Council has undertaken a further review of the area and proposes to install 'Motorcycle Parking' signs to restrict parking from 6m north of the existing driveway of No.19 Eastview Road to the pedestrian access to the property located at the northern end, due to the narrowing of the road shoulder. Some minor works, including trimming of the existing hedge and relocation of two bollards at the southern end, will be required in order to retain one car park space adjacent to the driveway.
- It is recommended that the proposed be supported to improve access at this location, provide an area for motorcycle parking, and to retain one car park space.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the proposal to install 'Motorcycle Parking' signs to restrict parking from 6m north of the existing driveway of No.19 Eastview Road to the pedestrian access to the property located at the northern end, due to the narrowing of the road shoulder.

BACKGROUND

Council has received a request from the Developer undertaking works at No.295 Whale Beach Road, Whale Beach, to change the existing 'No Parking' restrictions fronting the property to the opposite side of the road to facilitate construction of the development.

LOCATION

- Whale Beach Road is a collector road with a 40kph speed limit approved under a previous RMS Local Traffic Scheme.
- The section of Whale Beach Road under consideration is located between the driveway of No.278 Whale Beach Road and the intersection of Norma Road.
- The pavement width for this section varies between 6.5m and 7.5m.
- There is a School Bus service which operates along Whale Beach Road and bus stops are located on both sides of the road, just north of the Whale Beach Road/Norma Road intersection.
- The existing 'No Parking' restrictions only apply on the southern side of Whale Beach Road.

CONSULTATION

- The proposed Construction Traffic Management Plan (CTMP) was raised at a recent Committee meeting of the Palm Beach and Whale Beach Association (PBWBA). It was the view of the Committee that the CTMP adequately dealt with traffic management at the construction site during the proposed construction period and that no modification to the CTMP was required by PBWBA.
- Adjacent property owners will be notified of the recommendation prior to consideration of the matter by the Traffic Committee.

ISSUES

- The existing 'No Parking' restrictions fronting the property of No.295 Whale Beach Road prevents delivery of materials and concrete pours from the Public Road Reserve as the opposite side of the road is also unrestricted.
- The CTMP proposes partial closure of the road, providing a minimum 3m wide traffic lane when undertaking construction activities on the Public Road Reserve, and requires temporary 'No Parking' restrictions to be applied on the northern side of the road during the construction period.
- Palm Beach Road, Surf Road (off Barrenjoey Road) and Bynya Road (between Norma Road and Surf Road) are restricted to vehicles over 6m in length due to the winding road and narrow pavement widths. The Vehicle Movement Plan (VMP) requires that any heavy or long vehicle over 6m in length accessing the site approach from the southern end of Whale Beach Road off Barrenjoey Road.


- It is anticipated that the construction works will take approximately two years from August 2017 to June 2019.
- It is considered reasonable that the request be granted as the changes in 'No Parking' restrictions would enable the Developer to use the Road Reserve adjacent to the site to facilitate the work process, subject to obtaining any required permits from Council.



BACKGROUND

- Council has received a request from the Organisers acting on behalf of the Avalon Palm Beach Business Chamber, to hold the annual Avalon Market Day on Sunday 19 November 2017 with road closures from 5:00am till 7:00pm. This event attracts over 30,000 visitors to the area and is held annually with approval of the Traffic Committee.
- The Traffic Management Plan (TMP) for this event is included in Attachment 1, and as with previous years, the applicant will send copies to the Police, RMS, Ambulance, Fire Brigade, STA and Combined Taxis, subject to approval by the Traffic Committee. This matter is for the consideration by Council's Traffic Committee for a recommendation for support by Council.

CONSULTATION

The Traffic Management Plan (TMP) has been developed in consultation with the Organisers, RMS, the NSW Police and Council. The Traffic Management Plan for this event is attached for Traffic Committee consideration.

ISSUES

- The TMP is based on the TMP approved by the Traffic Committee for last year's Market Day; however, there has been a change to this year's event whereby an additional road closure in Old Barrenjoey Road is requested between Sanders Lane and Dress Circle Road in order to relocate the staging of the rides (previously held in the Avalon RSL and Bowling Green Lane Carpark) to the proposed closed section of Old Barrenjoey Road.
- The road closure is a similar closure used by the Avalon Public School, when holding their biennial School Fete, with a full road closure in Old Barrenjoey Road only extending along the length of the frontage of the public reserve. Old Barrenjoey Road is only to be closed to through traffic at Dress Circle Road and allow local resident access only.
- Access is provided around the closure with detours via Sanders Lane/Bellevue Avenue at the northern end; and Dress Circle Road/Bellevue Avenue at the southern end of the closure.
- As with previous years, the TMP proposes that 'No Stopping' restrictions apply in Central Road (south side) and Bellevue Avenue (both sides Avalon Parade to Sanders Lane) between 6:00am-5:00pm on the day of the event as a means of improving traffic safety and amenity for traffic moving around the actual market area (Avalon Shopping Centre).
- It is considered that restricting parking in these streets on Market Day will have a net safety improvement for the community, with increased parking available in the Avalon RSL and Bowling Green Lane Carpark for visitors attending the event.
- Support for the proposed road closures and parking restrictions by the Traffic Committee is required prior to Council granting approval for the proposed event to proceed.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the:

- A. Applicant be advised accordingly.
- B. Traffic Committee note this report.
- C. Traffic Committee supports the event taking place on Sunday 19 November 2017 using the Traffic Management Plan provided by the applicant for the Avalon Market Day, with road closures on the following streets (as indicated in the TMP attached) subject to approval by the RMS and Police:
 - Old Barrenjoey Road south of The Crescent
 - Old Barrenjoey Road north of Dress Circle Road
 - Old Barrenjoey Road north of The Crescent
 - Old Barrenjoey Road south of the Fire Station (at entrance to public carpark)
 - Wickham Lane at Avalon Parade
 - Avalon Parade west of Edmund Hock Avenue
 - Avalon Parade east of Bellevue Avenue
 - Simmonds Lane (Edmund Hock Avenue service way) at Old Barrenjoey Road
- D. Traffic Committee supports the implementation of temporary 'No Stopping' restrictions in Central Road (south side, full length) and Bellevue Avenue (both sides Avalon Parade to Sanders Lane) for one day only being 19 November 2017 (the day of the market) between the hours of 6:00am and 5:00pm.
- E. Approval would be subject to:
 - i. The TCP being prepared in accordance with the RMS Traffic Control at Work Sites Manual and Australian Standards.
 - ii. Any traffic control to only be carried out by persons with appropriate Traffic Control qualifications acceptable to the RMS.
 - iii. Barriers and signs to be used in the road closures are to be to RMS standards.
 - iv. The applicant obtaining the necessary approvals with respect to the use of the public reserves specified in the application and for the use of the public roads for stalls, etc.
 - v. The applicant advising Sydney Buses, Forest Coach Lines and the various emergency services of the closure.
 - vi. A minimum 4m wide lane being maintained to allow for emergency vehicles access.
 - vii. The temporary road closure being advertised in the Saturday edition of "The Manly Daily" the week prior to the event.
 - viii. Notification of the affected residents and businesses in the affected area be given by a letterbox drop two weeks in advance of the road closures with details of access restrictions, followed by a second letterbox drop one week prior to the event. The notification letter must also provide a contact phone number of the organisers should residents have any enquiries.

- ix. Variable Message Signs (VMS) being used in accordance with RMS guidelines to provide details of the road closure on the day of the event and also give information on upcoming changes to traffic conditions one week prior to the event.
- x. The organiser promoting the use of public transport (advising on route numbers and times) to the event in advertisings and publications to reduce car usage and traffic congestion on the surrounding road network.
- xi. The applicant obtaining the necessary RMS approvals with respect to any Traffic Management on the Main roads.
- F. Applicant be advised accordingly.

This document – Traffic and Transport Management Plan (TMP) aims to provide a plan for vehicular traffic and pedestrian control measures to assist in delivering safe logistical support of Avalon Beach Market event planned to take place at various locations, surrounding Avalon Beach on Sunday, 19/11/2017. The underlining objective is to minimise safety conflicts between vehicles and pedestrians and disruption to normal vehicular and pedestrian traffic on all approaches to Avalon Beach.

The objectives of this TMP are:

- To provide a high level description of the various traffic management elements needed to make the event a success
- Ensure effective separation between event patrons and participants from vehicular traffic
- To provide a framework for each agency to use to develop their own lower level plans
- To serve as the key document that is agreed to by all parties and is the final approval to conduct the event.
- · Minimise impact on non-event community and emergency services

Situation Analysis

On Sunday, 19/11/2017, there will be a Market Day at Avalon Beach, Avalon that will require altered traffic arrangements.

Road Closure at Avalon Pde, between Bellevue Ave & Barrenjoey Road, as well as Old Barrenjoey Road between The Crescent and north of exit driveway of the Woolworths supermarket for the Avalon Beach Market to take place.

It is anticipated in excess of 15,000 patrons are expected to attend the event throughout the day. Set up/ Bump in will occur at 5am Sunday morning. Event will start at 9am Sunday.

The partial road closures will be in effect from 8am to 4pm Sunday, 19/11/2017. Bump out will be between 4pm and 7pm.

Traffic Control measures included in this document is a result of consultation undertaken by Roobarb & Company Pty Ltd, RMS, NSW Police and Northern Beaches Council.

TRAFFIC ARRANGEMENTS

Traffic control measures include simple hard and soft road closures, use of traffic control devices (traffic signs) to warn motorist of the changes in traffic conditions. It is noted that per NSW Occupation Health & Safety (OHS) law the Event Organiser – Roobarb & Company and Land Owners – RMS, Northern Beaches Council bear individual and shared risks related to the safety of event patrons and motorist. Roobarb & Company Pty Ltd are identified as responsible for event related safety risks which are associated with non-transferable OHS statute-posed obligations and Common Law Duty of Care provisions. In this context, Roobarb & Company Pty Ltd should continue to actively consult and take all reasonable measures to practically exercise their duty of care obligations.

These traffic arrangements are detailed in Part 2.

Execution

General Outline

The event requires highly coordinated efforts from a number of agencies:

Roobarb & Company Pty Ltd

 Co-ordinates the logistics for holding the event, Venue Management / Event Production / Stage Management / Marshalling / Programming

Transport Management Centre & NSW Roads and Maritime Services

- Provides traffic information signposting as agreed to in the TMP.
- Monitor traffic on all roads approaching Barrenjoey Road, Mona Vale through TMC and on the ground to minimise traffic congestion on the day.

NSW Police

- Provide resources to manage road closures and point duty when required.
- Assists with the deployment of road closure and crowd control barriers when required

Northern Beaches Council

- Approves the event via the Local Traffic Committee and advises on or implements appropriate conditions to conduct the event
- Advertising for road closure locations, times and alternative route information in the Local News paper if required.

Road Closures

Avalon Parade to be closed between Bellevue Ave and Barrenjoey Road as well as Old Barrenjoey Road between The Crescent and north to exit driveway of the public car park adjacent to the Woolworths Supermarket.

The eastern barricade at Barrenjoey Road will be implemented so as to prevent traffic from turning off Barrenjoey Road into Avalon Parade while allowing traffic to turn onto Barrenjoey Road from Avalon Parade. A second eastern barricade will be implemented at Edmund Hock Ave. The second barricade will prevent all traffic from entering the market place with the exception of emergency service vehicles.

Minor Side Roads

Wickham Lane running between Sanders Lane & Avalon Parade will be closed at Avalon Parade. Wickham Lane will be accessible to local traffic: however, a detour sign will be displayed at the intersection of Sanders Lane.

Bellevue Avenue between Sanders Lane & Avalon Parade will be posted NO STOPPING along both side of the street.

Contingency Plans

Public Transport Management

Bus routes 191 and 192 have been amended by Sydney Buses to accommodate the road closures on the day of the event.

Event Signage

AAA Traffic Control will install advance notification and event signage per legislative requirements. This is outlined in the Traffic Control Plan document.

Community and Motorist notification

The Avalon Beach Market Day will be advertised through the local press and community radio. Included in the press releases and advertisements will be notification of the changes to local traffic conditions and road closures. A letter will be delivered to each residence within

the market day precinct advertising residents of the event and the restrictions placed on vehicular movements throughout the event.

Trailer Mounted VMS' will be in place one week prior to the event which will advertise the upcoming event to residents and motorists.

All roads within the event are governed by Northern Beaches/ Pittwater Council. However, due to the close proximity of the road closures to traffic signals and the event classification, Road Occupancy Licence(s) will be a necessity. The Traffic Control Company will impliment all temporary detour/ road closure signage for the purpose of notifying motorists.

Sensitive Places & Schools

Market Day does not fall on a gazetted school day, therefore no interruption to school activities are anticipated. There are no sensitive places including churches, prayer halls or kindergartens that will be affected by the Market Day activities.

Access – Local Residents, Business, Emergency vehicles

Local Resident and Business Access/ Parking

No local resident access throughout the event, only authorised personnel. Any vehicles found parked within the restricted parking areas while the event takes place will have a note placed under their wiper blade. The note will request the driver of the vehicle to contact a traffic controller to be escorted from the market place.

Emergency Vehicle Access

The road closures allow for emergency vehicle access. NSW Ambulance, Police and Fire Brigade will be informed of changed conditions by Roobarb & Company Pty Ltd.

Parking

In order to reduce congestion, Northern Beaches Council has recommended the implementation of street/ kerbside parking restrictions on Bellevue Street & Central Road. No stopping on the Eastern & Western sides of Bellevue Street, between Sanders Lane and Avalon Parade. The same restrictions will be implemented on the Southern side (Westbound lane) of Central Road between Barrenjoey Road and Avalon Road. Notification to residents within the Avalon Village will be in form of a letter detailing the parking restrictions on Central Avenue and Avalon Village. This notification letter will be undertaken by Avalon Beach Chamber of Commerce.

The nominated parking restriction is NO PARKING Sunday 19th November 2017. The time of the restrictions will commence at 05:00am on Sunday 19th November 2017 and shall remain in force until 7:00pm.

The traffic control company will be responsible for the installation and removal of the No Parking signage. The Central Road signage will be implemented on Saturday 18th November 2017 a day prior to the event.

Pedestrians

By implementing road closures and restricting parking within the Market Day area, we will provide a vehicle safe and hazard free environment for pedestrians.







BACKGROUND

- The Newport Public School has requested Council permit temporary road closures of Stuart Street and Queens Parade on Saturday 14 October 2017 in order to hold their biennial fundraising event.
- The Traffic Management Plan (TMP) for this event is included in Attachment 1.
- The temporary road closure for a School Fete has been approved every second year by Council following consideration by the Traffic Committee.

LOCATION

- Stuart Street is a local road and cul-de-sac with low volumes of traffic. There are two private residents with vehicular access to Stuart Street.
- Queens Parade (west) is a local road with a road pavement width of approximately 9.5m.
- The sections of Stuart Street and Queens Parade (west) under consideration are located within 40km/h School Zone.
- Newport Public School is located on the southern side of Queens Parade (west) with the driveway access off Stuart Street.
- Trafalgar Park is located on the northern side of Queens Parade (west) which also contains a 90 degree angle car park area.
- The Kalinya Street/Queens Parade Council car park is located at the western end of Queens Parade, near local shops and transport.

CONSULTATION

The School has consulted with the Police who have indicated support for the closure. The Traffic Management Plan for this event is attached for Traffic Committee consideration.

ISSUES

- A temporary road closure for Stuart Street has been approved in previous years, from the Queens Parade intersection to the southern end of the cul-de-sac.
- There has been a change to this year's event, the 'Newport Family Dash', with the inclusion of an inflatable obstacle course in Trafalgar Park with rides, stalls and entertainment on the school grounds.
- The event in Trafalgar Park requires the additional closure of Queens Parade, between Stuart Street and the Kalinya Street/Queens Parade car park, for pedestrian safety with between 1000 to 2000 people expected to attend the event throughout the day.
- Access for residents and emergency vehicles will be maintained at all times with the assistance of traffic controllers and detours in place for general traffic.

- The temporary road closures will be in effect from 6:00am till 3:00pm.
- It is considered reasonable that the temporary road closures of Stuart Street and Queens Parade be granted to allow the 'Newport Family Dash' to proceed and to ensure the safety of pedestrians moving to and from the school within the event area.

My client Newport Public School propose to close a section of Stuart Street between Queens Parade and the dead end leading to the school and also a section of Queens Parade between Stuart Street and Kalinya Street Newport for Newport Family Dash to take place which shall be run by Newport Public School.



All measures will be in place for approximately 9HR shift and are precautionary safety measures for the unlikely chance of incident.

A Traffic Control Plan (TCP) has been developed to ameliorate conditions whilst work is taking place. Short delays to motorists on the affected road is possible.



BACKGROUND

- The Avalon Public School has requested Council to permit a temporary closure of Old Barrenjoey Road adjacent to the school (south of Sanders Lane) on Sunday 10 September 2017 for their biennial fete, where they also use the public reserve on the opposite side of the road for amusement rides.
- The Traffic Management Plan for this event is attached and the applicant has sent copies to the Police.
- The temporary road closure for the School Fete is approved every second year by Council following consideration by the Traffic Committee.

LOCATION

- Old Barrenjoey Road is a collector road with a 50kph speed limit that serves as a secondary access route to the Avalon Shopping Centre from Barrenjoey Road.
- Bus services, including School Buses, which run along Old Barrenjoey Road do not operate on weekends.
- There are private residents south of the school property and public reserve that have vehicular access to Old Barrenjoey Road.

CONSULTATION

The School has consulted with the Police and provided a copy of the approval in support of the closure. The Traffic Management Plan for this event is attached for Traffic Committee consideration.

ISSUES

- A temporary road closure is proposed for Old Barrenjoey Road from Sanders Lane to Dress Circle Road. A full road closure in Barrenjoey Road can only extend along the length of the frontage of the public reserve. In order to preserve vehicular access to the properties, between the public reserve and Dress Circle Road, Old Barrenjoey Road is only to be closed to through traffic at Dress Circle Road and allow local resident access only.
- Convenient access is available around the closure via Avalon Parade and Dress Circle Road/Bellevue Avenue.



SUMMARY

To seek Traffic Committee approval for temporary road closures associated with Meet Your Street events.

BACKGROUND

Council has received applications for temporary road closures to facilitate "street parties" under the Council's "Meet Your Street" initiative. This program was initiated to support residents who wished to close their street for a few hours for a street party. These events are supported in view of the positive outcomes in terms of community building and fostering good neighbourly relations. Council assists residents by preparing and implementing a standard traffic control plan which has previously been approved for this type of event by the Traffic Committee. The requested locations for the temporary road closures are as follows:

- i. Francis Street, Fairlight (No.12 Griffiths Street to No.32 Francis Street) between Griffiths Street and Arthur Street on Sunday 3 December 2017 between the hours of 3:30pm and 7:30pm (This temporary road closure to utilise TCP No.1 as shown in the attachment).
- ii. Herbert Street, Manly (No.1 to 27) between Francis Street and Birkley Road on Saturday 2 December 2017 between the hours of 4:00pm to 8:00pm (This temporary road closure to utilise TCP No.1 as shown in the attachment).
- iii. Lodge Street, Balgowlah (No.15 to 29) between Condamine Street and Woodland Street on Sunday 9 December 2017 between the hours of 4:30pm and 8:00pm (This temporary road closure to utilise TCP No.1 as shown in the attachment).
- iv. Montauban Avenue, Seaforth (between Clontarf Street and Fromelles Avenue on Sunday 3 December 2017 between 11:00am and 3:00pm (This temporary road closure to utilise TCP No.1 as shown in the attachment).
- v. Edwin Street (full length) between Suwarrow Street and Daintrey Street on Saturday 9 December 2017 between 4:00pm and 8:00pm (This temporary road closure to utilise TCP No.1 as shown in the attachment).

ISSUES

The impacts on traffic resulting from the temporary road closures are expected to be minimal, for the following reasons:

- The roads function as local roads with low traffic volumes.
- There are no bus service routes that run along the requested road sections.
- Alternative routes are available for through traffic and connecting roads.

MEETING

- There have been no recorded accidents along these road sections within the last five (5) years.
- The temporary road closures are to be held on a Saturday or Sunday afternoon or evening when traffic impacts will be minimal and of a non-critical nature.

Access for pedestrians, cyclists and emergency vehicles will be maintained and the temporary road closure will be managed in accordance with the attached Traffic Control Plans (TCP) No.s 1 or 2 (as indicated). The standard street party conditions must also be adhered to in conjunction with the TCP, as outlined in attachment.

I. STANDARD TRAFFIC CONTROL PLAN (TCP)


A Traffic Control Plan, TCP, has been developed using the Roads & Maritime Service's (RMS) Traffic Control at Work Sites Manual. The TCP outlines the signs and barriers that are to be used, the erection and removal processes and other requirements. In addition to the TCP, additional requirements are necessary to facilitate the road closure safely and with minimal disruption to the public. The issues that require addressing include:

- Access to and from the street by resident's vehicles ONLY in an emergency and emergency vehicle
- Traffic controllers need to be qualified.
- Appropriate erection and removal of traffic control devices.
- Adequate notification
- These issues are addressed in the conditions



NOTES:

- 1. All persons working on road must wear visibility vests or jackets as specified in the RTA's OH&S manual.
- 2. All signs must be approved Australian Standard Signs appropriate for right use.
- 3. The temporary road closure should be carried out in conjunction with the attached conditions and requirements.



II. STANDARD CONDITIONS

Resident Street Party Organiser will be responsible for:

- 1. That resident street party organiser shall submit a completed application form to Council at least 4 weeks prior to the event.
- 2. That resident street party organiser shall undertake a letterbox drop minimum two weeks prior to the event. The letter shall include that:
 - the proposed date and time of the street party
 - residents participate at their own risk
 - Access to and from the street by resident's vehicles ONLY in an emergency and emergency vehicles
 - A contact name and contact details for residents to communicate any objections to the road closure
 - A copy of the letter is to be provided to Council
- 3. One week in advance of the event the street party organiser will provide a statement to Council notifying that not more than 25% of the residents oppose the street party.
- The resident street party organiser shall notify the Traffic Sergeant at the Manly Police Station to confirm that the street party will be going ahead on the proposed date.
- 5. The resident street party organiser shall ensure that noise is kept at an acceptable level and that it does not inconvenience the neighbouring community.
- 6. The resident street party organiser shall ensure that all rubbish is removed from the site at the completion of the street party.
- 7. The resident street party organiser shall notify all emergency service authorities.

Council's Events Team will be responsible for:

- 1. Ensuring the resident street party organiser has completed the induction and has lodged the application form and understands the conditions to conduct the event.
- 2. The implementation of the Traffic Management Plan (TMP) and ensuring the Closure and Road Opening is undertaken by qualified and certified people.
- 3. The road closure points are controlled by qualified and certified people for the duration of the event. This will involve engaging an external contractor to man the road closure barricades for the duration of the event. The estimated cost to Council to facilitate this is \$600 per street party, based on a four hour minimum.
- 4. The street party being restricted to local streets only (not collector, regional or state roads) in a very low traffic environment such as a dead-end or cul-de-sac (consult Council's Traffic and Transport section).
- 5. The street party shall be limited to not more than 100 people at any given time during the duration of the event.
- 6. Ensuring the applicant has obtained the concurrence from the Police.
- 7. Completing a risk management plan for each street party application and submitting this to Council's Insurers to confirm cover for event
- 8. The funding and coordinating of promotion of program and supply amenities/infrastructure to the street party including road closure barricades/signage, bins and portable toilets within approved budget.

Council's Traffic Management Team will be responsible for:

- 1. Advising the Events Team if a street is deemed suitable for temporary road closures.
- 2. Preparing the TCP and submitting to Council for approval. The TCP will indicate the recommended signage to be used to ensure traffic is managed effectively with minimum disruption.



Additional Terms and Conditions:

- 1. Street parties should be of a maximum four hours in duration and should be held during daylight hours only.
- 2. If a street party organiser fails to adhere to the terms and conditions set out in the letter of consent that Council have the discretion to fine the street party organiser up to a maximum of \$500. E.g. if the street party organiser extends the duration of the party or exceeds the maximum numbers permitted at the party.
