#### 3.2 VISION AND PURPOSE OF TRANSPORT & TRAVEL FOR NORTHERN BEACHES

Councillor Sarah Grattan addressed the group on this item.

The "Northern Beaches Goals for Transport & Travel" presentation was presented to the group (Attachment 1). The group participated in a discussion about key user groups on the Northern Beaches and their mobility needs. The needs identified are below:

Key User Group	Mobility Needs	
Commuters	Fast, reliable, bus lanes, "blue highway", consistency, easy, on-demand and active travel.	
Business (Freight and Services)	Parking management for on-street and loading zones, priority parking, online shopping delivery services.	
School Kids	Safety, parking for P-Platers, specific times, return trips for parents if accompanying children on a bus, staggering school start times, active transport solutions and exclusion zones around schools.	
Local Economy	On-street parking management, smaller buses, grouping of services together, land-use planning and bike parking.	
All Residents – Elders, Youth, Families, Disabilities, Other	Flexibility, accessible and timely.	
Cyclists and Commuter Cyclists	Shared paths, all ages permitted to cycle on the footpath, helmet laws, shoulder lanes replaced with separated cycle lanes for increased safety.	

It was noted that there has been a 30% increase in bus patronage since the B-Line was introduced. The group discussed the factors that have resulted in this increase.

Ben Taylor and Mayor Michael Regan provided an update regarding the East/West public transport solutions such as Dee Why to Chatswood and Mona Vale to Macquarie Park.





Historically we (traffic engineers) have been very reactive in the nature of what we do.


As the Transport Network team we have a wide brief to provide a more strategic focus and be more proactive.

## Objectives of MOVE

**MOVE** – The Northern Beaches Transport Strategy provides an integrated transport network for the Northern Beaches

- A clear framework for developing links with Council's future Delivery Program and Operational Plans.
- Advocate to NSW and Federal Government to develop realistic and achievable transport options.
- Engage with the community to ensure the strategy reflects the current and future needs of the community.
- Partner with our neighbouring Councils as stakeholders including Mosman, North Sydney, Ku-ring-gai and Willoughby and Ryde.

## The Discussion Paper

- Designed to stimulate the conversation with our community regarding all aspects of transport
- Public discussion paper in late March The paper is designed to be somewhat provocative
- Aimed at drawing out the community feeling in relation to all public transport options including bus, rail, light rail options. (noting relationship with potential future density)

# Planned Community Engagement Discussion Paper

- Public workshop in each ward
- Opportunity for Councillor involvement in this process
- Pop up engagement at local shops, venues, and events
- Your say page and social media campaigns



### Milestones for MOVE

- Early April 2018 Community Discussion paper and engagement commences
- 5 April 2018 Presentation to the Strategic Reference Group
- April 2018 Stakeholder Engagement State Government Agencies, Providers, and Adjoining Councils
- June 2018 Draft Strategy endorsed by Council for exhibition
- June to Mid July 2018 Public Engagement on Draft Strategy
- 25 September 2018 Final Strategy adopted by Council

- The SRG Transport and Travel over view of the process and alignment with the CSP goals.
- Adding value to the process with specialist/community input throughout the development.
- The project team will report back to the SRG on progress of the strategy development, engagement, and the SRG will provide a long term focused feedback to the project team.
