4.1 SOUTH CREEK ROAD (CROMER PARK), CROMER - PARKING RESTRICTIONS

PROCEEDINGS IN BRIEF

The Committee concurred with the recommendation.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports:

- A. The relocation of the 'No Stopping' signs in accordance with Roads and Maritime Services Technical Direction around the pedestrian crossing on South Creek Road in front of Cromer High School, Cromer.
- B. The installation of 'No Parking' signs either side of the driveway at 101 South Creek Road and two exits of Cromer Park Carpark, Cromer.

4.2 JUBILEE AVENUE, WARRIEWOOD - PARKING RESTRICTIONS

That the Traffic Committee supports the installation of No Stopping unbroken yellow lines along both sides of the access road from the turnaround area on Jubilee Avenue to the southern end of the bridge across Narrabeen Creek, Warriewood.

4.3 PACIFIC PARADE, DEE WHY - TIMED PARKING

PROCEEDINGS IN BRIEF

The Committee concurred with the recommendation.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports:

- A. The replacement of 1P 8:30am–6:30pm Mon-Fri, 8:30am-12:30pm Sat with a Loading Zone 8:30am-6pm Mon-Fri, 1/4P 8:30am-6:00pm Sat-Sun for 6m and 1/4P 8:30am-6:00pm Everyday for next 18m on the north side of Pacific Parade, Dee Why.
- B. The replacement of 1P 8:30am-6:30pm Sat-Sun with 1/4P 8:30-6:00pm Sat-Sun on the south side of Pacific Parade near the Pittwater Road/Pacific Parade intersection, Dee Why.

4.4 MADISON WAY, ALLAMBIE HEIGHTS - NO STOPPING RESTRICTIONS AND DIVINDING BARRIER LINE

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports:

- A. The installation of Dividing barrier lines on Madison Way, Allambie Heights.
- B. The Installation of No Stopping unbroken yellow lines at the intersection of Madison Way, Allambie Heights.

4.5 LANE COVE ROAD / INGLESIDE ROAD / BORONIA ROAD / LAUREL ROAD WEST, INGLESIDE - INTERSECTION IMPROVEMENTS

PROCEEDINGS IN BRIEF

The Committee concurred with the recommendation.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports:

- A. The installation of a Stop Sign and Holding Line at the intersection of Lane Cove Road and Ingleside Road, Ingleside.
- B. The installation of Dividing barrier lines (two way) at Ingleside Road on the approach to the intersection of Lane Cove Road and Ingleside Road, Ingleside.
- C. The installation of a Stop Sign and Holding Line at the intersection of Boronia Road and Ingleside Road, Ingleside.
- D. The installation of a Give Way Sign and Holding Line at the intersection of Boronia Road and Laurel Road West, Ingleside.
- E. The installation of flexible guideposts with delineators on the eastern side of Boronia Road and northern side of Laurel Road west, Ingleside.

4.6 CAREEL HEAD ROAD, AVALON BEACH - BUS ZONE RESTRICTIONS

PROCEEDINGS IN BRIEF

The Committee concurred with the recommendation.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the installation of Bus Zone signs for the E88 terminus located in Careel Head Road (near the intersection with Burrawong Road), Avalon Beach, to clearly indicate the extent of the Bus Zone and to improve bus stop accessibility.

4.7 ALLAMBIE ROAD, FRENCHS FOREST - BUS STOP RELOCATION

PROCEEDINGS IN BRIEF

The Committee concurred with the recommendation.

RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the relocation of the existing bus stop terminal for the 142 and E66 routes (opposite the Skyline Shops in Frenchs Forest Road East) to a new location south of the driveway to No.191 Allambie Road, Frenchs Forest.

4.8 SEAVIEW AVE, NEWPORT - NO PARKING RESTRICTIONS

That the Traffic Committee supports the installation of 'No Parking 7:00am-10:00am Mon-Fri' restrictions in Seaview Avenue (western side), Newport, from the driveway of No.26 to the location 18m north of the driveway of No.36.

S.1 BIMBADEEN CRESCENT, FRENCHS FOREST - TEMPORARY PARKING RESTRICTIONS

- A. The temporary installation of 3P 6:00am-6:00pm Mon-Sat on both sides of the Patanga Road, between Frenches Forest Road East and Dareen Street, Frenchs Forest, until the construction is finished.
- B. The temporary closure of the Bus Stop in front of Patanga Park, Frenchs Forest, until the construction is finished.
