Minutes of the Meeting of the Narrabeen Lagoon State Park Advisory Committee held on Tuesday, 12 June, 2018 in the Flannel Flower, Civic Centre, Dee Why, commencing at 4:00 pm.

1 Attendance

Meeting opened at 4:11pm.

2 Confirmation of minutes

The minutes of the meeting held 12 April 2017 were confirmed by Conny Harris, and seconded by Todd Dickinson, however it the absence of a quorum the minutes were noted rather than confirmed.

3 Matters arising from previous minutes

3.1 Proposed site inspection / tour

Conny Harris gave an update of her 'catchment traverse', a four hour walk taking in sites around the catchment. She is leading a public walk on 12 August but is prepared to lead a walk especially for members of the NLSPAC, either a bush walk showcasing the features of the catchment or a walk to visit problem sites. Tuesday 31 July or Tuesday 7 August were suggested. Ilana Waldman suggested that she would invite the MLALC to attend.

ACTION: Council to circulate date options for members to respond to.

3.2 Minutes to Council's website

Draft minutes now go onto the website following review and agreement by committee members. The minutes of the last meeting are on the website, as is the annual report.

RECOMMENDATION: That the Advisory Committee note this information.

3.3 Potential further expansion of State Park

There are no current plans for expansion of the State Park. None of the land within the catchment that is owned by State agencies can be included at this stage. Crown Lands and MLALC are involved in a formal process to address unresolved land claims for the entire northern beaches area. Once this process is complete there may be scope for further review of the reserves making up the State Park.

RECOMMENDATION: That the Advisory Committee note this information.

3.4 Discussion on the future direction of the State Park

This item was deferred until after Item 4.1 when a quorum was present. The Advisory Committee has met the goals set for it by the former Administrator. It has assisted with the expansion of the State Park, developed a decision support tool and provided feedback on the initial direction of the State Park. To maintain its relevance, the committee needs to redefine its role and identify the issues it should now focus on.

The Committee provided feedback on issues/opportunities and gave suggestions for how a new Committee focus could address these issues. The following new Committee Objectives were identified as a result:

- To act as a key advisory group for prioritising and informing strategic initiatives that relate to the State Park
- To advise on annual priorities in the Delivery Plan
- To act as a reference group on strategic matters impacting on the State Park including:
 - o Environmental management
 - Strategic land use planning;
 - Land tenure issues;
 - o Entrance management and floodplain management strategies;
 - o Bushfire management activities.
- To assist in developing a Plan of Management for Narrabeen Lagoon State Park (within 3 years, by request of DOI Lands).
- To assist in resolving conflicts between different types of community uses affecting the State Park.

It was noted that Council could apply for funding under the Crown Reserve Improvement Fund (CRIF) to prepare the Plan of Management.

RECOMMENDATION: That the Terms of Reference be updated to reflect the roles identified by the committee.

ACTION: Staff to update Terms of Reference to reflect the new objectives and purpose of the Advisory Committee and circulate to committee members for their endorsement.

4 Reports to Committee

4.1 Overview of the Open Space Strategy

Damian Ham gave a presentation on Northern Beaches Open Space Strategy (see attached).

The Open Space Strategy will guide long term development and management of open spaces within the LGA. It will link with Plans of Management and the open space strategies of former councils.

Council will be seeking community input into the Strategy. As part of this, a workshop with the Advisory Committee will be held later this year, date to be advised. Input will be sought on issues such as management of recreation trails in the catchment and recreational use of the lagoon waterbody.

The Chair attended the meeting at 4:30 and a quorum was achieved.

RECOMMENDATION: That the Advisory Committee note this information.

4.2 Recreational Trails

Jeremy Smith gave a presentation on recreational trails within the State Park (see attached).

The section of the Narrabeen Lagoon track that runs close to the Wakehurst Parkway is currently presenting an unacceptable safety hazard, due to both its proximity to the road and the number of people using the track (up to 4,000 bikes and 2,500 pedestrians per day).

Detailed environmental investigations have taken place and the option with least environmental impact is to construct an aquatic boardwalk in this section and to restore the current trail area to natural bushland. Design features that minimise the environmental and visual impact of the boardwalk include the materials to be used for the boardwalk; location of the boardwalk; colour and profile of the boardwalk; and the configuration of the approaches on and off the boardwalk.

An update was also given on a pedestrian bridge over the lagoon on the Pittwater Road bridge.

RECOMMENDATION: That the Advisory Committee note this information.

4.3 Floodplain Risk Management and Planning

John Heptonstall gave a presentation (see attached).

The lagoon has flooded on many occasions in recent times, due to either runoff from the catchment, storm surge from the ocean or a combination of both (as happened in June 2016). The flood level in June 2016 was similar to the flood level on at least four other occasions since 1942.

The Narrabeen Lagoon Floodplain Risk Management Study is nearing completion and has investigated options including: entrance management options; location specific levees; drainage upgrades; amendments to Ocean Street Bridge; upgrades to Flood Warning Systems; and flood awareness campaigns. The draft report will be presented to the Northern Beaches Flood Committee in July before being presented to council for public exhibition. A Community Consultation phase will follow and allow for feedback on the options.

The Wakehurst Parkway flood mitigation project is investigating mitigation options for very frequent floods (those that occur several times per year). Initial studies have included survey, ecology and sediment analysis. Modelling of different scenarios is being undertaken, with the feasibility study to be completed by the end of 2018. Design of the recommended option is likely to be completed by late 2019.

The Chair left the meeting at 5:15pm, resulting in the loss of the quorum.

In relation to managing the flood risk in Narrabeen Lagoon, staff have access to real time measurements of lagoon water levels. In addition, a real time predictive model has been developed to allow staff to better estimate the lagoon levels and timing of these levels following rainfall. This allows for better emergency response planning. This model takes into account current and predicted rainfall, actual rainfall, tide levels, entrance wave height and wave direction. As well, Council is developing processes with State Emergency Service, Office of Environment and Heritage and Bureau of

Meteorology (BoM) to be compatible with the BoM Flash Flood Warning Guidelines (FLARE).

RECOMMENDATION: That the Advisory Committee note this information.

4.4 Overview of progress with Ingleside development

Liza Cordoba gave a presentation (see attached).

Approximately 1/3 of the Ingleside precinct site is within the catchment of Narrabeen Lagoon. The Ingleside Precinct Plan aims to be a sustainable development, with 'biocertification' and above BASIX standards to be applied. In particular, the development of the area will need to ensure it deals with the potential flooding of areas below the site such as Warriewood Valley, Bayview and Narrabeen.

Strategic bush fire risk assessment is also being undertaken and will be important for the layout of the area. It is expected that the Minister will publically exhibit the Draft Planning Package later in 2018.

RECOMMENDATION: That the Advisory Committee note this information.




