# 4.0 AGENDA ITEMS

# 4.1 ARTS AND CREATIVITY STRATEGY - COMMUNITY ENGAGEMENT UPDATE

The following points were discussed:

- The 'Creative Champions' will be used as a sounding board during torchlight Sessions (focus groups). They will not be a decision making body and will be selected by staff in conjunction with consultants.
- Some members noted that 'Creative Champions' may not be the right title for the group.

# 4.2 CREATIVE ARTS SPACE - NORTH

Alicia Terry presented on this item. Members discussed the importance of the following when deciding on a site for the Creative Arts Space - North:

- Accessibility by public transport
- Visibility from road or village centre
- Council could utilise the surrounding areas of any site chosen, this could be through external sculptures

The report is anticipated to go to the September Council Meeting and go on Public Exhibition if adopted by Council.

# 4.3 COMMUNITY CENTRE STRATEGY

Caroline Psaltis introduced the consultants from TAP Consulting, Thao Ashford and Christie Kahukiwa, who have been engaged by Council for the Community Centre Strategy.

Both Council and the Consultants acknowledged that the network extends further than Council operated buildings and there are other service providers in the LGA. These include Surf Life Saving Clubs and Scout Halls.

The members discussed current fees and charges, these are set by Council and are reviewed annually. Council has recently conducted a major review, as a result of amalgamation there were discrepancies. These changes will come into effect at 1 January 2019. Council noted that if fees and charges are a key theme in submissions and feedback for the strategy these may be further reviewed.

All users of the Community Centres will have an opportunity to contribute specifically through an online survey which will be sent out to all users.

The Group participated in a various activities with the consultants.

# 5.0 UPDATE ON ACTIONS FROM LAST MEETING

Kylie Walshe provided an update on the following items:

- The Mona Vale Performance Space feasibility study has been finalised and will go to the Advisory Group at the end of August. It will then go to the October Council Meeting.
- Northern Beaches Coast Walk (formerly Coast Walkway) will encompass all features including public art elements. There has been a lot of community engagement over the past two months. Council is waiting on the Engagement Report.
- Outcome of action relating to State Transit Authority: Yes there are accessible buses, however, this is not necessarily the B-Line.
