3.1 NOTES OF COMMUNITY SAFETY STRATEGIC REFERENCE GROUP HELD 6 APRIL 2017

5.0 UPDATE ON ACTIONS FROM LAST MEETING

Mick Darda provided a response to questions which were taken on notice at last Community Safety SRG meeting.

- **Community Strategic Plan** The suggestions provided by the Community Safety Strategic Reference Group was taken under consideration and it was amended to include the word safety in various areas however majority of the safety issues will be addressed in the directions paper which focuses on these particular matters.
- **Community Safety SRG to continue** A timeline has been prepared and has been approved by EMT. The frequency of the meetings will be addressed in due course.
- Additional Agenda Items Aggressive bedding and hotspots will be addressed in General Business
- A copy of the CDAT campaign was forwarded to Susan Watson.

4.0 AGENDA ITEMS

4.1 COMMUNITY SAFETY SRG DIRECTIONS PAPER - WORKSHOP

DISCUSSION

Leanne Martin, Coordinator, Community Safety addressed the Group on this item.

All SRG asked to put together a directions paper as a result of the meetings.

Three main goals were addressed as being highly important:

• **Public Spaces** – To create safe public spaces which contribute to social inclusions.



- **Late night safety** To actively manage vibrant entertainment precincts which encourage safe, social interactions.
- **Community wellbeing and safety** To support the health and wellbeing of community through collaborative partnerships.

The group participated in a workshop to identify the objectives as Low, Medium or High. A copy of the results are attached to the Meeting Notes as **Attachment 1.** The results will help us better define what is contained in the directions paper and assist the new Council moving forward.

The group were provided with an update on a proposal to establish a Northern Beaches Council Community Safety Joint Stakeholder Advisory Committee prior to the Council Election. The group participated in a discussion to confirm the proposed Terms of Reference which will be reported to Council in an Administrators Minute on the 27 June. If the item is endorsed, the document will be placed on public exhibition prior to being reported to the Extraordinary meeting on 8 August which and be endorsed by the Administrator at the last meeting prior to the new Council. A copy of the Terms of Reference is attached to the meeting notes as **Attachment 2**.

6.0 GENERAL BUSINES

Dave Darcy, NSW Police - NB LAC provided an update to the group on items they are working on to assist residents of the Northern Beaches Local Government Area:

- 1. **Installation of Bollards** Following a review of the 2017 ANZAC celebrations at DY, the NB Police Command and the NBC Chief Executive Officer are in discussion surrounding the installation of bollards for the safety of the community.
- Probation and Parole Probation and Parole has now been removed from the Northern Beaches and offenders will either be transferred to now taken to temporary accommodation at St Leonards or Hornsby. There are concerns raised if they don't comply and if there was a Safety Committee for the Northern Beaches Council, would suggest that we to the Minister expressing our concerns and impacts on the area.

3. **Suicide** – Suicide numbers are rising again in this area with Police making every effort to save and prevent people from jumping off cliffs. David Darcy has scheduled a meeting with the Coroner to review the hotspot areas and key jumping points. Currently the most popular areas are the Catholic Church at Shelley Beach and Fairfax Walk, North Head. Whilst there has been precautions put in place, residents simply find new places to jump.

NOTE: David Darcy, NSW Police - NB left the meeting at 6.38pm and did not return.

4.2 EXHIBITION OF ALCOHOL FREE ZONES - UPDATE

DISCUSSION

Sue Johansson, Coordinator – Community Safety addressed the Group on this item. A copy of the presentation provided to the group is attached to the Meeting Notes as **Attachment 3**.

Leanne Martin provided an update to the Reference Group on the CDAT Project that Council is working with Health Promotion, Northern Beaches Sydney Local Health District and how the message will be delivered to youth coming of age and permitted to purchase alcohol and entry to pubs and clubs. A copy of the presentation is attached to the Meeting Notes as **Attachment 4**.

DISCUSSION

On 28 February 2017, Council resolved to commence a public exhibition period for reestablishment of alcohol free zones in the former Warringah local government area. By reestablishing Alcohol Free Zones, Council can assist the Police in controlling anti-social behaviour related to alcohol consumption. Alcohol Free Zones can apply to public roads, footpaths and car parks.

The community was consulted during March and April 2017 regarding reinstating alcohol free zones at:

- Dee Why Pittwater Road
- Narrabeen Pittwater Road
- Belrose Frenchs Forest
- Forestville Shopping Centre
- Collaroy Pittwater Road
- Cromer Community Centre
- Warringah Mall Bus Stops
- Dee Why Walter Gors Park

Roles and Objectives

To collaborate, consider and advise Council on ways to improve, resolve and progress issues that impact on community safety and place management including the following:

- Safety issues such as the security of open spaces, street lighting and transport
- Management of Late Night Entertainment precincts.
- Collaborative approaches to community safety and crime reduction, prevention and detection initiatives.
- Address alcohol related crime and anti-social behaviour in communities
- Address and audit local crime hot spots
- Public space management issues
- Homelessness/rough sleeping issues
- Monitoring of official Crime Statistics
- Major Events
- Major development applications that may require CPTED evaluation
- Relevant grant funding applications
- Community safety promotion and education


COUNCIL NIGHT RANGERS (MANLY) STAFF Staff include security, venue staff, bartenders and bouncers.

CCTV

CCTV is a security network which monitors entertainment precincts and liaises with police to prevent crime.

VENUE + POLICE LATE NIGHT RADIO

Venue + Police Late night Radio is a security network which monitors entertainment precincts and liaises with police to prevent crime.



DID YOU KNOW?

Drinking in adolescence can be harmful to young people's physical development, particularly brain development. Adolescence is a critical period in a young person's development towards adulthood. Alcohol consumption during this time can bring about learning difficulties, memory problems and other problems later in life.

YOUR BEHAVIOURS HAVE CONSEQUENCES

Consuming or in possession of alcohol in an alcohol free zone	Mimimum \$X fine of your choice program
Supplying liquor to a minor (persons under 18 years of age)	\$1,100
Fail to leave licensed premises/vicinity	\$550
Refuse/fail to comply with direction	\$220
Offensive behaviour (urinating in public)	\$500
Offensive language	\$500
Continue intoxicated behaviour after move on direction	\$1,100
Minor use false evidence of age document	\$220
Give or lend proof of age card to be used by another	\$330 + 6 months your provisional licence
Fail to pay taxi fare	\$300
Driving under the influence of alcohol or another drug	Serious consequences apply
Assaults	Serious consequences apply
Malicious damage to property	Serious consequences apply
Refuse or fail to state full name address and date of birth	\$220



Taking a drink from home or travelling with open containers of alcohol is not permitted on buses or in certain locations signposted as an 'Alcohol Free Zone' or an 'Alcohol Prohibited Area' (e.g Manly, Dee Why, Newport and Mona Vale). The Police may ask you to pour the alcohol out from the bottle or issue you a fine.

WHAT CAN BE ON YOUR

POLICE RECORD

Warnings are recorded

All police can access your record

BUYING ALCOHOL FOR

Here's your drink, it cost me \$1,100.

STOP the supply of alcohol to minors.

SUPPLYING ALCOHOL TO MINORS

Secondary Supply of alcohol to a person under 18 years is against the law and results in a minimum on the spot fine of \$1,100 or fine of up to \$11,000 and/or 12 months imprisonment. NSW Liquor Act 2007

WHAT IS IT?

Where a troublesome patron refuses to leave a licensed venue when asked by staff, the patron commits an offence.

WHAT DOES IT LOOK LIKE?

Grounds for ejection include the patron being intoxicated, violent, quarrelsome, disorderly, smoking, or using or possessing prohibited drugs.

WHAT IS THE CONSEQUENCE?

Offenders face an on-the-spot fine of \$550 for each offence and maximum court fines of \$5,500.

R U OVER IT?





Blood Alcohol Concentration increases with consumption and this correlation can be different depending on the person.

Count your drinks. This will then tell you how long it is before you can drive.



Don't drink more than one or two drinks if you know you have to drive the next morning.

BE PUB AND CLUB



Talking to venue staff if you have a problem

- Leaving the venue if you have been asked by security
- Sorting out your transport home (including a Plan B)
 - Reading the standard drink guide
 - Drinking water it is free and available at the bar

Eating a meal before you consume alcohol



- × Drinking alcohol excessively
- > Buying alcohol for intoxicated friends
- 🗴 Pre-drinking
- × Harassing other patrons
- Leaving your mates at the venue if they are intoxicated
- × Accepting drinks from strangers
- 🗴 Leaving drinks unattended



Make sure you plan your trip home from your night out, whether via a designated driver or through a variety of public transport or private transport options.

TripView App

- Real time information on buses, trains and ferry services.
- TripView Lite version available for free download.

Bus Services

- All major hubs: Manly, Dee Why, Mona Vale and Newport are connected through a bus service, including night-time services.

PRIVATE TRANSPORT OPTIONS:

Taxi / Uber

- Sharing a private ride home with a mate is a good way to lower the cost of your ride home!
- Anly, Dee Why and Mona Vale have dedicated taxi ranks that make it easy to always secure a safe ride home.
- Uber allows you to book and see driver details ahead of time, split the fare with friends and share your trip home safely with mates.

Safety tips if you decide to ride via Taxi/Uber:



Once your driver has picked you up share your ETA with your friends and family so they can follow your route and know when to expect you.

Sit in the back seat.



If you're riding with Uber, you'll see their name, license plate number, photo and rating so you'll know who is picking you up ahead of time.

Shuttle Bus

The Newport offers a courtesy shuttle bus loop that operates midday – 11:15pm, Friday through Sunday. There is an Avalon/Newport loop and a Manly/Dee Why/Warriewood loop.

WATCH YOUR MATES:

Make sure you and your designated mate are always together, watch what they're drinking and if they disappear checkup on them.



IMPORTANT DIGITS:

Always have a number ready to call in case of an emergency; this could be a parent or a friend who isn't out with you that you can call on to help.

NEED SERIOUS HELP:

Contact 000 if you urgently need police or an ambulance. Don't hesitate to call the ambulance just because you are worried that there may be drugs involved. You won't get in trouble.



Stick together with your friends, making sure not to leave anyone behind, and help friends who are in trouble. Make sure everyone gets home safe.

📮 PLAN AHEAD:

Think about how you're going to get home. Avoid walking home alone. Bring your designated mate with you or walk with a group of friends. Consider catching a bus, Uber or taxi.
