4.1 COMMUNITY STRATEGIC PLAN DEVELOPMENT WORKSHOP – KATE LEWIS

DISCUSSION

4.2 YOUNG PEOPLE'S CONNECTION AND PARTICPATION IN RECREATIONAL ACTIVITIES – SUZI PAWLEY

DISCUSSION

Suzie congratulated member, Olivia Murray, on receiving the 2017 Outstanding Community Services Award at Northern Beaches Council Australia Day Ceremony.

Olivia has been a volunteer with Council helping organise and run Youth & Families events, as well as other valuable volunteering roles.

S Pawley distributed a handout and then gave members time to review before the workshop.

Members then discussed the recreational needs of young people and noted the following recreational opportunities.

- challenges exist around raising awareness about the kinds of things that are available to participate in and venues for activities to take place
- challenges for the community around how they find services, and how do they differentiate between the services, who's doing what
- promotion is most likely to happen through social media platforms and word of mouth
- potential opportunities exist for collaborative projects between local government, nongovernment organisations (NGO's) and businesses. Opportunities also exist for parents to play a role in creating opportunities, and linking their young people with community activities
- suggested activities / projects were for the 18+ aged young people who are no longer linked with the school community, and transition to life programs, eg. employment, life skills
- Council's role can include coordinating and/or assisting community engagement, connecting the community with activities,
- finding solutions through consultation, and running events and activities.
- NOTE: Kylie Ferguson, asked members to give an opinion of the Northern Beaches Website and the members advised that it wasn't user friendly.

4.3 HOMELESSNESS AND HOUSING AFFORDABILITY - SUZI PAWLEY

DISCUSSION

Suzie Pawley gave a PowerPoint presented on Homelessness/Affordable Housing.

Members then discussed homelessness and affordable housing and the difference between the two.

Members also discussed the recent community discussions around local boarding house development applications, affordable housing considerations for Frenchs Forest and Ingleside development plans.

S Pawley advised that the prevention of homelessness was more than building more houses.

There was also discussion about support services for people experiencing homelessness and what early intervention strategies were available for people at risk.

Members also questioned how people were going to be able to supported once they have the accommodation.

Julie Action – Program Manager, Mission Australia, Northern Sydney Youth Homelessness Service gave a presentation which highlighted the Challenges and opportunities available to youth

- School counsellors
- Student-run campaigns

EXECUTIVE SUMMARY

PURPOSE

To provide information to the Youth Strategic Reference Group to inform discussion concerning transport issues and young people on the Northern Beaches.

REPORT

Transport is essential within every community, providing access to services, facilities, environments, various social networks, activities and events.

Access to efficient, affordable and timely public transport impacts the Northern Beaches community due to the isolating nature of the geography of the peninsula. However, young people, who may not have access to private modes of transport due to their age or for financial reasons are more heavily reliant on public transport than others.

The issues that young people face in accessing transport have been acknowledged in various Council plans and documents, including the former Pittwater Social Plan 2012-2016, the former Warringah Youth Strategy 2013-2023 and the former Manly Youth Strategy 2014.

The Pittwater Social Plan 2012-2016 identified that young people are reliant on public transport for a number of reasons including: getting around the Northern Beaches; establishing and maintaining social interactions and networks; and accessing services and facilities. This plan suggested that access to public transport was particularly more difficult for young people in the Pittwater area; however it was acknowledged that young people across the Northern Beaches also experience difficulty.

Public transport on the Northern Beaches mainly resides on 'trunk routes' or main roads, such as Pittwater Road, Warringah Road and Barrenjoey Road. The roads outside of these main thoroughfares, called 'feeder routes', are not as well serviced and therefore present problems for young people who cannot easily access the main routes (Pittwater Social Plan 2012-2016).

During the consultation for the Manly Youth Strategy 2014, young people in Manly also expressed their concern with a lack of appropriate transport in their area. Their main concern was access to the Manly CBD as it is a hub for young people offering a variety of recreational and social opportunities. Young people expressed that they like to travel into Manly and are likely to stay for an extended period of time with their friends; however they have difficulty in accessing appropriate transport that suits their needs (Manly Youth Strategy 2014).

The negative consequences of poor access to public transport for young people include disengagement from social networks and support services, lack of access to education, particularly tertiary education and increased difficulty in accessing employment (Pittwater Social Plan 2012-2016).

EXECUTIVE SUMMARY

PURPOSE

This workshop will build upon the work to date of the Youth Strategic Reference Group (SRG) on issues and priorities affecting young people on the Northern Beaches.

REPORT

The Youth SRG has had a number of opportunities to identify the key issues and priorities for young people, which have informed the development of the Draft Community Strategic Plan.

In addition to these engagement exercises, members of the SRG have extended their current knowledge on housing and recreation in relation to young people on the Northern Beaches.

The workshop will build upon the body of work developed to date to create a paper on the 'Key Issues for Young People.' It is anticipated that this paper will provide a resource to inform the incoming Council in September 2017.

The Draft Community Strategic Plan is a high level, strategic document and it can therefore be difficult to identify the detail behind the key issues and priorities and how these can be addressed. The 'Key Issues for Young People' paper will provide a layer of detail and information for the community and the Council around the various challenges young people may encounter living on the Northern Beaches and explore opportunities to address these.

RECOMMENDATION OF EXECUTIVE MANAGER COMMUNITY SERVICES

That a workshop is conducted on April 27 with the Youth SRG to review and build on the work conducted to date on the key issues and priorities for young people on the Northern Beaches. This workshop will contribute to the development of a paper on "Key Issues for Young People" to inform the incoming Council.

ISSUE

Update on the development of the first Community Strategic Plan (CSP) for the Northern Beaches Council.

BACKGROUND

The development of the CSP is currently in Stage 2, with a Discussion Paper released and various community forums held throughout the Northern Beaches. Almost 300 people have attended forums so far, and provided valuable feedback on the draft goals and strategies. All 11 SRGs were consulted in their February 2017 meetings, with a workshop on draft goals and strategies for the Discussion Paper.

DISCUSSION

All comments from the SRGs were considered and analysed. The comments were generally thoughtful and helpful in understanding that Council was on the right track with the Discussion Paper goals and strategies. The comments varied in relevance from strategies for the 10-year CSP, to actions for Council's next Operational Plans and Delivery Programs, and actions that Council could consider in future service delivery.

Where it was considered relevant, some of the goals and strategies were 'tweaked' and adjusted at this stage to provide greater clarity and definition. The comments will still be used in the context of further adjustments to CSP goals and strategies, and considerations for future planning and performance targets.

With regards to the specific comments raised in February by the Youth SRG, the following was noted:

Comments on the consideration of youth and creative industries are supported in the economic strategy;

Strategies regarding further education and tertiary facilities on Northern Beaches are supported. These are reliant on partnerships, land becoming available and lobbying undertaken in future Delivery Program actions;

Further youth participation strategies that are pragmatic are also supported and will be progressed in discussion with Council's relevant staff.

The next steps in developing the CSP include a focus group to be held in April, further refinement of the goals and strategies, and production of the draft CSP document in May-June. This will then be exhibited for final community feedback in July-August 2017.
