 - 12.9 (b) Resolve the complaint by use of alternative and appropriate strategies such as, but not limited to, mediation, informal discussion or negotiation and give the complainant advice on the resolution of the matter in writing
 - ii) Where complaints are received from anonymous sources that don't supply contact details, that those complaints be determined as being invalid and not subject to the expenditure of public funds or staff time
 - iii) Place a freeze on spending public funds on external conduct reviewers, code of conduct review panellists or external legal advice on code of conduct allegations made against councillors for the remainder of this term, unless mediation (ie. S12.9 b) fails.

Passing of Mrs Pam Hall - Co Founder Manly Warringah Netball (Previously Women's Basketball) Association

- a) The passing of Mrs Pam Hall the Co Founder of the Manly Warringah Netball Association who was involved with the sport of netball (previously known as women's' basketball) for over 60 years.
- b) That in 1954 Mrs Hall along with Mrs Iris Gracie and Mrs Evelyn Langbein wrote to local swimming clubs, surf clubs, gas companies, factories and businesses in the Manly Warringah area inviting girls and women to play in the first women's basketball (now netball) competition in the Manly Warringah area. Prior to this, teams such as Manly Y and West Dee Why travelled to the city to play and higher grade teams continued to travel to the city to play up until the mid to late 1960s.
- c) In 1955 Mrs Hall with others founded the Manly Warringah Women's Basketball Group, which went on to become an affiliated Association of New South Wales Women's Basketball Association in 1965 and has developed into the second largest netball association in the world and one of the most successful netball associations in the Country with numerous players and officials representing NSW and Australia.
- d) That in 1960 Mrs Hall founded the Collaroy Plateau Youth Club Netball Division.
- e) Mrs Hall served on the Executive Committees of the Manly Warringah Women's Basketball Group and Manly Warringah Netball Association for in excess of 35 years, was a badged umpire, coach, manager and served on numerous subcommittees of the association.
- f) In honour of Mrs Hall's outstanding service to netball she was awarded Life Membership of the Manly Warringah Netball Association, Life Membership of the Collaroy Plateau Youth Club, the NSW Netball Association's Anne Clarke Service Award, the Centenary Medal and the Warringah Council Outstanding Community Service Award.
- 2. That Council acknowledges the enormous contribution Mrs Hall has given to the Manly Warringah Community and extends its deepest sympathy to her family and friends on her passing.

- 2. In an effort to expedite matters and show transparency for the benefit of the Warringah community, the Sea Eagles and NSW Government, in the hope of obtaining a State Government Grant in the future, the General Manager be requested to furnish a Report to the next Council meeting outlining:
 - a) A full breakdown of works the \$6 million NSW Government grant was expended on and dates of commencement and completion of those respective works.
 - b) A full breakdown of works Warringah Council funds were expended on, how much those respective works cost Warringah Council and the dates of commencement and completion of those respective works.
