- "Tailgating" will result in membership cancellation of the member, and any patron deemed to enter the centre fraudulently.
- Secure your belongings in the Fitness Centre lockers. Management takes no responsibility for items lost or stolen.
- Patrons suspected to be under the influence of drugs or alcohol will not be permitted in the centre.
- Abusive or offensive behaviour is not permitted, including swearing and abusive language.
- For hygiene reasons, customers using the fitness centre must use a towel. No Towel, No Workout.
- Appropriate fitness attire, including enclosed footwear must be worn at all times. Swimming costumes are not an acceptable fitness attire.
- Patrons must return and re-rack weights or any other fitness equipment after use.
