## Part 5: Terms and Conditions

Please note the following Terms and Conditions:
<ol style="list-style-type: none"><li>1. The Scotland Island Access Permit is valid from 30 November 2020 to 29 November 2021.</li><li>2. All documents required in Part 6 – “Documentation and Identification Required” section of this document must be submitted with your application</li><li>3. The Scotland Island Access Permit must be displayed on the passenger side of the dashboard of the vehicle. It must not be displayed under the tint of the windscreen or otherwise obscured.</li><li>4. Your vehicle must have current registration, be roadworthy and not present a hazard to the public or the environment.</li><li>5. Council restricts access to public roads on Scotland Island to all traffic except vehicles authorised by Northern Beaches Council. Vehicles will be restricted to the use of registered vehicles approved by Council (e.g. Small private vehicles, community vehicle, Island contractors, waste collection, and RFS).</li><li>6. Parking is restricted on roads to designated parking areas, as the proposed future road width will eliminate legal on street parking except for areas constructed for this purpose. Parking is to be in marked bays. All new developments would also be required to provide on-site parking where authorised vehicles are garaged.</li><li>7. Vehicles can only travel up to 20km/h speed limit.</li><li>8. All pedestrian activity has priority</li><li>9. Permits for long term use of vehicles for personal use i.e. general access (including access for the disabled), shopping etc. would be determined by Council.</li><li>10. Emergency vehicles and cyclists will have a general exemption to the road restrictions.</li><li>11. Heavy vehicles will be required to seek a permit from Council and will be bound by the restrictions/guidelines imposed as part of the permit approval process.</li></ol>

## Part 6: Documentation and Identification Required

<p>All documents must specify the applicant's name. All applications are to be submitted with a copy of the following information:</p> <ul style="list-style-type: none"><li>• Copy of current and valid Driver Licence showing full name of applicant.</li><li>• Current and valid vehicle registration information of the vehicle/s to which the permit will be allocated.</li><li>• If the vehicle is registered to a business, then a letter of confirmation on an official letterhead and signed by the nominated Director or Manager is to be submitted with the Application Form.</li><li>• If the property is tenanted, then a current and valid Residential Tenancy Agreement must be provided showing the property address and tenant details.</li></ul>
<p>Please note:</p> <ul style="list-style-type: none"><li>• Council will undertake any other necessary checks to confirm validity of application and rateable information.</li><li>• The name of the applicant must match the name of the property owner or the name of tenant on the Residential Tenancy Agreement.</li></ul>
