In short, Swap for Good is all about supporting our local businesses to stop or reduce single use plastics. Council's program offers resources, ongoing assistance as well as information on alternative materials and suppliers for businesses to use. You can register to get involved on our website or express your interest to be included as a sustainable supplier.

To that end, Council will also be hosting a Swap for Good business expo on 1 July at the Harbord Diggers. Come along to network with other businesses and see how you too can phase out single use plastics. With studies predicting our ocean will contain more plastic than fish by 2050, we all need to do our bit to tackle plastic pollution.

This week we were also fortunate to meet with the new Minister for Local Government, Shelley Hancock. It was a very constructive meeting and she was really open to supporting us to address some of the key issues facing our area. It was welcome to have her report back to the NSW Parliament on how impressed she is with what Council is doing and stressing the benefits of us working together for our residents.

They had received a state government grant and Council stepped in to help manage contracts and provide additional funds.
