It was a proud moment for all our staff recently when Council was officially recognised as an accredited White Ribbon workplace.

It is estimated that on average, one woman a week is murdered by her current or former partner

and one in four women have experienced emotional abuse by a current or former partner since the age of 15. These are shocking statistics and it will take a community effort to turn them around.

As an accredited workplace, our Council continues to lead by example and raise awareness through our staff and the community. We provide training to staff to help support those in need and have introduced flexible work policies for anyone experiencing violence. A great initiative.

Elsewhere, many will be pleased to learn that we are putting the Manly Warringah War Memorial Park forward for a National Heritage listing.

If approved, the site, also known as Manly Dam, would join the likes of the Sydney Harbour Bridge, North Head and the Opera House as nationally recognised places of significance.

Given Manly Dam's importance as a place of reflection and memorial for those fallen in war, it's high degree of technical achievement as a dam of the era, the prevalence of threatened plant and animal species, and a rich Indigenous history, we hope it will have a good chance of a successful listing.

With a little over 100 approved venues across the country, to see Manly Dam added to the National List would be a massive coup for our area. Thank you to the various community members for pushing this forward.
